ADOPTION OF MINUTES

The Minutes of the Standing Committee on City Services and Budgets meeting of November 16, 2006, were adopted.

CONSIDERATION

1. Application of Childcare Design Guidelines to a Private Childcare Centre at 990 Homer Street (VanRIMS No.: 11-3500-10)

The Committee had before it an Administrative Report dated November 28, 2006, in which the Deputy General Manager, Community Services sought Council's guidance on an application for a private childcare development that does not meet the intent of the current Childcare Design Guidelines, which are currently under review, and put forward options to either not approve the application, given the lack of contiguous outdoor space or to receive the application and waive the requirement for contiguous outdoor space.

Carol Ann Young, Child Development Coordinator, responded to questions.

Natasha Beim, Founder, Core Education & Fine Arts (CEFA), submitted a proposal and letter, (on file), which addressed the City's concerns regarding contiguous outdoor space. Ms. Beim provided rationale for the proposed outdoor rooftop play area, noting that high rents and the inability to secure adequate outdoor space on the same level as indoor space makes it difficult to offer daycare services in the City of Vancouver, especially in the downtown area.

Sharon Gregson spoke in opposition to approving the application because other operators are required to meet the need for outdoor space and that the guideline review underway should be completed prior to granting exceptions. Ms. Gregson noted that if exceptions to guidelines are to be granted, it must be done in a thoughtful, planned and equitable manner.

The following urged Council to waive the condition of contiguous outdoor space for the application because there is already shortage of childcare available in Vancouver, CEFA provides the highest quality childcare, and other municipalities have relaxed this guideline without compromising quality of childcare.

RECOMMENDATION

2. Street Cleaning Initiatives (VanRIMS No.: 13-6200-30)

The Committee had before it an Administrative Report dated November 29, 2006, in which the General Manager of Engineering Services provided Council with information on various street cleaning initiatives that reduce health and environmental impacts, improve safety, address street disorder issues, and improve the livability and quality of life for citizens and visitors of Vancouver. The report also sought Council's approval for a grant of \$115,000 to Save Our Living Environment (SOLE) so that they can continue to provide supplemental street cleaning services in the Downtown Eastside (DTES) and to allocate \$60,000 from the 2007 Street Cleaning Operating Budget for the purpose of funding additional supplementary street cleaning services provided by a Vancouver social enterprise selected through an expression of interest process. Also put forward for consideration was an option to amend the Solid Waste By-law to require locking of commercial bins of a certain size, which are on or visible from the street or lane. The City Manager recommended approval.

Chris Underwood, Solid Waste Management Engineer, reviewed the report and with Tom Timm, General Manager of Engineering Services and Brian Davies, Assistant City Engineer, Solid Waste Division, responded to questions.

The following spoke in support of locking garbage bins and offered additional comments:

Robert Gateman Ken Lyotier, United We Can Dave Jones, Director of Crime Prevention Services, Downtown Vancouver Business Improvement Association Leanore Sali, Gastown Business Improvement Society Aaron Jasper, West End Residents Association

Speakers' comments included:

- open bins create noise, health and safety burdens on those living downtown;
- locking garbage bins will not increase poverty, drug addition or mental illness;
- 50% of recyclables are not being picked up; incentive to reduce and recycle needs to be increased;
- the binning population needs to be provided with an alternative way to be productive in the community;
- dumpsters in the downtown area should be banned because they negatively affect livability; suggestion was made that the DVBIA be dumpster free by August 1, 2007;
- suggestion was made that fees could be charged for garbage disposal which could be put toward establishing other employment for binners;
- cleaning up laneways will this part of the streets more usable for all people but binners should not be penalized; a win-win solution should be sought;
- solutions should be sought that do not increase traffic in laneways;
- better recycling facilities are required on main streets; the recycling portion of existing City street garbage containers is too small.

The following spoke in opposition to locking garbage bins and offered additional comments:

Speakers' comments included:

- the binning population provides a valuable service because recycling is increased; if bins are to be locked then the money saved should be used to find new ways to encourage people on the Downtown Eastside to become valuable citizens;
- quieter, more efficient carts are becoming available which will help reduce noise;
- locking bins is wrong because the bins provide employment; the City should deal with poverty and homelessness rather than locking bins.

VARY ORDER OF AGENDA

At this point in the proceedings, the Committee agreed to vary the order of the agenda to deal with items 5 and 7. Subsequently, during consideration of item 7, the Committee agreed to deal with items 3a, 3b, 4 and 6. For ease of reference, the items have been minuted in numerical order.

3. Neighbourhood Energy Utility

3a Neighbourhood Energy Utility - Evaluation of Ownership and Operating Options for the City of Vancouver (VanRIMS No.: 11-2000-20)

The Committee had before it an Administrative Report dated November 27, 2006, in which the General Manager of Engineering Services, in consultation with the Director of Financial Planning and Treasury, the Project Manager of Southeast False Creek and Olympic Village, and the Manager of the Sustainability Group provided Council with an evaluation of four different ownership and operation options for a Neighbourhood Energy Utility (NEU) for Southeast False Creek (SEFC), sought Council approval for a City-owned and operated NEU based on this evaluation, recommended a set of governance principles and rate setting principles to be used in the ongoing development of an NEU, and sought Council approval for the next steps of work that are required for the NEU to interface with buildings in SEFC. The City Manager recommended approval.

MOVED by Councillor Deal

THAT the Committee recommend to Council

- A. THAT Council approve continued ownership and operation of the Neighbourhood Energy Utility (NEU) by the City, and that:
 - i. the NEU be integrated into the Engineering Services Department;
 - ii. ongoing governance, operational and financial responsibilities related to the NEU be shared by the General Manager of Engineering Services and the Director of Finance; and
 - iii. the merits of continued ownership to be reviewed before any significant expansion of the NEU; and, in any event, within three years of the commencement of commercial operations.
 - B. THAT Council adopt as policy the following governance principles for the NEU:
 - 1. That the utility will seek to minimize greenhouse gas emissions, consistent with the directions established in the Community Climate Change Action Plan.
 - 2. That the utility will be operated to ensure long-term financial viability based on a commercial model.
 - 3. That the utility will strive to establish and maintain customer rates that are competitive with the long-term capital and operating costs of other heating options available to customers.
 - 4. That the City, where feasible, will support the development and demonstration of flexible, innovative and local technologies through the NEU.
 - 5. That the City will consider and evaluate the potential to expand the NEU to other neighbourhoods and developments, with the merits and feasibility of each expansion phase to be determined separately.

- C. THAT Council adopt as policy the following principles for the NEU when enacting by-laws respecting NEU rates and terms of service:
 - 1. That NEU rates are structured so as to recover the following costs incurred by the City, based on forecasted costs:
 - i. all direct operating costs associated with the NEU;
 - ii. all debt service and repayment costs associated with the NEU;
 - iii. the share of City administrative overheads that are attributable to the NEU;
 - iv. property taxes and/or payments-in-lieu of property taxes, as appropriate;
 - v. a reserve fund for NEU rate stabilization;
 - vi. an appropriate level of compensation for the risks and liabilities assumed by the City associated with the ownership and operation of the NEU; and
 - vii. credits for any benefits provided by the NEU to City taxpayers (e.g., contribution to corporate GHG reductions goals), as determined by Council.
 - 2. That NEU rates fairly apportion the aforementioned costs among customers of the NEU.
 - 3. That NEU rates be understandable to customers, practical and costeffective to implement.
 - 4. That at least two separate rate classes (commercial and residential) be established to distinguish different types of NEU customers, with rates reflecting each class's proportional contribution to total costs.
 - 5. That, where feasible, NEU rates provide price signals that encourage energy conservation by NEU customers.
 - 6. That the methodology for calculating NEU rates provide year-to-year rate stability for NEU customers to the greatest extent possible.
 - 7. That the methodology for calculating NEU rates provide year-to-year revenue stability for the City to the greatest extent possible, and include the use of a rate stabilisation reserve similar to that used by the City for other utility operations.

- 8. That rates be updated by Council annually based on forecasted costs, and adjusted to reflect any deviation from target levels of reserves, with annual rate changes requiring review and approval by Council followed by enactment of the necessary amendments to the NEU bylaw.
- D. THAT the financing arrangement for the NEU approved by Council in the March NEU Report (being the March 2, 2006 Administrative Report, RTS No.: 5706) be continued, AND THAT once amendments to the Vancouver Charter are enacted, the General Manager of Engineering Services, in consultation with the Director of Legal Services and the Director of Financial Planning and Treasury report back on:
 - 1. a bylaw for the regulation and operation of the NEU,
 - 2. a long term financing strategy for the NEU, and
 - 3. a recommended operating plan for the NEU that includes budget, staffing and supporting utility rates.
- E. THAT Council authorize a contract with FVB Energy Inc., (without a competitive procurement process) for energy transfer station design services and to provide staff with technical advice on integrating each building owner's/developer's mechanical system with the NEU for the reasons and purposes described in this report, up to a maximum total of \$700,000; this cost to be financed from the \$14.0 million interim financing approved by Council pursuant to the March NEU Report (the "NEU Interim Budget");

AND THAT, the contract be on terms satisfactory to and approved by the City Manager and Director of Legal Services and that the City Manager and Director of Legal Services be authorized to sign such contract on behalf of the City;

AND THAT no legal rights or obligations will be created or arise by Council's approval unless and until a contract is signed and delivered.

F. THAT Council approve a temporary mechanical engineer in Engineering Services to assist in activities related to NEU building interface work, energy centre design and customer development for a temporary two year period at a cost of \$181,936; this cost to be financed from the NEU Interim Budget.

CARRIED UNANIMOUSLY (Councillor Capri absent for the vote)

3b Neighbourhood Energy Utility - Evaluation of Heat Source Options (VanRIMS No.: 11-2000-20)

The Committee had before it an Administrative Report dated November 27, 2006, in which the General Manager of Engineering Services, in consultation with the Director of Financial Planning and Treasury, the Project Manager of Southeast False Creek and Olympic Village, and the Manager of the Sustainability Group, sought Council approval to apply for an emissions permit for the use of biomass energy for the False Creek Neighbourhood Energy Utility (NEU) Community Energy Centre, and for preliminary design activities to begin. The City Manager recommended approval.

The Committee also had before it a memorandum dated December 5, 2006, entitled "David Suzuki Foundation Response Regarding NEU Heat Source Options", in which the Deputy City Manager addressed issues raised in correspondence from the David Suzuki Foundation (DSF), and provided an alternate course of action for Council consideration.

Rowan Birch, Assistant City Engineer, and Chris Baber, Project Manager, Neighbourhood Energy Utility, reviewed the report, explained the process for the NEU and provided an overview of the timeline for the next three months.

Messrs. Birch and Baber, along with Tom Timm, General Manager of Engineering Services, responded to questions regarding different heat sources, emissions, process for intent to contract, energy sources, costs, cooling, technology to be used, risks involved with not getting fuel sources in time, height of smokestack, quality of pellets, ash testing, and stewardship issues.

THAT the Committee recommend to Council

- A. THAT Council direct staff to submit an application with the GVRD for an air emissions permit for a biomass heat source for the False Creek NEU, with a maximum output of 5 megawatts; the permit process to include public consultation activities to determine the level of public support.

FURTHER THAT the contract be on terms satisfactory to and approved by the City Manager and Director of Legal Services and that the City Manager and Director of Legal Services be authorized to sign such contract on behalf of the City; and

FURTHER THAT no legal rights or obligations will be created or arise by Council's approval unless and until a contract is signed and delivered.

4. East Fraserlands District Energy Feasibility Analysis (VanRIMS No.: 11-2000-20)

The Committee had before it an Administrative Report dated December 4, 2006, in which the General Manager of Engineering Services, in consultation with the Director of Financial Planning and Treasury and the Manager of the Sustainability Group, sought Council approval of a study to determine the feasibility of developing a district energy system, similar to the Southeast False Creek Neighbourhood Energy Utility (NEU) model, to serve the East Fraserlands Official Development Plan area. The City Manager recommended approval.

MOVED by Councillor Deal THAT the Committee recommend to Council

THAT Council authorize the Director of Engineering Services to participate in a study to be undertaken by the developer of East Fraserlands, WesGroup Income Properties LP, to investigate the technical and financial feasibility of a district energy system, similar to the NEU model, to serve the East Fraserlands Official Development Plan area; with the City contribution to be 50% of the cost, estimated at \$45,000 to be funded from the Sustainability Group 2006 operating budget.

5. Federation of Canadian Municipalities' Getting to 30% - National Campaign (VanRIMS No.: 01-1500-10)

The Committee had before it an Administrative Report dated November 30, 2006, which sought Council support to endorse FCM's "Getting to 30% Initiative", and to provide funding for a consultant. The consultant will liaise with other municipalities and women's organizations to plan, organize, and find additional resources for a joint event to promote this initiative and bring awareness to the community at large. This event will also be a City's celebration of the International Women's Day.

THAT the Committee recommend to Council

- the Project Civil City plan targets the poor and marginalized people in the city and punishes people who are already in survival mode; it is cheaper to house people than to punish them;
- request that Carnegie Community Action Project be removed from the organizations listed in Appendix A;
- the plan is really about cleaning up the streets prior to the Olympics;
- Project Civil City is the point of view of BIAs and the tourism industry; the community has been excluded;
- the plan will increase conflict between police and people on the streets, which is already a problem;
- ticketing for sitting or lying in streets is not fair and will not solve the homelessness problem.

- E. Revitalize the City's Neighbourhood Integrated Service Teams (NIST) by realigning them toward program delivery and meeting public disorder reduction goals.
- F. Advise bar owners and their patrons in Vancouver's entertainment district that they have a 90-day countdown toward implementing immediate solutions that will significantly improve public order or Council may consider the option of bringing Vancouver bar hours in line with other GVRD jurisdictions.
- G. In order to track the progress of Project Civil City, immediately benchmark the current level of incidents of aggressive panhandling and open drug sales and use in our City. In addition, conduct an immediate litter audit as well as benchmark the current satisfaction of citizens in relation to how the City manages complaints for public nuisances and annoyance complaints such as excessive motorcycle noise. The source of funding will be through the Project Civil City budget allocation.
- H. Request that the Vancouver Police Board seek out every opportunity to significantly increase the street presence of our police force.
- I. Conduct thorough review of ticketing, by-laws and fines with the objective of improving efficiencies and increasing their effectiveness in countering public disorder. This review shall be completed within 90 days and be incorporated into the PCC Implementation Plan. Source of funding to be through the Project Civil City budget allocation.
- J. Request that the City Manager seek out every opportunity to work within existing budgets in the preparation of the PCC Implementation Plan.
- K. Request that the City Manager outline a proposal that will seek to work with other levels of government to significantly increase the collection of unpaid fines as a possible means of funding part of the PCC Implementation Plan.
- L. That Council receives for information the Project Civil City document "the white paper," as prepared by the Mayor's Office.

The Committee recessed at 6:02 p.m. and reconvened at 7:00 p.m. with the same members present except Councillors Chow, Deal, Louie and Stevenson and the Mayor who was absent.

The Committee adjourned December 15, 2006 at 1:20 a.m.
