3. License By-Law Amendments: New Pet Store Regulations (VanRIMS No.: 08-4000-11)

The Committee had before it an Administrative Report dated January 15, 2007, in which the Chief License Inspector sought Council approval for an amendment to the License By-Law to

introduce new pet store regulations outlining the duties, responsibilities and business practices of operators of pet store establishments in the city. The General Manager of Community Services recommended approval.

Alena Straka, Policy Analyst - License Office, reviewed the report, and submitted amendments to Appendix A of the report (on file in the City Clerk's Office).

Ms. Straka, along with Paul Teichroeb, Chief License Inspector, responded to questions regarding status of the work, the timing and priority of this issue, and expertise required for veterinarians.

The following delegations spoke in favour of staff's recommendations:

Their comments included general support of recommendations, noting pet store employees need to be properly trained in handling animals and veterinarians treating animals need to have experience with the species.

#### 4. Exotic/Wild Animals in Captivity (VanRIMS No.: 08-4000-11)

The Committee had before it an Administrative Report dated January 15, 2007, in which the Chief License Inspector presented Council with information on exotic/wild animals in captivity, elaborated upon the issues surrounding the keeping, sale and use of exotic/wild animals in performances in the City, and provided a summary of exotic/wild animal regulations and by-laws in other municipalities and encapsulated views and opinions of animal

welfare advocate groups and various animal-related associations on exotic/wild animals in captivity. The report also sought Council approval for: amendments to the Animal Control Bylaw and the Business Prohibition By-law to prohibit the keeping and sale of certain exotic/wild animals in the City for reasons of public safety, health and animal welfare, and sought Council approval, in principle, of the prohibition of the use of exotic/wild animals in performances and other forms of entertainment in the City.

Alena Straka, Policy Analyst - License Office, reviewed the report.

Paul Teichroeb, Chief License Inspector, and David McLellan, Deputy General Manager of Community Services, responded to questions regarding applicability of the by-law to the aquarium and other city-owned property, definitions used in the proposed by-law. - need to make sure "non-exotic" pets are not abandoned as well;
- regulations need to fall in line with reptiles' home countries; and
- education important in decreasing the number of abandoned reptiles.

- 5. Award of Contract for RFP#PS06027 The Supply of Electrical Wire, Cable, Conduit and Miscellaneous Electrical Components (VanRIMS No.: 03-1200-11)

At its meeting on January 31, 2007, Vancouver City Council received a request to speak on this matter, and referred this item to the Standing Committee on Planning and Environment meeting on February 1, 2007, in order to hear from the speaker.

Accordingly, the Committee had before it an Administrative Report dated January 8, 2007, in which the General Manager of Corporate Services and the Manager of Materials Management recommended Council authorize a three-year contract with the option to extend for two additional 12-month periods to Wesco Distribution Canada - LP for the supply of wire, cable, conduit and miscellaneous electrical components to the City, based on responses to Request for Proposal (RFP) PS06027.

Judy Rogers, City Manager, noted the speaker had withdrawn his concerns.

MOVED by Councillor Cadman
THAT the Committee recommend to Council

- A. THAT, subject to the conditions set out in B, C, and D, below,, Council authorize a contract with Wesco Distribution Canada LP to supply electrical wire, cable, conduit and miscellaneous electrical components for a period of three (3) years at an estimated cost of \$4,800,000 plus GST (less any municipal rebate received) and PST with a subsequent renewal option of two (2) one-year extensions. Source of funding for the contract to be provided from the existing Departmental operating budgets.
- B. THAT the Director of Legal Services be authorized to execute and deliver on behalf of the City all legal documents required to implement A, above.
- C. THAT all such legal documents be on terms and conditions satisfactory to the General Manager of Corporate Services, Manager of Materials Management and the Director of Legal Services.

D. THAT no legal rights or obligations will be created by Council's adoption of A, B and C above unless and until such legal documents are executed and delivered by the Director of Legal Services.

6. Modest Market Housing: Sub-Area 2A, South East False Creek (VanRIMS No.: 11-2200-21)

At its meeting on January 31, 2007, Vancouver City Council received a request to speak, and referred this item to the Standing Committee on Planning and Environment meeting on February 1, 2007, in order to hear from delegations.

Accordingly, The Committee had before it an Administrative Report dated December 15, 2006, in which the Director of the Housing Centre and the Project Manager for South East False Creek in consultation with the Director of Real Estate Services, sought Council approval for the City to enter in an agreement Millenium Southeast False Creek Properties Ltd for the development of all the Modest Market Housing in the Olympic Village on the conditions that the units be restricted in size and that such market rental housing be subject to a 20-year rental restriction.. The General Manager of Community Service recommended approval. The City Manager provided additional comments in support of the recommendations and noted affordable homeownership or having the City develop market rental housing may be worth pursuing in later phases of South East False Creek's Development, and allowing Millennium to develop the Modest Market Housing in the Olympic Village as market rental housing is appropriate. She further noted the development of over 100 units of market rental housing secured for 20 years and with limitations on unit sizes is a significant enhancement of the affordability objectives for the Olympic Village.

Cameron Gray, Director of the Housing Centre, along with Michael Flanigan, Real Estate, Jody Andrews, Project Manager - Southeast False Creek and Olympic Village, and Roger Bayley, Millenium Southeast False Creek Properties, Ltd., responded to questions regarding timelines, parcel retention, costs and benefits, practicality of providing rentals geared to income, subsidies, selection of developer, time constraints for decision-making and work, comparison to the rest of North America in terms of affordable housing, .

Leslie Stern noted concerns with the recommendations, specifically that what will happen in South East False Creek is significant, and questioned who would be able to live in the community.

THAT the Committee recommend to Council

A. THAT Millennium Southeast False Creek Properties Ltd. develop all of the Modest Market Housing (as defined in the South East False Creek Official

Development Plan) in Sub-Area 2A of South East False Creek (the Olympic Village) as market rental housing built to maximum unit size limitations and subject to a rental restriction covenant to be registered on title requiring that such housing be rented for 20 years as outlined in this report; and

B. THAT the Director of Legal Services be authorized to execute the necessary legal agreements on terms and conditions to the satisfaction of the City Manager and the Director of Legal Services, provided that no legal rights or obligations shall arise or be created until all the legal documentation has been fully executed.

7. Central Waterfront Hub and Whitecaps Stadium Issues Integration (VanRIMS No.: 11-2000-14)

The Committee had before it an Administrative Report dated January 16, 2007, in which the Director of Planning and the General Manager of Engineering Services sought Council approval of a program to resolve the fundamental issues related to the Whitecaps stadium proposal on the Central Waterfront, in parallel with the previously approved Central Waterfront Hub and Rail Yards Study ("the Hub Study").

Brent Toderian, Director of Planning, and Matt Shillito, Central Area Major Developments Group, reviewed the report, and along with Trish French, Assistant Director of Current Planning, and Jim Cox, Vancouver Port Authority, responded to questions regarding communication with transit authority, location, new cruise ship terminal, available space in the area, ferry transportation, public consultation processes, authority over the lands, when and how the stadium proposal will come back to Council, contents of the hub report, expectations of Whitecaps, public consultation, discrepancy in timelines between Hub Study and the Stadium, working group, issues around Crab Park, liability, dangerous goods, using other ports for dangerous goods, timing of an overall development plan

- 4. drug addiction is a concern to all citizens of Vancouver;

THEREFORE BE IT RESOLVED THAT City Council direct the City of Vancouver Drug Policy Coordinator to prepare a report for Council that includes:

- 1. An update on the NAOMI project and the challenges that the project has faced including the attraction of sufficient number of participants.
- 2. Examples of other similar substitute drug treatment programs around the world including their benefits and challenges.
- 3. An estimate of the cost of such a substitute drug treatment program for at least 700 participants, including a facility, staff, utilities etc.
- 4. A research component program and associated costs.
- 5. Relevant legislative changes necessary to allow such a program to operate.

AND BE IT FURTHER RESOLVED THAT a public consultation process be undertaken to allow opportunity for the public and all interested parties to provide input into the program thus giving the program greater support.

#### 3. Rent Review - False Creek Residential Leaseholds (VanRIMS No.: 02-3000-10)

At the Regular Council meeting on January 30, 2007, the following motion was submitted by Councillor Louie. Councillor Ball called Notice under Section 5.4(c) of the Procedure By-law. The motion was put on the agenda for the Regular Council meeting immediately following the Standing Committee on City Services and Budgets meeting on February 1, 2007. The motion was subsequently referred to the Council meeting following the afternoon's Standing Committee on Planning and Environment meeting, due to time constraints.

#### WHEREAS:

- 1. In the 1970s, based on the recommendations by citizens, two advisory review panels, and City staff, policies which laid out guidelines for redeveloping False Creek were adopted by City Council in 1973;
- 2. The new City policy required a range of housing to provide a social mix that reflected the City's income and social composition;
- 3. The social mix originally envisioned is currently under threat of being lost due to a significant rent increase;
- 4. On October 3, 2006 Council approved a prepayment option and requested staff to report back for approval of prepayment amounts;

THEREFORE BE IT RESOLVED THAT Vancouver City Council direct staff to include in their report back, a range of options to make accommodation for hardship cases in order to allow for their personal economic circumstances and to ensure no one facing extreme financial hardship, as it would be defined under the rules of the Homeowner Protection Plan, is displaced from his or her home as a result of the increases.
