REPORT REFERENCE

1. Vancouver Police Department Operational Review (VanRIMS No. 05-1000-30)

A Report Reference on the Vancouver Police Department Operational Review of the Department's Patrol operations was presented by:

- Brent MacGregor, Deputy City Manager
- Deputy Chief Constable Jim Chu, Operations Support, Vancouver Police Department
- Dr. Curt Griffiths, Senior Project Consultant
- Sergeant Adam Palmer, Planning, Research & Audit Section, Vancouver Police Department

They referred to the Administrative Report *Vancouver Police Department Operational Review*, dated February 5, 2007 and described the scope of the review, key "leading indictors" of police service, deployment efficiencies and provided an overview of the recommendations contained in the report. Council was requested to receive the report and postpone consideration to the 2007 Interim Operating Budget.

MOVED by Councillor Chow

- A. THAT Council receive this report for INFORMATION and postpone approval and funding of B through G below to the 2007 Interim Operating Budget.
 - B. THAT Council approve an increase to the Vancouver Police Department's sworn strength by 65 police officers to be deployed as patrol officers (positions listed in Appendix G) at a net cost of \$1,936,960 for 2007, estimated at \$4,991,010 for 2008; on-going funding is estimated at \$6,684,120.

All vehicles are to be purchased by the Plant and Equipment Reserve (Plant Account), 12 in 2007, 31 in 2008, based on the VPD Master Schedule at a total cost of \$515,200 in 2007 and \$1,382,600 in 2008 and are to be funded by the Vancouver Police Department through increased rental rates of \$30,600 and budget offsets within the VPD Fleet Budget for 2007, and through increased rental rates of \$501,300 in 2008 and \$836,200 in 2009 and are included in the above annual estimates.

93 Radios and 43 patrol laptops are to be purchased through E-Comm and added to the annual levy at a cost of \$65,790 in 2007; \$274,560 in 2008 and \$483,740 in 2009 and are included in the above annual estimates.

C. THAT the Steering Committee develop key performance measures for approval by the Police Board to be reported to Council by September 2007 that include all inputs, outputs and outcomes for both reactive and proactive policing; and that as proposed by the Police Board in its comments, the Police Board will conduct bi-annual evaluations to measure the effectiveness of the deployment strategy and will provide these status reports to Council for its information.

- D. THAT the Chief Constable in consultation with the Police Board and the City Manager report to Council on a full review of the deployment strategy after one year of implementation of the recommendations.
- E. THAT the Chief Constable report, in consultation with the Police Board, the confirmation of the Vancouver Police Union's agreement to the recommended shifting strategy or other shifting patterns that meet the operational and financial objectives outlined in this report. Further, THAT funding shall not be allocated for "Stage A3" of the recommendations until this confirmation is received by Council.
- F. THAT Council instruct the Joint City/VPD Steering Committee to report back prior to the 2008 Operating Budget on Phase 2 of the VPD Operational Review including further opportunities related to overtime, shared services, and deployment efficiencies to offset VPD resource requirements.
- G. THAT Council approve the creation of a Bylaw Prosecutor effective January 2008 with an annual cost of \$144,000; funding to be added to the 2008 Operating Budget without offset.

Estelle Lo, General Manager of Corporate Services, and Annette Klein, Director of Budget Services, presented a Report Reference on the interim estimates for the 2007 Operating Budget. Ms. Lo and Ms. Klein presented an overview of the public consultation process, the budget process to date, budget and funding options and initiatives, a summary of the recommendations and considerations before Council, and responded to questions.

Ms. Jami Koehn, representing the Mustel Group presented highlights of the public opinion survey undertaken by the Mustel Group seeking the opinions of Vancouver residents and businesses on a range of service and taxation options.

Ms. Klein noted a Special Standing Committee on City Services and Budgets meeting will be held on February 20, 2007 at 7:30 p.m. to hear from speakers on the 2007 Interim Operating Budget.

THAT Council amend Section 8(a) of the Development Permit Board and Advisory Panel By-law, No. 5869, to add a Deputy General Manager of Community Services, as another alternate to the Deputy City Manager.

FURTHER THAT David McLellan, Deputy General Manager of Community Services, be appointed as an alternate to the Deputy City Manager, effective on the date of the by-law amendment.

2. Purchase of Replacement Wildlands Firefighting Vehicle for Pacific Spirit Park (UEL funded)

January 8, 2007 (VanRIMS No. 03-2400-10)

- A. THAT, subject to the conditions set out in B, C, D, and E below, Council authorize the sole source purchase (without public tender) of a Wildlands Firefighting vehicle from Hub Fire Engines & Equipment Ltd. at a total cost of \$194,943, plus applicable taxes and Provincial Environmental Levy; source of fund to be the University Endowment Lands (UEL) Apparatus Replacement Reserve. Annual operating costs of \$1,500 will be funded as part of the Fire Services Agreement (UEL) between the City of Vancouver and the Province. There is no cost implication to the City of Vancouver's Plant Account, internal equipment rental rates, and operating budget.
- B. THAT, subject to the conditions set out in C, D, and E below, Council authorize an amendment to the Fire Services Agreement (UEL) between the City of Vancouver and the Province, whereby the Province legally commits to an increased annual contribution to the Reserve, for the increased replacement cost of this and other enhanced vehicles that are funded through this Agreement.
- C. THAT all legal documents required to implement A and B above, be on terms and conditions satisfactory to the General Manager/Fire Chief, Vancouver Fire & Rescue Services (VF&RS) and the Director of Legal Services.
- D. THAT upon approval of the terms and conditions of such legal documents pursuant to C above, the Director of Legal Services be authorized to execute and deliver them on behalf of the City.
- E. THAT no legal rights or obligations will be created by Council's adoption of A, B, C, and D above unless and until such legal documents are executed and delivered by the Director of Legal Services.

3. Form of Development: 4575 Clancy Loranger Way - DE410676, CD-1 By-law No. 9230

January 26, 2007 (VanRIMS No. 11-3500-10)

THAT the form of development for this portion of the CD-1 zoned site known as Hillcrest Park and Nat Bailey Stadium Park (4575 Clancy Loranger Way being the application address) be approved generally as illustrated in the Development Application Number DE410676, prepared by Hughes Condon Marler Architects and stamped "Received, Community Service Group, Development Services, December 22, 2006", provided that the Director of Planning may approve design changes which would not adversely affect either the development character of this site or adjacent properties.

THAT the Vancouver Heritage Register be amended by deleting the addresses of three buildings demolished/destroyed in 2006, the addresses of two buildings demolished prior to 2006, and one building for which alterations have compromised its character, listed in Appendix B of the Administrative Report *Vancouver Heritage Register Annual Update for 2007*, dated February 2, 2007.
 - C. THAT the Vancouver Heritage Register be amended to change the addresses of four buildings listed in Appendix C of the Administrative Report *Vancouver Heritage Register Annual Update for 2007*, dated February 2, 2007.

5. Amendment to Childcare Amenity Density Bonus at 833 Homer Street February 6, 2007 (VanRIMS No. 11-3500-10)

THAT Council amend clause A of the resolution approved on January 16, 2007, regarding the Childcare Amenity Bonus at 833 Homer Street as follows (amendments in italics)

A. The design, construction, fit, finish, and equipping by the Owner, at its cost, of a licensed 37-space child care facility, on the 3rd floor, of approximately *14,957 square feet*, including contiguous outdoor area, *and including* shared use of lobby, elevators and stairs, and dedicated parking, as per the City of Vancouver Childcare Design Guidelines, and acceptable to the Directors of Social Planning, Facilities Design and Management, Community Care Facilities Licensing (CCFL), and Director of Legal Services.

AND FURTHER THAT Council approve an additional clause D as follows:

D. The foregoing is provided in exchange for 78,503 square feet of amenity bonus floor area, under section 6. II of the Downtown ODP.

THAT, subject to enactment of the by-law to rezone 51-85 and 199-215 West 1st Avenue, 1599 -1651 Ontario Street and 1598 -1650 Columbia Street (Olympic Village site), the Director of Planning be instructed to make application to amend such CD-1 By-law generally as described in Appendix A of the Policy Report *CD-1 Text Amendment - 51-85 and 199-215 West 1st Avenue, 1599-1651 Ontario Street and 1598-1650 Columbia Street (Olympic Village Site)*, dated January 30, 2007, and that the application be referred to Public Hearing;

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary amending by-law, generally as described in Appendix A of the Policy Report, for consideration at the Public Hearing.

2. CD-1 Rezoning - 4887 Cambie Street February 8, 2007 (VanRIMS No. 11-3600-20)

- A. THAT the application by Art Cowie, Eikos Planning Inc. to rezone 4887 Cambie Street (Lot 9, Block 819, D.L. 526, Plan 7221) from RS-1 to CD-1 to permit a three-unit freehold tenure rowhouse development, each parcel to include an additional secondary dwelling unit located on top of the garage at the rear, all under the Neighbourhood Housing Demonstration Project program, be referred to a Public Hearing, together with:
 - (i) plans received June 20, 2006;
 - draft CD-1 By-law provisions, generally as presented in Appendix A of the Policy Report *CD-1 Rezoning - 4887 Cambie Street*, dated February 8, 2007; and
 - (iii) the recommendation of the Director of Planning to approve, subject to conditions contained in Appendix C of the Policy Report *CD-1 Rezoning 4887 Cambie Street*, dated February 8, 2007.

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary CD-1 By-law generally in accordance with Appendix A of the Policy Report for consideration at a Public Hearing.

- B. THAT, if the rezoning is approved at a Public Hearing, enactment of the CD-1 Zoning By-law be subject to the City Manager and the Director of Legal Services approving the party wall agreement required for the freehold tenure rowhouses, failing which subdivision to create three separate legal parcels to occur by an alternative mechanism.
- C. THAT, subject to approval of the rezoning at a Public Hearing, the Subdivision By-law be amended as set out in Appendix B of the Policy Report *CD-1 Rezoning* - 4887 Cambie Street, dated February 8, 2007; and

FURTHER THAT the Director of Legal Services be instructed to bring forward the amendment to the Subdivision By-law at the time of enactment of the Zoning By-law.
