#### **ADOPTION OF MINUTES**

The Minutes of the Standing Committee on Planning and Environment meeting of January 18, 2007 were adopted.

## RECOMMENDATION

1. 626 East 62<sup>nd</sup> Avenue - Warning to Prospective Purchasers and Injunctive Relief (VanRIMS No.: 11-4400-20)

This item was withdrawn.

2. Second Annual Food Policy Progress Report (VanRIMS No.: 11-2000-14)

The Committee had before it an Administrative Report dated January 29, 2007, in which the Director of Social Planning in consultation with the Vancouver Food Policy Council provided information to Council on the work of Social Planning Food Policy staff and the Vancouver Food Council, along with information on the Vancouver Recovered Food Assessment and a Context and Background document related to the Food Charter as prepared by the Vancouver Food Policy Council and sought Council approval on a Food Charter. The General Manager of Community Services recommended approval.

Devorah Kahn, Food Policy Coordinator, along with Susan Kurbis, Barbara Joughin, and Carole Christopher, of the Food Policy Council, reviewed the report and along with Brian Davies, Assistant City Engineer, Solid Waste Management; and Mary Clare Zak, Director, Social Planning, responded to questions relating to composting options, potential for business community partnerships, potential participation of GVRD, community gardens, and food recovery/reuse/recycling.

# 3. Burrard Slopes IC District Rezoning Policies (VanRIMS No.: 11-3600-01)

The Committee had before it a Policy Report dated January 30, 2007, in which the Director of Planning sought Council approval to adjust the rezoning policies to update the policies and guidelines and bring them into standard format as well as to provide more flexibility for office/service uses by increasing the maximum floor space ratio (FSR) for these uses from 1.0 to 2.0 FSR. The General Manager of Community Services recommended approval.

Heather Burpee, Planning Analyst, reviewed the report and along with Ronda Howard, Assistant Director, City Plans, responded to questions relating to industrial land, and notification procedures.

The following spoke generally in favour of the recommendations but expressed concerns:

# Speakers' comments included:

- consider different IC zoning between Burrard & Fir Streets and south of 4<sup>th</sup> Avenue area south is becoming quite small; new park/green space will reduce industrial use availability by approximately 30%;
- current proposal in report downzones area from original intent;
- proposed change discourages development because land values are high and density low;
- density should be increased to 2.75 FSR; and density height limit should be increased;
- more residential use around parks would increase security;
- proposed zoning of IC3 that would preserve employment;
- consider 1 FSR of office/commercial space with 2 FSR for residential above to increase population and office/commercial space;
- supported policy north of 4<sup>th</sup> Avenue; but needs incentives along with zoning;
- do not go beyond 3FSR, but change FSR allocation to accommodate more residential;
- Burrard Slopes last area in Vancouver close to downtown that is available to be developed so citizens do not have to travel far in order to work;
- report has few changes from previous City policies;
- suggestions:
  - o increase FSR to 4 or 5 for industrial/office use, but allow small type retail service on main floor; also consider vertical rezoning;
  - o discourage residential use except for main streets;
  - o increasing residential density is highly attractive from market perspective; and
  - o table staff report for 90 days and interview stakeholders.

Ms. Burpee, along with Ronda Howard, Assistant Director, City Plans, responded to questions relating to FSR, building envelopes, residential/commercial space allocations, heights/viewcones, industrial/service use balance, impact on jobs and zoning boundaries. MOVED by Councillor Louie

THAT the Committee recommend to Council

THAT the matter of the *Burrard Slopes IC District Rezoning Policies* be postponed to a future Standing Committee meeting with instruction to staff to report back on encouraging job producing space.

#### **UNFINISHED BUSINESS**

Following the hearing of speakers at the Special Standing Committee meeting on Planning and Environment on January 25, 2007, Vancouver City Council referred discussion and decision on this matter to the Regular Council meeting on February 13, 2007, as Unfinished Business.

Subsequently, at its meeting on February 13, 2007, Vancouver City Council postponed consideration of the following to a Regular Council meeting on Thursday, February 15, 2007 due to time constraints:

- (a) Administrative Report dated November 29, 2006, entitled "Downtown Eastside Housing Plan Report Back on SRO Stock";
- (b) Policy Report dated November 30, 2006, entitled "Single Room Accommodation (SRA) By-law Status Report"; and
- (c) Motion entitled "Moratorium on SRA Conversions".
- a) Downtown Eastside Housing Plan Report Back on SRO Stock (VanRIMS No.: 11-2200-21)

# MOVED by Councillor Ladner

- A. THAT Council direct staff to search for a potentially suitable hotel where use of Section 23 of the Standards of Maintenance By-law might be appropriate and report back to Council on procedures, timeline and budget estimates.
- B. THAT staff continue to review opportunities to purchase rental buildings, including SROs, throughout the City as well as in the downtown, that could accommodate low-income singles, in partnership with senior levels of government and Vancouver Coastal Health, or other funders.
- C. THAT Council direct staff to report back on a grant of \$35,000 for tenant support services, with matching funding from BC Housing, as part of the 2007 operating budget process.

b) Single Room Accommodation (SRA) By-law Status Report (VanRIMS No.: 11-3500-10)

A. THAT Council, having conditionally approved conversion or demolition permits for the following SRA-designated properties, and as the conditions have been met and the resulting conversion or demolition permits issued, now approve the removal of the following properties from Schedule A of the SRA By-law:

434 Richards Street (Empress Rooms);
909 Richards Street (Roseberry House);
746 Richards Street (Passlin Hotel);
24 Water Street (Grand Hotel); and

FURTHER THAT Council, having authorized an exemption from the requirements of the SRA By-law of all 19 SRA-designated rooms at the following property, now approve the removal of this property from Schedule A of the SRA By-law:

347 West Pender Street (New Backpackers Hotel).

- B. THAT Council authorize the Director of Legal Services to bring forward amendments to the SRA By-law and any consequential changes to the License By-law, generally in accordance with the draft amendments attached as Appendix A of Policy Report *Single Room Accommodation (SRA) By-law Status Report*, dated November 30, 2006, that would:
  - remove from Schedule A of the SRA By-law the properties listed in A above;
  - increase the conditional \$5,000 per room fee to \$15,000 per room, which Council could attach to the approval of a conversion or demolition permit for deposit into the City's reserve fund for the creation of replacement housing; subject to a report back on the success of achieving the City's minimum 1:1 replacement policy for low income housing;
  - require Council to consider the recent history of an SRA hotel when presented with an application to convert or demolish its designated rooms;
  - require an owner or operator of an SRA building to maintain for each designated room a standardized "room registration form" (Appendix E of Policy Report Single Room Accommodation (SRA) By-law Status Report, dated November 30, 2006);
  - require an owner or operator of an SRA building to identify on the business license specific room numbers of the maximum 10% of SRA units which are available for rent to temporary guests; and
  - include provisions that would improve the effectiveness of and promote compliance with the By-law; and

FURTHER THAT the draft By-law be referred to a public meeting, following the format of a public hearing, to provide an opportunity for persons to make their views known to Council.

C. THAT Council consider on a case-by-case basis the requirement for applicants wishing to demolish SRAs to enter into a Housing Agreement to secure affordability; and

FURTHER THAT staff report back in one year with an update on the SRA by-law, including SRO losses, the development of replacement housing, the appropriate conditional fee, and any emerging issues.

AMENDMENT MOVED by Councillor Stevenson

THAT in the second bullet of B, the fee of \$15,000 be increased to \$50,000.00.

c) Moratorium on SRA Conversions (VanRIMS No.: 11-2200-21)

MOVED by Councillor Stevenson SECONDED by Councillor Deal

#### WHEREAS:

- 1. The number of homeless in Vancouver's streets is steadily climbing.
- 2. Conversions of single room accommodation units is increasing despite the SRA bylaw.
- 3. These conversions within a few blocks of the Olympic village may constitute a violation of the City of Vancouver's commitments to the IOC under the Inclusivity Intent Statement with our bid to host the 2010 Olympic Winter Games and Winter Paralympic Games.

#### THEREFORE BE IT RESOLVED

- 1. THAT Council impose a moratorium on any conversions or demolitions of SRA accommodation with the exception of conversions or demolitions that result in the development of social housing, shelters or SRAs.
- 2. THAT Council direct staff to recommend measures necessary to strengthen the SRA bylaw, including increasing the conversion fee.
- 3. THAT Council, through the Mayor, call on both senior levels of government to commit to restore funding for affordable housing to confront the crisis.
