ADOPTION OF MINUTES

The Minutes of the Standing Committee on Transportation and Traffic meeting of January 16, 2007, were adopted.

RECOMMENDATION

1. Parking Payment in Lieu - review of fees and area, and assignment of payments (VanRIMS No. 13-5500-20)

The Committee had before it an Administrative Report dated February 26, 2007, in which the General Manager of Engineering Services, in consultation with the General Manager of Corporate Services, provided a review of the payment-in-lieu parking fee and recommended the fee be increased to reflect the net cost for the City to provide a parking space, the payment-in-lieu boundary be expanded, a number of payment-in-lieu payments be assigned to parking facilities and that \$895,000 be transferred to the Parking Site Reserve fund.

The City Manager recommended approval.

Bob Macdonald, Senior Parking Policy Engineer, Parking Management Branch, reviewed the report and responded to questions regarding the difference between the Payment-in-lieu and Parking Site Reserve Funds, purpose of boundary expansion, and tracking inventory, development credit, renting options, and rates.

MOVED by Councillor Louie
THAT the Committee recommend to Council

- A. THAT the payment-in-lieu fee per parking space be increased from \$14,500 to \$20,200.
- B. THAT the payment-in lieu boundary, currently bounded by Burrard on the West, be extended west of Burrard Street as shown on Appendix A of the Administrative Report dated February 26, 2007, entitled *Parking Payment in Lieu review of fees and area, and assignment of payments*, to reflect the addition of a City parking facility at 1095 Waterfront Road.
- C. THAT payments totalling \$895,000, identified in Appendix C of the Administrative Report dated February 26, 2007, entitled *Parking Payment in Lieu review of fees and area, and assignment of payments*, be transferred from the Payment-in-lieu Fund to the Parking Site Reserve.

2. Balaclava Bike Route (VanRIMS No. 13-5000-20)

The Committee had before it an Administrative Report dated February 23, 2007, in which the General Manager of Engineering Services provided information about issues which arose during the design and consultation for the Balaclava Bike Route, and sought Council's approval to proceed with the implementation of the bike route and funding to construct street improvements to accommodate it.

Scott Edwards, Manager, Greenways and Neighbourhood Transportation, reviewed the report and noted the Southlands Ratepayers Association provided clarification regarding their position on the Balaclava Bike Route and this was distributed to Council on March 12, 2007 *(on file)*. He also noted the Balaclava Bike Route is the first bike route connection to Southlands neighbourhood and that consultation with the area's stakeholders remains an outstanding item with respect to detailed design for the full development of pedestrian and equestrian trails. Mr. Edwards advised that a Community Amenity Contribution will assist further development of pedestrian and equestrian trails in the area as a separate project.

Mr. Edwards, together with Jerry Dobrovolny, Assistant City Engineer - Transportation, and David Rawsthorne, Civil Engineer, Greenways and Neighbourhood Transportation, responded to questions regarding consultation with bike groups and schools, additional bike racks and creative design, traffic circle artwork, north end bike route connections, horse pathways, safety and pedestrian/equestrian facilities, project timelines, Community Amenity Contributions, and traffic counts and monitoring.

The following spoke in general support of the bike route but noted the need for further monitoring:

A summary of their comments follows:

- increasing quality cycling facilities attracts people to cycling and is crucial for achieving a higher cycling mode share;
- recommend monitoring vehicle speed and volume and cyclists' comfort level on Balaclava Street;
- the proposed route is better than Blenheim Street which would have required trees to be cut for a bike route;
- the bike route is environmentally friendly, supports the new EcoDensity Initiative, and gives residents an alternate way to reach the Dunbar shopping area;
- pleased the north-south stops are being replaced with traffic circles;
- the expanded bicycle network is beneficial by providing a safe and pleasant means for getting around, and cyclists can avoid Marine Drive;
- looking forward to improved connection with Point Grey Road and access to Downtown;
- monitoring the 10th Avenue intersection is needed; would like to have cyclist-activated traffic signals at 10th and 33rd Avenues and for Point Grey Road, or at least a left-turn bike lane for cyclists heading south;
- there are outstanding issues regarding the intersections at Galiano/Puget Drive, 49th Avenue, and Celtic Avenue, as well as anticipated additional traffic from housing development on the south side of Celtic;
- concerned about routes shared with horses, the potential for spooking, and the possible loss of the big ditches in Southlands;
- prefer to have horses on separate paths;
- would like to maintain a 30 km speed limit in the Southlands neighbourhood; and
- vehicle speed and equestrian related concerns if the area becomes popular with bike groups.

Following delegations, Mr. Edwards responded to questions regarding the 10th Avenue intersection, changes planned for the Galiano/Puget Drive area, potential traffic increase from new development and pedestrian/equestrian trails.

MOVED by Councillor Deal THAT the Committee recommend to Council

- A. THAT the Balaclava Bike Route be implemented as described in the Administrative Report dated February 23, 2007, entitled *Balaclava Bike Route*, at an estimated cost of \$630,000.
- B. THAT \$230,000 be allocated from the 2003-2005 Streets Basic Capital Program (CB1EA2E Bicycle Network) to supplement the funding approved by Council on February 16, 2006.
- C. THAT, subject to the 2008 Budget review, the Engineering Services Operating Budgets be increased by \$15,000, without offset, commencing in 2008.
