THAT Council close, stop-up and convey to the abutting owner at 2859 Commercial Drive, (legally described as [PID: 015-981-126], Lot D, Except (A) The West 8 Feet Now Lane and (B) Part in Plan 4368, of Lots 18 to 22 Block 170 District Lot 264A Plan 2105 (hereafter, "Lot D")), the 5 foot wide portion of lane adjacent to Lot D, the same as generally shown hatched on the plan attached as Appendix A to the Administrative Report *Closure and Sale of a Portion of Lane South of 12th Avenue, West of Commercial Drive and Adjacent to 2859 Commercial Drive*, dated May 28, 2007, subject to the terms and conditions as noted in Appendix C of the Administrative Report.

  - B. THAT all that volumetric portion of Homer Street included within the heavy outline and illustrated isometrically on a plan of survey, a reduced copy of which is attached as Appendix B to the Administrative Report *Proposed Closure of Portions of Homer Street and Hamilton Street Adjacent to 1228 Homer Street* dated May 28, 2007; and, all that portion of Hamilton Street included within the heavy outline and illustrated isometrically on a plan of survey, a reduced copy of which is attached as Appendix C to the Administrative Report; be closed, stopped-up and that easements be granted to the owner of abutting Lot B of Lot 12 Block 76 District Lot 541 Plan 6488 ("Lot B") to contain the portions of the existing building which encroach onto Homer Street and Hamilton Street. The easements to be for the life of the encroaching portions of the existing building on Lot B and to be to the satisfaction of the Director of Legal Services.
  - C. THAT fees for the document preparation, registration and use of the easements referred to in B above are to be in accordance with those charged for in an agreement prepared pursuant to the Encroachment By-law.
  - D. THAT the Director of Legal Services be authorized to execute all documents and plans required.

E. THAT the authorities granted in A, B, C and D above be subject to the Approving Officer granting approval of the application to convert the previously occupied building situated on Lot B to strata title ownership.

#### A. Administrative Motions

1. Closing a portion of lane north of 2<sup>nd</sup> Avenue, east from Cambie Street; a portion of lane west of Wylie Street, south from 1<sup>st</sup> Avenue; and a portion of the east side of Cambie Street south of 1<sup>st</sup> Avenue (VanRIMS No. 13-2000-40)

MOVED by Councillor Lee SECONDED by Councillor Capri

THAT WHEREAS:

- 1. The City of Vancouver is the owner of all the streets and lanes lying within the limits of the City of Vancouver;
- 2. There is a proposal to re-develop privately owned Lot B Plan 12940; Lots 7, 8, and 9 Plan 5832; Lot A Plan 6163; Lot C, Except Part in Explanatory Plan 17673 Plan 13533; and Lot D Plan 13533; all of Block 2 District Lot 302;
- The proposal requires the closure of: a portion of lane north of 2<sup>nd</sup> Avenue, east from Cambie Street; a portion of lane west of Wylie Street, south from 1<sup>st</sup> Avenue; and a portion of the east side of Cambie Street south of 1<sup>st</sup> Avenue;
- 4. The portion of lane to be closed adjacent to said Lots 7, 8, and 9 was dedicated by the deposit of Plan 5832 on August 3, 1927;
- 5. The portion of lane to be closed adjacent to said Lot A was dedicated by the deposit of Plan 6163 on November 23, 1929;
- 6. The portion of road to be closed adjacent to said Lot B was dedicated by the deposit of Plan 12940 on March 7, 1968;
- 7. The said portions of road and lane to be closed (the "Road and Lane") are no longer required for municipal purposes;
- 8. That Part of Lot C in Explanatory Plan 17673 Block 2 District Lot 302 Plan 13533 ("Part C"), established as road by document filed N44490L in 1985, is still required for municipal purposes and for the sake of simplicity and clarity is required to be dedicated as road;
- 9. The City requires the dedication as road of a 15.6 square metre area and a 21.7 square metre area along 1<sup>st</sup> Avenue, and a 253.9 square metre area along 2<sup>nd</sup> Avenue and Cambie Street;
- 10. The City requires a Statutory Right of Way adjacent to Cambie Street for access, utilities, and bridge maintenance;
- 11. The City requires an option to purchase over a portion along 2<sup>nd</sup> Avenue that is occupied by a heritage building;

12. The said Road and Lane will be conveyed to the owner of said Lot B and subdivided with said Lots 7, 8, and 9, Lot A, Lot C, Lot D, and Part C to form a single parcel and dedicate road to the satisfaction of the Approving Officer.

THEREFORE BE IT RESOLVED THAT the 307.1 square metre portion of lane dedicated by the deposit of Plan 5832 adjacent to Lots 7, 8, and 9 Plan 5832; the 231.1 square metre portion of lane dedicated by the deposit of Plan 6163 adjacent to Lot A Plan 6163; and the 49.3 square metre portion of road dedicated by the deposit of Plan 12940 adjacent to Lot B Plan 12940; all of Block 2 District Lot 302; the same as shown within heavy bold outline on the Reference Plan prepared by Gregory Marston, B.C.L.S., attested to on the 17<sup>th</sup> day of October 2006, and marginally noted "FILE 9214-06", be closed, stopped up and conveyed to the owner of abutting Lot B Block 2 District Lot 302 Plan 12940;

BE IT FURTHER RESOLVED THAT the said portions of road and lane to be closed be subdivided with the said abutting Lot B; Lots 7, 8, and 9 Plan 5832; Lot A Plan 6163; Lot C, Except Part in Explanatory Plan 17673 Plan 13533; Lot D Plan 13533; and That Part of Lot C in Explanatory Plan 17673 Plan 13533; all of Block 2 District Lot 302; to form a single parcel and road as shown within heavy bold outline on the Subdivision Plan prepared by Gregory Marston, B.C.L.S., attested to on the 17<sup>th</sup> day of May 2007, and marginally noted "FILE 9214-13", and that a Statutory Right of Way and Option to Purchase be granted to the City, to the satisfaction of the General Manager of Engineering Services, the Director of Legal Services and Approving Officer.

2. Closing portions of Homer Street and Hamilton Street adjacent to 1228 Homer Street (VanRIMS No. 13-2000-40)

MOVED by Councillor Capri SECONDED by Councillor Cadman

THAT WHEREAS:

- 1. The City of Vancouver is the owner of all the streets and lanes lying within the limits of the City of Vancouver;
- Portions of the building constructed on Lot B of Lot 12 Block 76 District Lot 541 Plan 6488 encroach onto the easterly side of Homer Street southerly of Davie Street;
- 3. The portion of Homer Street encroached upon, abutting said Lot B, was dedicated by the deposit of Plan 210;
- 4. To provide for the registration of an easement to contain the said encroachments onto Homer Street, as required by Section 244 of the Strata Property Act, it is necessary to raise title to the portion of Homer Street that is encroached upon;

- 5. Portions of the building constructed on said Lot B encroach onto the westerly side of Hamilton Street southerly of Davie Street;
- 6. A title already exists for the portion of Hamilton Street upon which the building encroaches;
- 7. As required by Section 244 of the Strata Property Act it is necessary to register an easement to contain the said encroachments onto Hamilton Street on the title to that portion of Hamilton Street encroached upon, more particularly described as Lot K, Except: (A) Part in Plan 4544, (B) Portions Coloured Yellow on Plan 4959, (C) Part in Explanatory Plan 17265, Block 76 District Lot 541 Plan 3469, established as road by document filed BJ374292 in 1995;
- 8. To enable Council to grant the required easements to contain the said encroachments it is necessary for Council to close and stop-up the volumetric portions of Homer Street and Hamilton Street that are encroached upon;

THEREFORE BE IT RESOLVED THAT the Director of Legal Services be authorized to make application on behalf of the City of Vancouver to raise title in the name of the City of Vancouver to that portion of road dedicated by the deposit of Plan 210 and included within the heavy bold outline on a Reference Plan attested to by J. Neil Bennett, B.C.L.S. completed on the 22nd day of May, 2007, marginally numbered DRAWING FILE: R12927.DWG (SL); and

BE IT FURTHER RESOLVED THAT all that volumetric portion of Homer Street included within heavy bold outline and illustrated isometrically on a plan of survey certified correct by J. Neil Bennett, B.C.L.S. completed on the 22nd day of May, 2007, marginally numbered DRAWING FILE: Ex12827.dwg (SL), be closed, stopped-up and that an easement be granted to the owner of abutting Lot B of Lot 12 Block 76 District Lot 541 Plan 6488 to contain the portions of the existing building which encroach onto Homer Street; and,

BE IT FURTHER RESOLVED THAT all that volumetric portion of Hamilton Street included within heavy bold outline and illustrated isometrically on a plan of survey certified correct by J. Neil Bennett, B.C.L.S. completed on the 22nd day of May, 2007, marginally numbered DRAWING FILE: EX12927-3-F.dwg (DWS), be closed, stopped-up and that an easement be granted to the owner of said abutting Lot B to contain the portions of the existing building which encroach onto Hamilton Street; the said easements to be to the satisfaction of the Director of Legal Services.

- 3. Vancouver Port Policing Costs (VanRIMS No. 01-5500-30)

MOVED by Councillor Capri SECONDED by Councillor Lee

WHEREAS:

- The Federal Government is responsible for the security and policing provisions of all of Canada's Ports;
- The "make-up funding" for Vancouver's additional policing requirements expired on July 1, 2004;
- The funding of \$350,000 per year, that is paid by the Vancouver Port Authority to the Solicitor General, relates to policing operations directed at intelligence and security within the Port of Vancouver and is not specifically designated for Vancouver;
- The Port of Vancouver enjoys a collaborative, on-site presence with the Vancouver Police Department, that includes a partnership with CBSA, RCMP and the Coast Guard; and
- The Vancouver Port Authority recommends that policing services are best handled by the police of local jurisdiction and the RCMP, as these police forces possess the capacity and personnel to better manage criminal intelligence and emergency response than would a stand-alone port police force;

THEREFORE IT BE RESOLVED THAT Vancouver City Council ask the Mayor to request the Minister of Public Safety and Solicitor General, the Honourable Stockwell Day, to reinstate the compensatory funding for the Vancouver Police, as a critical element to effective policing in the Port of Vancouver.

#### 4. Federation of Canadian Municipalities' Getting to 30% National Campaign - Report Back on March 16, 2007 Regional Event (VanRIMS No. 07-2400-10)

#### MOVED by Councillor Anton SECONDED by Councillor Deal

BE IT RESOLVED THAT Council request that the Greater Vancouver Regional District (GVRD) Sustainable Region Initiative host a regional follow-up event in March 2008 in support of the Federation of Canadian Municipalities' Getting to 30% National Campaign, prior to the 2008 municipal elections, to continue the work of increasing women's participation in municipal government.

## ENQUIRIES AND OTHER MATTERS

## 1. Mayor's Arts Awards (VanRIMS No. 01-5200-50)

Councillor Deal advised of concerns from the arts community on whether the Mayor's Arts Awards will be held in 2007.

The Mayor advised the awards will be held as soon as practicably possible.

## 2. City of Toronto Mayor's Campaign - One Cent of the GST Now (VanRIMS No. 01-5500-30)

Councillor Deal noted the FCM recently endorsed City of Toronto Mayor Miller's campaign to secure permanent funding for cities by requesting the federal government to give one cent of the GST to local governments. Councillor Deal called on the Mayor to support Mayor Miller's campaign and make the campaign a flagship of his and the City's websites.

## 3. Mental Health Facility (VanRIMS No. 01-5500-60)

Councillor Lee referred to a City held public meeting on May 30, 2007 at the Hastings Community Centre to discuss possible impacts of public safety because of a new mental health facility at 2750 East Hastings Street. He requested staff to provide a brief memorandum on what happened during the meeting, and what staff are planning to do to mitigate issues of misunderstanding with citizens.
