### **BUSINESS LICENSE HEARING MINUTES**

JUNE 13, 2007

A Business License Hearing of the Council of the City of Vancouver was held on Wednesday, June 13, 2007, at 9:30 a.m., in the Council Chamber, Third Floor, City Hall, to determine whether or not the City of Vancouver business license for the year 2007 granted to Menasbo Kiros (the "License Applicant") doing business as Afro Canadian Restaurant, for business premises located at 324 Cambie Street, Vancouver, British Columbia (the "Premises"), should be suspended or revoked.

lain Dixon, Counsel, was present on behalf of the City of Vancouver. Derek C. Creighton, Access Law Group, was present on behalf of the License Applicant.

Mr. Dixon advised that this matter had been referred to City Council by the Chief License Inspector pursuant to Section 4(2a) of the License By-law and Section 278 of the Vancouver Charter which states that Council has broad powers to revoke, suspend or uphold a business license. He also advised that it is at Council's discretion as to whether to issue a license to a particular business, which is the case at this hearing. Mr. Dixon also noted that the Chief License Inspector had issued a 2007 business license to the Applicant, and subsequently referred the license to Council to decide what can be done in the future.

Mr. Dixon referred the Panel to evidence before it as set out in documents which were considered by the Chief License Inspector in referring the business license application to Council, a letter from the Deputy Chief License Inspector and the evidence of witnesses, which set out allegations that the License Applicant has not properly managed the Premises by:

- a) carrying on business to the detriment of public order and safety in the neighbourhood;
- carrying on business to the detriment of other licensed businesses in the City of Vancouver;
- c) repeatedly violating the laws of the City of Vancouver.

In support of the allegations set out in the above-noted reports and evidence, Mr. Dixon called the following witnesses:

- Barb Windsor
- 2. Ken Suzuki
- 3. Detective Constable Darren Hudniuk
- 4. Constable Courtney Frail

Throughout the hearing of witnesses, Mr. Dixon also referred the Panel to additional colour photographs submitted as evidence at this hearing (on file in the City Clerks Office).

Mr. Creighton also directed questions to witnesses, and during the hearing of witnesses produced a summons detailing charges of fire code and By-law violations being faced by Mr. Kiros.

The Panel recessed at 11:00 a.m. and reconvened at 11:10 a.m. with the same members present.

Upon the questioning of Detective Constable Darren Hudniuk, Mr. Creighton requested Constable Courtney Frail leave the room, as Detective Hudniuk's testimony was regarding the same incident. Constable Frail left the room and did not return until it was time for her testimony.

The Panel also asked questions of witnesses, to clarify the evidence.

In support of the Licensee, Mr. Creighton called the following witnesses:

- 1. Philip Swartz, Owner of the Premises
- 2. Isaiah Kiflemarian
- Menasbo Kiros

A summary of witnesses' comments follows:

- Licensee is a good tenant and is of good character;
- review of previous license suspension and evidence presented by the City;
- size and use of basement;
- basement access and egress; and
- clarification of summons charges.

The following documentation was submitted on behalf of the Licensee (*on file in the City Clerk's Office*):

- article from "The Metro" (weekend edition), dated January 5 to 7, 2007;
- job invoice from Commercial Vent Cleaning dated May 7, 2007, for servicing the kitchen grease exhaust system.

Mr. Dixon and the Panel also asked questions of the Licensee's witnesses.

In closing, Mr. Dixon submitted the Licensee has been using the basement contrary to zoning and as a result, there are numerous fire violations, and the space is designed as a storage area and is not suitable for parties. Mr. Dixon also submitted that the setup of the basement indicates it is being used as a permanent liquor outlet and it is believable that parties occur frequently. Mr. Dixon noted there is a lengthy history of putting people in danger, allowing minors to consume alcohol and people congregating in the area; as a result, the Licensee has demonstrated neither willingness nor an ability to comply with By-laws and regulations.

In closing, Mr. Creighton noted the Panel has a duty to exercise an appropriate punishment, that attention was drawn to an ancillary matter that the Licensee was not aware of until the following day and that the Licensee is of good character and serves the Downtown Eastside Community well. Mr. Creighton also noted that revoking the business license would remove what life there is in the Downtown Eastside and bankrupt the Licensee. In lieu of revoking the license, Mr. Creighton recommended a three-week suspension with a strong warning that any prohibited use of the basement will result in a permanent suspension.

### PANEL MEMBERS DISCUSSION

Prior to making a decision, the Panel requested Mr. Dixon clarify the range of penalties, reviewed the evidence, and asked Mr. Dixon's, Mr. Creighton's and Ms. Windsor's opinions of the range of penalties.

## MOVED by Councillor Anton

- A. THAT the 2007 Business License for the City of Vancouver issued to Menasbo Kiros (the "License Applicant") dba Afro Canadian Restaurant, for business premises located at 324 Cambie Street, Vancouver, British Columbia (the "Premises") be revoked because the License Applicant has failed to properly manage the Premises by:
  - (a) carrying on business to the detriment of the safety of his customers and others in the neighbourhood; and
  - (b) repeatedly violating the by-laws of the City of Vancouver.
- B. THAT the Licensee, Menasbo Kiros, be permitted to reapply for a 2007 business license for the premises at 324 Cambie Street, Vancouver, British Columbia, provided renovations, satisfactory to the City of Vancouver, which restrict access to the basement, are made to the Premises.

#### CARRIED UNANIMOUSLY
