SUBJECT: 2007 Civic Childcare Grants - Allocation 2 of 3

RECOMMENDATION

THAT Council approve 51 Childcare Enhancement Grants totalling \$698,558 as listed in Appendix A, with conditions as noted; source of funds: 2007 Childcare Grants Budget, 2007 Operating Budget.

GENERAL MANAGER'S COMMENTS

The General Manager of Community Services RECOMMENDS approval of the foregoing.

COUNCIL POLICY

Council established the annual Civic Childcare Grants Program on October 23, 1990, as part of the Civic Childcare Strategy. The overall objectives of this grant program are:

- to support the viability, accessibility and quality of existing child care services;
- to assist child care initiatives in high need areas;
- to encourage and support efficient, coordinated administrative services required for a child care system in Vancouver;
- to lever other sources of child care funding whenever possible.

Council approved "Moving Forward" - Childcare: A Cornerstone of Childhood Development in April, 2002, which set out a strategic plan for child care and child development services for the City.

In June, 2005, Council approved combining the Inner City Sustaining, Program Enhancement and Inner City Bursary grants into one Childcare Enhancement grant to help offset operating costs, based on centre's licensed capacity for high need areas and tie to conditions of quality and affordability.

In June, 2006, Council approved revised criteria for the Childcare Enhancement grant.

On February 27, 2007, Council approved the 2007 Operating Budget with a 2% cost of living increase in the amount of \$1,096,800 for the Civic Childcare Grants.

Approval of grant recommendations requires eight affirmative votes.

SUMMARY

This report recommends the allocations for the Childcare Enhancement Grant which targets services to children in high need neighbourhoods. Funding is provided on an annual basis to assist in keeping parent fees below the city average, provide extra staff ratios in high need programs, develop and implement continuous quality improvement, support co-ordinated administration and offer hot breakfast/lunch and nutritious snack programs.

This year, staff received grant requests for 57 programs, of which six were deemed ineligible as they did not meet the grant criteria. The majority of qualifying programs reside in the top ten most at-risk communities according to the Early Development Instrument developed by Dr. Clyde Hertzman - UBC. The recommended allocation is \$698,558 to support 51 licensed group care programs for infants, toddlers, three to five year olds, out-of-school age children full and/or part time, and child minding. The grants support approximately 1,515 spaces serving an estimated 1,664 children.

PURPOSE

This report makes recommendations for the Childcare Enhancement Grant to 51 licensed non-profit child care programs serving children in high need areas. Specifically, the grant supports maintaining fees at or below city averages, hot lunch, breakfast and/or snack programs, additional staff ratios, coordinated administration or quality improvement.

This is the second of three reports regarding the 2007 Childcare Grants Program.

BACKGROUND

Recognizing that child care is a Provincial mandate and primarily funded by parent fees, Councils, since 1990, have assisted children and families attending child care programs in high need neighbourhoods in Vancouver. Vancouver City Council established the annual Civic Childcare Grants program on October 23, 1990, as part of the Civic Childcare Strategy. The purpose of the Child Care Civic Grants Program is to help support a comprehensive publicly

funded child care system that is affordable, accessible and of high quality. Grant funding specifically provides enhanced program quality without necessitating an increase in parent fees.

Purpose of the Grant

The purpose of the Childcare Enhancement grant is to:

- Strengthen co-ordinated administration through the community hub model to increase administrative effectiveness among small non profits;
- Develop and implement a quality improvement plan to increase the quality of the care provided;
- Provide a food supplement program (e.g. hot breakfast and lunch) including monthly menu plan based on sound nutritional planning and a staff schedule for food preparation to increase the nutrition of the children;
- Enhance staff ratios to better serve high-need children;
- Support affordability by maintaining fees at or below city average.

Client Profile and High Need Neighbourhoods

Dr. Clyde Hertzman argues a universal versus targeted approach to child care; however, given the Provincial mandate for child care, Councils have targeted high need programs in high need neighbourhoods in Vancouver.

High need programs are identified by the percentage of:

- children from single parent families,
- children who receive Provincial subsidy,
- children from new immigrant or refugee families,
- children who speak English as a second language,
- Aboriginal children.

Funding Amount

The grant allocation provides a consistent level of funding for all eligible programs licensed based on the type of care and the number of hours and staff ratios required to deliver the service. A full-time equivalent space formula is applied.

The maximum eligible amount for this grant is \$27,000, which ensures a wider distribution of funding to a variety of programs.

DISCUSSION

In 2006, Council allocated \$670,104 to 51 programs with 1,429 spaces serving 1,545 children. This year \$698,558 supports an estimated 51 childcare programs with 1,515 spaces serving 1,664 children - an increase of 86 spaces. This is a result of changes in program type or number of spaces.

Of the 51 grant recipients, 42 were located and/or serving families in the ten areas most at risk on any scale of the Early Development Instrument. The remaining programs, although not in high need neighbourhoods, have high numbers of children from families at risk.

One of the objectives of the Childcare Enhancement Grant is to assist with the affordability of child care. All programs maintain their fees at or below city averages. The city average for group child care for 3-5 year olds is \$636. The current average fee charged by grant applicants is \$581.

SOCIAL IMPLICTIONS

Cost of Living Indicators ("Worldwide Cost of Living Survey") suggest that Vancouver is the second most expensive Canadian city to live in. Families with a median income of \$51,268 (2001 census), with one infant and one three-year old in child care would spend approximately \$19,608/year (2006 Westcoast childcare Resource Centre Fee Survey) on child care fees, or roughly 38% of annual income. For lone parent families that have a median income of \$30,814, this is 64% of their income.

While spending a significant percentage of income on child care fees is not unique to Vancouver, the additional high cost of living (housing, etc.) in Vancouver presents many challenges, especially for those with lower income. The support that is targeted by Council to lower income families with children in child care helps to alleviate a portion of this financial burden.

FINANCIAL IMPLICATIONS

The 2007 Operating Budget for Civic Childcare Grants is \$1,096,800 with \$698,558 recommended to be allocated for Childcare Enhancement Grants (as listed in APPENDIX A).

CONCLUSION

This is the second of three reports related to the allocation of the 2007 Childcare Grants. Social Planning is recommending Council approval for:

51 Childcare Enhancement grants (\$698,558)

The Childcare Enhancement grant funding will support 1,664 children, in 1,515 spaces in 51 licensed group child care programs. This leaves a balance of \$25,000 in the Childcare Grants budget for Research and Innovation, Program Stabilization and Program Development grants to be allocated later this year.

Themes and Trends

Staff and board members from the respective organizations were asked to share any themes, trends and issues or challenges they have experiences over the past year. They have reported the following trends:

- Multiple barriers for families applying for Provincial child care subsidy (high turnover of Ministry staff, application process very long and confusing, parents needing to reapply every three months, long wait times for processing applications).
- Elimination of the Westcoast Child Care Resource Centre outreach worker is anticipated to create more difficulty for parents accessing subsidy.
- Increased drug use and needles in Mt. Pleasant child care playgrounds.
- Increased waitlists for the 0 5 group.
- Families desperate for child care.
- Children arriving at the centre on Monday morning hungry after the weekend. Parents asking to take left over food home.
- Increasing number of families living in shelters in the DTES and having to deal with bed bugs.
- Increasing number of parents with dual diagnosis (mental health concerns and addictions).
- Dropping enrolment for school-age care in Grandview and increasing demands in Cedar Cottage.
- Enquiries from families from out of country requesting child care.
- Increased cooperation among Vancouver child care organizations to work together.
- Increase in fees due to Provincial child Care Operating Fund reduction (see below for a more detailed discussion) and families unable to afford fees.
- Increased emotional and financial stress of families and frustration regarding the Provincial funding reductions.
- Recruiting and retaining staff a challenge why?
