RECOMMENDATION

1. Annual Report for the Year 2006: Advisory Committee on Diversity Issues (VanRIMS No. 08-3000-11)

The Committee had before it an Other Report dated June 7, 2007, in which the Advisory Committee on Diversity Issues provided Council with a report on its activities for the period of January 1 to December 31, 2006. The City Manager submitted the report for information.

Monica Kay, Director, EEO, was present to respond to questions from Council.

MOVED by Councillor Capri THAT the Committee recommend to Council

THAT the Other Report dated June 7, 2007, entitled "Annual Report for the Year 2006: Advisory Committee on Diversity Issues" be received for information.

2. Animal Welfare Grant Funds (VanRIMS No. 05-5000-10)

The Committee had before it an Administrative Report dated May 28, 2007, in which the Chief License Inspector outlined the application process and objective designed for animal-related grant applications for 2008. A portion of the funds for 2007 are recommended to be dispersed in accordance with 2006 allocation based on an application from the Wildlife Rescue Association. The General Manager of Community Services recommended approval.

Liza Jimenez, License Office, provided an overview of the report, and along with Paul Teichroeb, Chief License Inspector, noted the lack of cat care facilities in the City and also provided clarification on intended funding allocations for 2008.

Janice Dickie, Wildlife Rescue Association of BC, provided an overview of work done by the Association, including oil spill response, and noted the significance to Vancouver, located adjacent the harbor. Ms. Dickie also provided details on funding sources for the Association, and information on government legislation related to oil spills.

- A. THAT Council approve a 2007 grant of \$5,000 to the Wildlife Rescue Association of British Columbia: the source of the funds for this request would be half of the total funds allocated to animal-related applications as directed by the License Office.

THAT Council approve the Application Process and Form, generally as set out in the Administrative Report dated May 28, 2007, entitled "Animal Welfare Grant Funds" and in Appendix A, for 2008 and future years for animal-related grant applications that traditionally were funded under the Miscellaneous Grants category.

3. Major Exhibiting Institutions - 2007 Operating Grant Recommendations (VanRIMS No. 05-5000-10)

The Committee had before it an Administrative Report dated June 6, 2007, in which the Co-Director (Grants, Awards & Support Programs), Office of Cultural Affairs, provided a review of the five major exhibiting institutions' 2006 activities and recommended approval of 2007 Operating Grants as outlined in the report. The General Managers of Community and Corporate Services recommended approval.

Karen Hasselfelt, Cultural Planner, provided an overview of the report and, along with Sue Harvey, Managing Director of Cultural Services, responded to questions related to the cultural grants programs review and bus access to the institutions. The following speakers provided an overview of work done by their organizations, responded to questions related to programs, budgets, funding sources and fund raising initiatives, and requested Council support staff's recommended 2007 operating grants:

Council discussion followed related to parking issues, potential revenue from same, bus access to the various institutions, and options for improved access to a number of those institutions.

The Committee had before it an Administrative Report dated June 4, 2007, in which the Director of Social Planning recommended approval of a grant to the Downtown Eastside Women's Centre to support outreach and services to Chinese seniors in the Downtown Eastside and Strathcona area. The General Manager of Community Services recommended approval.

Anne Kloppenborg, Senior Social Planner, responded to questions from Council regarding the unallocated balance in the Community Services Grants budget, and the City's policy for dissemination of these unallocated funds.

Cynthia Low, Administrative Coordinator, Downtown Eastside Women's Centre Association, provided an historic overview of the Association, and responded to questions from Council regarding the status of the facilitator position and development of their work plan.

5. Closure of Federal Commercial Heritage Properties Incentive Fund Program (CHPIF) (VanRIMS No. 01-5500-30)

The Committee had before it an Other Report dated May 30, 2007, in which the Vancouver Heritage Commission and staff recommended that the City send a letter to the Government of Canada urging the reopening and/or expanding the CHPIF Program to address a broader range of rehabilitation and revitalization issues.

Zlatan Jankovic, Planner, Heritage Group, was present and responded to questions from Council related to projects eligible for funding, and the rationale for the requested expansion of the program. Mr. Jankovic also suggested the letter include points as set out in the appendix to the report.

The lack of reference in the appendix to non-profits was noted by a Council member.

B. Motions on Notice

1. Emergency Housing Meeting to Address Olympic Housing Legacy (VanRIMS No. 11-2400-10)

MOVED by Councillor Deal SECONDED by Councillor Louie

WHEREAS the citizens of Vancouver voted in favour of a sustainable, socially inclusive Olympics;

WHEREAS the Vancouver 2010 Bid Corporation and its Member Partners promised to create an affordable housing legacy as part of their commitment to hosting the games;

WHEREAS the Inner-City Inclusive Housing Table Report recommended the construction of 800 units of social housing a year for four years, starting as soon as possible;

WHEREAS Vancouver is on pace to have more people sleeping on the street (3100) than in the Olympic Village (2800) during the 2010 Olympics;

WHEREAS the provincial government has shown a recent willingness to provide funding and support for affordable housing in Vancouver;

WHEREAS many citizens of Vancouver voted in favour of the Olympic referendum based on the Inner City Inclusivity Agreement;

AND WHEREAS the 2010 Olympic Games will not simply be a showcase for Vancouver, but for all of Canada;

THEREFORE BE IT RESOLVED THAT

The City of Vancouver convene an emergency meeting to deal with Olympic housing commitments and homelessness; with

- a) participants to include the provincial and federal governments, VANOC, and housing stakeholders; and
- b) the meeting be held within 60 days.

Referred

The Chair advised a request to speak on the motion had been received. Council agreed to refer consideration of the motion to the June 28th meeting of the Standing Committee on Planning and Environment to hear from speakers.

Councillor Anton requested the Deputy City Manager provide a verbal update on trademarking "EcoDensity". The Mayor advised emails related to this matter could be shared.
