Subject: Requesting Endorsement for Land for Multicultural Helping Village

The Multicultural Helping House Society (MHHS), with the support of the City of Vancouver, has had the privilege of serving the community's newcomers for over 6 years now, the last 4 in its own center called the Multicultural Helping House on Fraser Street and 32 Ave. Since it completed in May 2003, we have grown so fast in terms of services, programs, clients, staff and volunteers, that we have now run out of space. To accommodate its existing needs and future growth, MHHS is seeking to build a new and larger facility for the communities we serve.

We would like to request free or subsidized land from the City of Vancouver on which to build

Called the Multicultural Helping Village, the new facility will build upon the current services of MHHS in helping newcomers succeed in Canada. Such services include settlement and employment assistance to newcomers including the popular Bamboo Network, community development for ethnic seniors, youth, families and caregivers, capacity building and citizenship training for newcomers, building bridges among cultures through understanding of arts and culture of newcomers and of Canada. The focus will be the Filipino Canadian community, now the third largest ethnic community in BC, and ethnic communities that we work with that do not yet have a home and services of their own such as emerging minority communities of South Asia, Southeast Asia, and Hispanic communities.

We envision that this project will be a partnership between Federal Government, Provincial Government, City of Vancouver, and Multicultural Helping House Society in consortium with community organizations.

We envision that the village will contain 4 types of uses:

- newcomer integration services including counseling offices, employment resource center, training center, program space for seniors, youth, and families;
- a multicultural center containing spaces for use by different ethnic and community ogranizations such as office, meeting, arts and culture, and classroom space, and
- temporary group housing for newly arrived newcomers, refugees, student housing and respite housing for live-in caregivers during their days off
- entrepreneurial uses to help sustain the project financially in the future like private office rental for establishments compatible with the multicultural village.

Preliminary scoping of requirements indicates that we will need for phase 1, approximately 36,000 sq ft, requiring approximately 12,000 sq ft of land. p. 1 of 2
