# 1. Final Report of the Property Tax Policy Review Commission

The Chair of the Property Tax Policy Review Commission, Professor Stan Hamilton, presented the final report of the Commission. Professor Hamilton, Dr. Enid Slack, Mr. Peter Adams, and Ms. Karen Levitt (staff) responded to questions.

MOVED by Councillor Ladner

- A. THAT Council receive the final report of the Property Tax Policy Review Commission for information.
- B. THAT Council instruct staff to implement the public consultation process design with the timeline described in this report, at a cost not to exceed \$25,000, with source of funding to be the 2007 Contingency Reserve.
- C. THAT Council instruct staff to report back to Council by no later than the end of January 2008 with staff's analysis of and comments on the Property Tax Policy Commission's final recommendations.
- D. That council send a formal letter of thanks to the Property Tax Policy Review Commission for their work.

2. Vancouver 2010 Winter Games Live Site Plan

The Chair advised that a request to speak was received. The Chair proposed that Council proceed with the presentation and discussion, and refer the vote on the recommendations to the September 20, 2007 Standing Committee on Planning and Environment after hearing from the speaker.

Councillor Stevenson rose on a point of order to ask whether it is Council's normal practice to have the presentation and discussion at one meeting but refer the vote to another meeting to hear from speakers. The Chair advised that the common practice when receiving a request to speak is have the presentation and hold consideration of

the recommendation to the Standing committee meeting after hearing from the speaker.

Council agreed to refer the debate and vote on the recommendations to the September 20, 2007 Standing Committee on Planning and Environment after hearing from the speaker.

Dave Rudberg, General Manager, Olympic and Paralympic Operations and Tom Stulberg, Fireworks Marketing Group presented the live site plan for the Vancouver 2010 Winter Games. Staff responded to questions concerning the report.

MOVED by Councillor Anton

- A. THAT Council approve the two-site "Live Site" concept utilizing, on a temporary basis, the Beatty Street (former Bus Depot) site and David Lam Park and authorize further work on the design and operation;
- B. THAT concept approval be given to use Hamilton/Mainland Streets as the connecting link between the two Live Sites and that Robson Street be the connector to the Provincial Robson Square activation with further work undertaken on the design and operation for the connectors;
- C. THAT staff work with the partners including VANOC, Resort Municipality of Whistler, Province of British Columbia and City of Richmond on the Live Site/celebration planning to ensure that the programming and development plans are coordinated to deliver a consistent program and achieve cost efficiencies;
- D. THAT community feedback continues with the adjoining businesses and residences on the Live Site concept, design and operation;
- E. THAT staff be authorized to submit an application for funding to the Federal Government and to seek cost sharing opportunities with sponsors and other stakeholders, and
- F. THAT \$200,000 be approved for the next phase of the Live Site design and operational planning, source of funding to be the Olympic Legacy Reserve, once the Reserve is funded. Interim funding of \$200,000 for 2007 to be borrowed from the 2007 Olympic and Paralympic Operations budget and repaid once the Olympic Legacy Reserve is funded.

# **NEW BUSINESS**

## 1. The British Columbia Climate Action Charter

The following motion was submitted by Councillor Capri with notice that the motion would be on the agenda of the Standing Committee on Planning and Environment on September 20, 2007.

MOVED by Councillor Capri SECONDED by Councillor Ladner

WHEREAS the City of Vancouver has committed to taking actions to meet ambitious short and long-term targets to reduce greenhouse gas emissions from its own operations and in the community,

AND WHEREAS the City will be more successful in meeting its own greenhouse gas reduction targets as well as serving to mitigate climate changes by working in partnership with other local governments, the Union of British Columbia Municipalities and the Province of BC,

AND WHEREAS the City of Vancouver has a responsibility to play a leadership role amongst local governments in BC by sharing its insights and experiences in addressing climate change,

AND WHEREAS the purpose of the British Columbia Climate Action Charter (attached) is to establish a partnership between the Province, UBCM and signatory local governments to reduce GHG emissions and develop a common approach to carbon neutrality,

AND WHEREAS the Province and the UBCM have invited councils to signal their acceptance of the on behalf of their local governments at the 2007 UBCM Convention (September 24<sup>th</sup> to 28<sup>th</sup>),

AND WHEREAS the full implications of becoming carbon-neutral can be further assessed by the City and Council in the future once the Province and UBCM have developed the structure and criteria for carbon offsets and a carbon market for BC,

AND WHEREAS the Charter is an inspirational agreement and not legally binding,

AND WHEREAS the Province and UBCM have invited signatory local governments to include a statement of their initiatives and commitments as an appendix to the Charter,

### THEREFORE BE IT RESOLVED

• THAT the City of Vancouver sign on to the British Columbia Climate Action Charter at the 2007 UBCM Convention, and

• THAT Staff be directed to prepare an appendix outlining the City's greenhouse gas commitments, activities and plans, to be attached to the Charter at the 2007 UBCM Annual Convention.

2. Pacific Spirit Regional Park

MOVED by Councillor Cadman SECONDED by Councillor Louie

WHEREAS:

Pacific Spirit Regional Park is a significant 2000-acre natural park that borders on Vancouver parks, and is annually visited by more than 1.5 million Vancouver area residents and tourists;

Any diminishment of Pacific Spirit Park would jeopardize the integrity of Vancouver's park system, and the Metro Vancouver regional park system;

Pacific Spirit Park is administered by the Metro Park Committee with Councillor Elizabeth Ball representing the City on that committee;

There have been recent proposals that a portion of Pacific Spirit Park be given away as part of negotiations regarding the future of the University Golf Course;

THEREFORE BE IT RESOLVED THAT:

Vancouver City Council opposes any proposal or plan that would reduce or give away any portion of Pacific Spirit Regional Park; and

Council, through its representative at the Metro Vancouver Park Committee, bring this motion to the attention of the Metro Park Committee at the earliest opportunity.

Not put

The Chair ruled the motion out of order.

Councillor Cadman challenged the ruling of the Chair.

The Chair then put the question Shall the ruling of the Chair be sustained? (Councillors Cadman, Louie, Deal, Chow, and Stevenson opposed)

A two-thirds majority of those present is required to overrule the ruling of the Chair. Therefore the ruling of the Chair was SUSTAINED.

### 3. Zoning and Development By-law "Social Service Use"

MOVED by Councillor Louie SECONDED by Councillor Chow

WHEREAS churches are charitable organizations that provide much needed support to those who are less advantaged;

AND WHEREAS various faith communities have come together to form the "Faith Communities Called to Solidarity with the Poor" group;

AND WHEREAS they feel the City has imposed unacceptable and onerous conditions under the "social service use" permit process;

AND WHEREAS it is important that City Council balance the livability needs of our neighbourhoods with these much needed services;

THEREFORE BE IT RESOLVED THAT staff be directed to review the definition of "Church use" and the applicability of "Social Service Use" with the faith community and that interested parties be given an opportunity to address Council on this matter.

#### AMENDMENT MOVED by Councillor Lee

THAT the wording 'interested parties be given an opportunity to address Council on this matter.' be replace with 'staff report back to Council with a memorandum on the progress made by the City with the faith communities on the core issues.' The amended motion would read as follows:

THAT staff be directed to review the definition of "Church use" and the applicability of "Social Service Use" with the faith community and that staff report back to Council with a memorandum on the progress made by the City with the faith communities on the core issues.

#### AMENDMENT TO AMENDMENT MOVED by Councillor Louie

THAT the wording 'staff report back to Council with a memorandum on the progress made by the City with the faith communities on the core issues.' be replaced with 'the motion be referred to the Standing Committee on City Services and Budgets to allow for the public to speak to the motion.' The amended motion would read as follows:

THAT staff be directed to review the definition of "Church use" and the applicability of "Social Service Use" with the faith community and that the motion be referred to the Standing Committee on City Services and Budgets to allow for the public to speak to the motion.
