 - A. THAT, subject to B and C below, Council approve a one time donation of three (3) City of Vancouver decommissioned Fire Engines to the Rotary Clubs of the Lower Mainland of BC World Help Network, Certificate of Incorporation Number -S-37357 Address; #315-475 Howe St. Vancouver, BC V6C 2B3 (for the benefit of the National Fire Service of El Salvador).
 - B. THAT the transfer, insurance, shipping, export and any other legal documentation required to implement A above be executed and delivered by the City's Director of Legal Services.
 - C. THAT no legal rights or obligations will be created or arise from Council's approval of A above unless and until the legal documentation referred to in the Administrative Report *Donation of Three (3) Decommissioned Fire Engines to the Rotary Clubs of the Lower Mainland of BC World Help Network (for the benefit of the National Fire Service of El Salvador)* is reviewed, approved, and executed by the City's Director of Legal Services.

- B. Motions on Notice
- 1. Free Parking for Veterans during Remembrance Day Week 2007 (VanRIMS No. 13-5500-20)

MOVED by Councillor Louie SECONDED by Councillor Stevenson

WHEREAS the Federal Government declared 2005 the Year of the Veteran and Canadians celebrated, honoured and remembered the contributions and sacrifice of our veterans throughout the year;

AND WHEREAS the City of Vancouver honours veterans and their service every year through a ceremony at the victory Square Cenotaph and other locations like the Chinatown Cenotaph to mark Remembrance Day;

AND WHEREAS 2007 marks the 62nd anniversary of the end of the Second World War and many of our armed forces are currently engaged overseas;

AND WHEREAS City Council has previously unanimously supported the provision of free meter parking for Veterans during the week of Remembrance Day;

AND WHEREAS City Council failed to honour our veterans in 2006 with free meter parking;

AND WHEREAS City Council's direction to staff to explore options to provide free metered parking for Vancouver resident Veterans on an ongoing basis for future weeks of Remembrance Day and report back to council for consideration is unlikely to be fulfilled in time for 2007 Remembrance Day;

THEREFORE BE IT RESOLVED THAT the city of Vancouver provide free meter parking from Sunday, November 4, 2007 to Sunday, November 11, 2007 for Veterans with veteran's license plates as a way to acknowledge their sacrifice and service to our community.

Referred

The Chair noted that a request to speak on Motion B.1 has been received. Council agreed to refer the motion to the Standing Committee on City Services and Budgets meeting on October 18, 2007 to be considered with the Administrative Report *Veterans Parking*, dated September 26. 2007 (Agenda Item 3).

NEW BUSINESS

1. Financial and Staffing Impacts of Civic Strike (VanRIMS No. 07-1000-20)

MOVED by Councillor Chow SECONDED by Councillor Deal

WHEREAS the residents of the city of Vancouver have endured three months of decreased and suspended services during the civic strike; and

WHEREAS the 2000 civic strike lasted 7 weeks and produced a net savings to the City of \$1.3 million; and

WHEREAS the 2007 job action by CUPE 15 and CUPE 1004 lasted for 12 weeks with CUPE 391 issues still not resolved as of October 15; and

WHEREAS Vancouver City Council voted to use any savings from the strike to reduce property taxes in 2008; and

WHEREAS exempt staff were deployed to perform a variety of services during the strike; and

WHEREAS there have been reports of significant resignations of inside workers, outside workers and exempt staff since the beginning of the strike; and

WHEREAS these staff losses could have implications for the City's ability to return to full operational status;

THEREFORE BE IT RESOLVED THAT Council request staff to report back with:

- a full accounting of gross and net savings realized by the City of Vancouver and Vancouver Park Board during the strike;
- a complete analysis of city spending on operations and services during the strike; and
- o an accounting of all staff (inside workers, outside workers and exempt staff) who have resigned since the beginning of the strike.
