SUBJECT: 2008 Engineering Fee Report

# **RECOMMENDATION**

- A. THAT Council approve increases in the Engineering Services Department Permit Fees totalling an estimated amount of \$180,700, as set out in Appendix A to this report;
- B. THAT Council approve the introduction of credit card payment for fees identified in Appendix A of this report up to a maximum of \$8000.00 per transaction and that a budget of \$24,400 be added to cover bank charges with full offset through an additional 1% increase to the fees eligible for credit card payment;
- C. FURTHER THAT the Director of Legal Services be instructed to prepare bylaws to amend the Street and Traffic By-law, Encroachment By-law, Crossing Bylaw and Street Vending By-law, and the Street Distribution of Publications By-law all generally in accordance with Appendix A.

## **COUNCIL POLICY**

Permit fees are reviewed periodically to comply with Council policy that fees recover the full cost of providing services or are equivalent to competitive charges where the fee is of a market nature.

#### **PURPOSE**

The purpose of this report is to seek Council's approval of a schedule of Engineering Permit Fees which will generate an additional \$180,700 per year in 2008. Council is also being asked to approve an additional 1% fee increase for fees payable by credit card to create a \$24,400 budget for all associated bank charges.

#### **BACKGROUND**

The Engineering Services Department generates revenue from several permits, under the authority of the Street and Traffic By-Law No. 2849, Street Vending By-Law No. 4781, Crossing Bylaw No. 4644, Street Distribution of Publications Bylaw No. 9350 and the Encroachment By-Law No. 4243.

Fees were last adjusted in January, 2007.

## **DISCUSSION**

## Inflationary Adjustments

A list of proposed fee increases is attached to this report as Appendix A. As part of the City's budget-building process, a general inflationary adjustment of 2.75% for revenues has been established. All of the fees in Appendix A have been increased by this inflationary amount.

The total increased revenues generated by the recommended fee increases in Appendix A amount to \$180,700 per year.

## Introduction of Credit Card Payment Option

For many of the fees collected from the ground floor service counter, Engineering Services would like to offer the option of credit card payment. Allowing credit cards as a form of payment will generate carrying fees and require an expenditure budget. Payment by use of credit cards would be limited to \$8000.00 per transaction. Fees for anchor rod permits, for instance, typically exceed the \$8000 limit and therefore will not be eligible to pay by credit card and will not be increased beyond the standard 2.75%. Multiple transactions to pay for a single permit will not be allowed.

The fees for which credit card payment would be accepted have been identified in Appendix A. In order to accommodate the anticipated credit card fees, an additional 1% increase is recommended on those fees where credit card payment will be accepted. The additional 1% increase will generate \$24,400 in additional revenue. It is recommended that budgets totalling \$24,400 for bank charges be created in the following cost centres:

## Housekeeping By-law Amendment

A minor by-law revision is proposed to incorporate a previous Council decision into the Street Vending By-law. On April 25, 2002, Council approved an annual fee for Mobile Special Event Vending Permits equivalent to the annual fee for non-motorized mobile ice cream vendors (a similar activity). This fee is charged to vendors selling wares on foot in the vicinity of special events. It is recommended that this fee be incorporated into the Street Vending By-law by adding the category " (b.2) mobile special event vendor......\$133.26" in Schedule A (Permit Fees) of the Street Vending By-law.

#### CONCLUSION

The recommendations of this report will provide for an inflationary adjustment to several Engineering permit fees and allow for the introduction of credit card payment on selected Engineering Fees.
