# DECEMBER 12, 13 AND 19, 2007

A Special Meeting of the Council of the City of Vancouver was held on Wednesday, December 12, 2007, at 7:30 p.m., in the Council Chamber, Third Floor, City Hall, for the purpose of hearing speakers on the City/Province Social and Supportive Housing Partnership and Memorandum of Understanding. The meeting reconvened at 7:33 p.m. on Thursday, December 13, 2007, and at 6:35 p.m. on Wednesday, December 19, 2007, to continue hearing speakers. The minutes have been consolidated for ease of reference.

1. City/Province Social and Supportive Housing Partnership - Memorandum of Understanding (VanRIMS No. 08-2000-22)

At its Regular Council meeting on November 13, 2007, Vancouver City Council heard a Report Reference on a partnership between the City and BC Housing to develop 12 City-owned sites for 1100-1200 units of social and supportive housing and agreed to refer consideration of a Memorandum of Understanding between the City and the Province (BC Housing), appended to the Administrative Report *City/Province Social and Supportive Housing Partnership*, dated November 6, 2007, to a Special Council meeting on the evening of December 12, 2007, in order to hear from speakers.

Council had before it the following motion which was approved at the November 13, 2007 meeting, as well as the Administrative Report and appended Memorandum of Understanding noted above:

- A. THAT Council refer consideration of Recommendations B and C of the Administrative Report entitled *City/Province Social and Supportive Housing Partnership* dated November 6, 2007, to a public meeting to be held on the evening of December 12, 2007.
- B. THAT Council approve the Memorandum of Understanding between the City and the Province (BC Housing) attached as Appendix A to the Administrative Report City/Province Social and Supportive Housing Partnership, dated November 6, 2007, whereby 12 City-owned sites would be developed for social and supportive housing for the homeless and those at risk of homelessness such as the mentally ill, people with addictions, and residents of the City's Single Room Occupancy (SRO) hotels, and whereby:
  - the City would lease 12 sites to non-profit sponsors of social and supportive housing for 60 years with a nominal prepaid lease rent;
  - the non-profit sponsors would not be required to pay property taxes; and
  - the City would pay the cost of environmental remediation (removing hazardous materials from the buildings and soil remediation);

with the source of funding to be the Property Endowment Fund, Development Cost Levies allocated to replacement housing, and the Affordable Housing Fund as set out in the Administrative Report.

- C. THAT Council approve making two existing temporary Planner II positions in the Housing Centre permanent, subject to review by Human Resources. Community Services will fund the positions for 2008, and for 2009 funding to be added to the 2009 Operating Budget without offset, as part of Community Services' operating budget, subject to the 2009 Budget Process, at an estimated cost of \$81,900 (2006 rates) for each position.
- D. THAT the scope and financial cost of these and the City's other social housing investments be summarized and circulated to the Metro Vancouver Housing Committee and to other municipalities in Metro Vancouver with a request that they also report to the Metro Vancouver Housing Committee on their contributions to achieving regional housing strategy goals.

Council also had before it a memorandum dated December 11, 2007, from Cameron Gray, Director of the Housing Centre, which put forward for Council's consideration an additional recommendation regarding the Streetohome Vancouver funding model as follows:

THAT Council advise the Province, and the non-profit housing and service providers to be selected for the projects proposed in the City/Province Social and Supportive Housing Partnership, that the City will want the option of developing the 12 City-sites under the Streetohome Vancouver funding model to be considered, should the Federal Government provide the tax changes that Streetohome Vancouver requires.

Cameron Gray, Director of the Housing Centre, provided a presentation. Staff responded to questions.
