# Proposed Amendment to Subdivision By-law 5208 - Reclassification of Properties in the 3000 Block West 43<sup>rd</sup> Avenue (VanRIMS No. 08-4000-11)

The Committee had before it an Administrative Report dated December 17, 2007, in which the Subdivision Approving Officer sought approval to refuse two options proposed to either reclassify all properties on the south side of the 3000 Block West 43<sup>rd</sup> Avenue from Category D to Category A for the purpose of subdivision; or to reclassify three properties at 3070, 3180 and 3190 West 43<sup>rd</sup> Avenue (lots 1, 2 and A) from Category D to Category A, in accordance with the minimum parcel size requirements of Schedule A, Table 1 of the Subdivision By-Iaw. The General Manager of Community Services recommended approval of the staff recommendation.

Staff reviewed the report and responded to questions.

The Committee heard from 6 speakers, two in favour of the recommendation and 4 in opposition.

At its meeting on Tuesday, January 15, 2008, Vancouver City Council referred this item to the Standing Committee on Planning and Environment meeting on January 17, 2008 in order to hear speakers. Accordingly, the Committee had before it the following motion:

WHEREAS responsible pet ownership contributes to neighbourhoods and communities that are safer, more enjoyable and more liveable for everyone;

WHEREAS licensing of pets in other cities has proven to be financially beneficial and well-supported, as it helps the pets, their owners and the city; WHEREAS other cities have demonstrated that licensing compliance of over 90% is achievable;

WHEREAS the Vancouver animal services facility is inadequate for the current needs of the city;

THEREFORE BE IT RESOLVED THAT staff are requested to work in cooperation with the School Board and Park Board to:

- 1. Develop and pursue a self-sustaining funding model for dog licensing, urban animal education, by-law enforcement and related programs;
- 2. Bring forward a request to the 2009-2011 capital plan for a new animal services facility; and
- 3. Consider community partnerships which may assist in the City's delivery of animal services.

The Committee heard from 11 speakers (briefs submitted - on file). Six speakers spoke in favour of the recommendations with concerns expressed, 3 were opposed and 2 spoke on issues specifically related to cats.

- 3. Consider community partnerships which may assist in the City's delivery of animal services with a report back for Council consideration.
