**A By-law to amend License By-law No. 4450  
regarding 2008 fee increases for marina operators**

THE COUNCIL OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

1. From Schedule A to the License By-law, Council repeals the provisions and fees under the heading "MARINA OPERATOR", and substitutes the following provisions and fees:

"MARINA OPERATOR	247.00	197.00	per annum plus
	960.00	960.00	for each occupied live-aboard boat 21 feet or less in length, at water line, plus
	1161.00	1161.00	for each occupied live-aboard boat more than 21 feet but not more than 26 feet in length, at water line, plus
	1307.00	1307.00	for each occupied live-aboard boat more than 26 feet but not more than 31 feet in length, at water line, plus
	1491.00	1491.00	for each occupied live-aboard boat more than 31 feet but not more than 37 feet in length, at water line, plus
	1645.00	1645.00	for each live-aboard boat which is more than 37 feet in length at water line."

2. This By-law is to come into force and take effect on the date of its enactment.
