#### **ADOPTION OF MINUTES**

The Minutes of the Standing Committee on Planning and Environment meetings of November 29, 2007 and January 17, 2008, were adopted.

1. Vancouver Athletic Commission - Annual Report for the year 2006-2007 November 30, 2007 (VanRIMS No. 08-3000-11)

The Committee also had before it the Vancouver Athletic Commission's Financial Statements for the period September 16, 2006 to September 15, 2007.

 750 Pacific Boulevard - Dock B, Plaza of Nations Marina M.V. Queen of Diamonds - Vancouvercruises.com Charters Ltd. Motor Vessel Liquor Primary Liquor License December 3, 2007 (VanRIMS No. 11-4600-23)

Staff from the License Office reviewed the report and noted there was an error reflecting the number of seats applied for. The report indicated 610 in total when the actual number was 400 in total capacity.

The Committee heard from two speakers; one opposed and one in support of the report recommendations.

Staff responded to questions.

THAT Council not endorse the request by Vancouvercruises.com for a new 400 seat (total capacity) (Motor Vessel) Liquor Primary Liquor License on board the M.V. Queen of Diamonds as outlined in the Administrative Report dated December 3, 2008 titled "750 Pacific Boulevard - Dock B, Plaza of Nations Marina, M.V. Queen of Diamonds - Vancouvercruises.com Charters Ltd., Motor Vessel Liquor Primary Liquor License".

CARRIED UNANIMOUSLY (Mayor Sullivan absent for the vote)

3. Northeast False Creek Update and BC Place Stadium Work Request January 21, 2008 (VanRIMS No. 11-2000-11)

Staff from the Planning Department reviewed the report and responded to questions.

The Committee heard from seven speakers; three in support of the report recommendations, two which spoke neither for nor against, and two expressed concerns (brief distributed - on file in the City Clerk's Office).

THAT the Committee recommend to Council

A. THAT Council approve undertaking a process to develop and assess a proposal by the BC Pavilion Corporation to amend the False Creek North Official Development Plan (OPD), in parallel with the Northeast False Creek High Level Review, with the aim of getting to Public Hearing in October 2008, as outlined in the report dated January 21, 2008, entitled Northeast False Creek Update and BC Place Stadium Work Request.

- B. THAT Council approve an allocation of \$290,000 for the necessary work to amend the False Creek North ODP, as described in the report dated January 21, 2008, entitled *Northeast False Creek Update and BC Place Stadium Work Request*, source of funding to be:
  - \$145,000 as a contribution from B.C. Pavilion Corporation; and
  - \$145,000 from the 2008 Operating Budget to be determined as part of the 2008 Operating Budget process.

#### AMENDMENT MOVED by Councillor Louie

THAT the motion be struck and substituted with the following:

- A. THAT Council approve undertaking a process to develop and assess a proposal by the BC Pavilion Corporation, as outlined in this report along with any other proposal from the remaining participants in the Northeast False Creek High Level Review, and to amend the False Creek North Official Development Plan (ODP), with the aim of convening a Public Hearing in October 2008.
- B. THAT Council approve an allocation of \$290,000 for the necessary work to amend the False Creek North ODP, as described in this report, source of funding to be: \$145,000 as a contribution from BC Pavilion Corporation; and \$145,000 from the 2008 Operating Budget to be determined as part of the 2008 Operating Budget process.
- C. THAT Council stipulates that the remaining participants in the Northeast False Creek High Level Review can proceed under the same October 2008 timeline as long as they contribute in a 50 percent cost share formula, similar to the BC Pavilion Corporation proposal.

### 4. Eliminating Plastic Bags (VanRIMS No. 13-6000-50)

At its meeting on November 27, 2007, Vancouver City Council referred the motion on this matter to a future Standing Committee in order to hear from delegations.

Accordingly, the Committee heard from 18 speakers; the majority of whom spoke in favour of the motion, with a number of them proposing alternative bags; two speakers spoke against a ban (briefs distributed - on file in the City Clerk's Office).

During the debate, the City Manager responded to questions.

MOVED by Councillor Stevenson
THAT the Committee recommend to Council

#### WHEREAS:

- 1. the City of Vancouver has a duty to protect the natural environment, the economy, and the health of its citizens;
- 2. plastic grocery bags cannot be composted and are not accepted in Vancouver's curbside recycling program;
- 3. plastic bags don't biodegrade, they photo-degrade breaking down into smaller toxic bits that contaminate soil and waterways;
- 4. plastic bags can take between 15-1,000 years to break down in the environment;
- 5. In the Mayor's State of the City address, he stated that one of his Five Goals for a Better Vancouver was "Becoming a world leader in environmental practices and sustainable transportation"; and
- 6. the expansive usage of plastic shopping bags and their typical disposal creates an impediment to the GVRD's *Zero Waste* Challenge.

#### THEREFORE BE IT RESOLVED

THAT staff provide a report within 90 days for options on phasing out plastic bags within the City of Vancouver.
