THAT Council, having considered the proximity of residential developments, noise impacts and relevant city policy as outlined in this report titled 602 Dunsmuir Street - St. Regis Investments Ltd., Liquor Primary Liquor License Application for an Increase in Patron Capacity, dated January 29, 2008, endorse the request by St. Regis Investments Ltd. for an increase in patron capacity for the Liquor Primary Liquor License (License #024634) from 227 seats to 258 seats at The St. Regis Hotel, 602 Dunsmuir Street, subject to:

- i. Adhering to clean air practices;
- ii. Signing a Good Neighbour Agreement with the City; and
- iii. A Time-limited Development Permit.

- B. THAT Council instruct the Director of Legal Services to prepare the necessary amendments to the Business Prohibition By-Law No.5156 as generally set out in Appendix B of the Administrative Report dated December 12, 2007, entitled "Prohibition of Exotic Animals in Performances".

4. Amendments to Vancouver Fire by-law No. 8191 Regarding Fireworks January 29, 2008 (VanRIMS No. 14-1000-01)

The Committee heard from seven speakers, the majority of which spoke in support of the recommendations. Two speakers presented the industry perspective and spoke in opposition to the recommendations.

THAT Council approve in principle the proposed amendments to the Fire By-law as summarized in this report, such that the purchase and discharge of fireworks in the City be restricted to individuals who hold a valid certification from the Federal Government, Natural Resources Canada Explosives Regulatory Division as a Display Fireworks Supervisor, and that the sale, purchase and discharge of fireworks otherwise be banned.
- B. THAT Council authorize the Director of Legal Services to bring forward the by-law amendments generally as shown in Appendix B of the Policy Report dated January 29, 2008, entitled "Amendments to Vancouver Fire By-law No. 8191 Regarding Fireworks", and any consequential amendments required to any other by-laws.
- C. THAT Fire Prevention's 2009 permit revenue budget be adjusted by \$9,000, without offset subject to budget review, to reflect the estimated reduction to revenue as a result of the by-law amendments.
