Provisions of Those By-laws

# **RECOMMENDATIONS**

- B. THAT Council repeal the existing Fines and Penalties By-law No. 3043 and enact a new Fines By-law generally as set out in Appendix B.

#### **COUNCIL POLICY**

There is no applicable Council Policy.

#### **SUMMARY**

City Staff recently undertook a review of the minimum fine levels set out in the various bylaws referenced in this report. The review revealed that across the board, fines were inconsistent and were not at a sufficient level to be a deterrent to offenders. It was determined that the fines should reflect the seriousness of the related offences and should send a message to the public and the courts as to how seriously the City views the offences. This report is a companion to the Project Civil City Enforcement Review report.

# **PURPOSE**

The purpose of this report is to request that Council amend the by-laws outlined in Appendix A and B of this report in order to provide an increase in the minimum fines for each by-law. It also requests administrative amendments related to fines and enforcement of several by-laws including the Parking By-law.

#### **DISCUSSION**

Staff has undertaken a comprehensive review of the fine range in all by-laws. The review indicated that minimum fines vary widely across by-laws and are generally very low.

The by-laws can be grouped into four distinct categories as follows:

## 1. By-laws related to lands/buildings:

Building, Zoning and Development, Electrical, Standards of Maintenance, Fire, Untidy Premises, Solid Waste and Private Property Tree By-law.

#### General Intent:

To protect the public, regulate construction and the use of lands and buildings and monitor the liveability and ongoing maintenance of properties.

# 2. By-laws related to public disorder:

Street and Traffic, Granville Mall, Parking Meter, Graffiti, Street Vending, Animal Control, Motor Vehicle, Impound, Noise and Solid Waste.

#### General Intent:

To regulate the use of public spaces and the conduct of individuals in order to provide a safe and peaceful environment for the public.

# 3. <u>By-laws related to business regulation:</u>

License, Zoning and Development, Secondhand Dealers/Pawnbrokers, Vehicles for Hire

General Intent:

To regulate the operation and proper management of businesses.

# 4. By-laws related to the use of park land:

Parks Control, Animal Control

General Intent:

To regulate the use of park land and the conduct of persons on park land to ensure peaceful enjoyment of the public.

#### Rationale for the Fine Increases:

The current minimum fines are inadequate, inconsistent and do not come close to offsetting the City's costs of enforcement. They are too low to act as a deterrent.

When a defendant is found guilty of an offence against a by-law, the Judicial Justice of the Peace (JJP) may sentence the offender within the applicable fine range. In many cases the JJP imposes the minimum fine as a standard penalty. An increase in the minimum fines is expected to change behaviour and to restrict discretion of the courts so that a lower fine may not be imposed.

# MTI (Municipal Ticket Information) Pilot:

An expansion of the MTI pilot is anticipated in the near future. In order to recoup higher fines through the MTI process, the minimum fine levels in the by-laws must be increased.

The amendments attached request that minimum fines for most by-law offences be increased to \$250. (This would not include parking tickets or like offences which are only being

increased nominally.) An increase to \$500 is requested for more serious offences such as failing to comply with an order and where an offender has caused or allowed an unsafe condition.

In addition, this report requests administrative amendments to various by-laws including the Parking By-law with respect to fines and enforcement proceedings.

#### FINANCIAL IMPLICATIONS

The proposed increases to the minimum fines are expected to realize an increase of approximately \$240,000 annually and \$160,000 for 2008 subject to- the implementation of these increases by May 1, 2008.

#### **CONCLUSION**

A review of the existing minimum fine structure in City by-laws across the board revealed that the fines are inconsistent and not a not at a sufficient level to be a deterrent to offenders. It has been determined that the fines should reflect the seriousness of the related offences and should send a message to the public and the courts as to how seriously the City views the offences.

The increased minimum fines outlined in this report will result in an increase in projected revenue for the City and will increase public awareness on the importance of complying with the City's by-laws.

# Minimum fines and housekeeping

- 1. In each by-law referred to in Column 1 of Table 1, Council amends each section or table referred to in Column 2 by:
  - (a) striking out the minimum fine, if any, as set out in Column 3;
    - (b) substituting or adding the minimum fine as set out in Column 4;
  - (c) amending the wording as set out in Column 4:

# A By-law to impose fines for breaches of the Vancouver Charter or of by-laws that do not specify fines

THE COUNCIL OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

# Name of By-law

1. The name of this By-law, for citation, is the "Fines By-law".

#### Fine for offence

- 2. A person who:
  - (a) violates any provision of the Vancouver Charter or of a by-law of the city, or does any act or thing which violates any provision of the Vancouver Charter or of a by-law, or suffers or allows any other person to do any act or thing which violates any provision of the Vancouver Charter or of a by-law;
  - (b) neglects to do or refrains from doing anything required to be done by any provision of the Vancouver Charter or of this by-law; or
  - (c) fails to comply, or suffers or allows any other person to fail to comply, with an order, direction, or notice given under any provision of the Vancouver Charter or of a by-law;

for which the Vancouver Charter or by-law, as the case may be, does not provide any punishment is punishable on conviction by a fine of not less than \$250.00 and not more than \$2,000.00 for each offence or to imprisonment for not more than 6 months, or to both.

#### Fine for continuing offence

3. Every person who commits an offence referred to in section 2 of a continuing nature is liable to a fine not exceeding \$50.00 for each day such offence continues.

# Severability

4. A decision by a court that any part of this By-law is illegal, void, or unenforceable severs that part from this By-law, and is not to affect the balance of this By-law.

#### Repeal

5. This By-law repeals By-law No. 3403.
