SUBJECT: 2008 Celebration Grants Recommendations

RECOMMENDATION

THAT Council approve a total of \$204,200 in Celebration Grants to 41 organizations listed in Tables 1 and 2 including four conditional grants as noted. Source of funds to be the 2008 Celebration Grants budget.

GENERAL MANAGER'S COMMENTS

The General Manager of Community Services recommends APPROVAL.

COUNCIL POLICY

Council approved creation of the Celebration Grants program in October 2002 for cash grants to community-based festivals, celebrations and large scale parades.

In July 2003, Council approved the establishment of a new service grant component of the program, which may provide an offset of up to 50% of the cost of city services (police and engineering) incurred by major parades to a maximum sum of \$10,000.

Approval of grant recommendations requires eight affirmative votes.

PURPOSE

As listed in Tables 1 and 2, this report recommends approval of \$204,200 to 41 organizations, outlines the recommendation process, discusses the applications in more detail (Appendix A), appends the evaluation criteria in the Program Information Guide (Appendix B), and includes front pages of the applications (Appendix C).

BACKGROUND

In October 2002, Council established the Celebration Grants program as a means of encouraging and assisting community-based cultural festivals, celebrations and major parades. Through their provision of cultural interaction and entertainment, these events contribute to building a stronger sense of community in Vancouver.

On-going outreach is conducted in the community through a variety of channels: public service announcements, web page, paid ads, and an e-mailed distribution list targeted to the ethno-cultural and broader community. Four weeks in advance of each application deadline, staff host a public information meeting about the program for prospective applicants.

Applicants were first screened for eligibility and then, as available, interviewed by OCA staff. A further technical review for operational issues and permit or site requirements was then conducted by representatives from Cultural Affairs, Park Board and Engineering. Where the technical committee identified possible need for further follow up with organizations prior to their event, conditions, such as meeting with FEST Committee partners, were proposed to be placed on recommendation prior to release of grant funds.

As is consistent with every review process, not all organizations meet the criteria at the same level as their peers and therefore in a competitive process with finite resources, not all are being recommended for support.

DISCUSSION

Celebration Cash Grants:

The cash grant component is available to help offset programming, outreach or administrative costs to a maximum sum of \$10,000.

For the Celebration Grants deadline in 2008 on March 3rd, there were 50 applications received, totalling a combined cash and city services request of \$386,492 and an available budget of \$204,200. Among the 50 total applicant organizations, four requested \$35,500 in funding from the city service component of Celebration Grants.

The applications were reviewed by an Assessment Committee comprised of Staff and three independent community members with a range of experience and expertise with both professional and community-based cultural events. The independent members are:

- Susan Gordon, Vancouver Park Board Arts and Culture coordinator, retired
- Victor Martinez Aja, Festival Coordinator, Vancouver Latin American Film Festival
- Nicole Nozick, Festival Director, Jewish Book Festival

The Committee's consensus recommendations reflect a thorough assessment of each application in the context of cultural or community interest, organizational capacity and resources to deliver the proposed event, and well-articulated community outreach and impact.

The Assessment Committee recommended funding in this category to 40 applicants as per Table 1, reflecting those projects which best met the evaluation criteria as outlined in **Appendix B**: Celebration Grants Program Information Guidelines.

Celebration Service Grants:

The service grants component is available to help offset up to 50% of the cost of city services incurred by major parades up to a maximum sum of \$10,000. The Assessment Committee recommended funding to four organizations in this category as per Table 2.

FINANCIAL IMPLICATIONS

The 2008 Celebration Grants program budget is \$204,200. Approval of recommendations in Tables 1 and 2 (cash \$175,700 and city services \$28,500) will leave no balance in the 2008 Celebration Grants program budget.

CONCLUSION

The Celebration Grants program provides support to community organizations holding festivals and celebrations throughout the year and throughout Vancouver's neighbourhoods. The program continues to strive to be flexible enough to allow access to new organizations and events while providing encouragement to more established organizations to build both stronger events and organizational capacity.

The Co-Director, Office of Cultural Affairs notes the importance of the Assessment Committee's expertise, insight, and carefully balanced recommendations and recommends approval.

2008 CELEBRATION GRANTS RECOMMENDATIONS

RECOMMENDED

Alliance of Portuguese Clubs & Assn. of BC

\$2,000

A first-time grant of \$2,000 is recommended for event costs and performers' fees for the 6th annual Portuguese Cultural Festival, which celebrates and promotes Portuguese culture, music and food to the broader Vancouver community. The multi-day event begins June 7, 2008 and culminates on Portugal Day, June 10. The festival includes free indoor and outdoor performances and exhibits featuring arts and crafts, music, folklore, dance and cuisine at Our Lady of Fatima Church in the Kensington-Cedar Cottage Neighbourhood.

Association of United Ukrainian Canadians

\$10,000

A maximum grant of \$10,000 is recommended for the 5th annual multi-disciplinary Heart of the City Festival, which celebrates the Downtown Eastside community's history, people, cultures, art forms. The 2008 festival will feature an estimated 650 community and professional artists in 80 events at 25 locations during a 12-day celebration from October 29-November 9.

BC Multicultural Health Services Society

\$1,500

On behalf of the South Hill Festival organizing committee, BC Multicultural Health Services Society requested funding to support the 7th annual South Hill Festival on May 23, 2009 in the Fraser Street area at 48th Avenue. The Festival engages community in the Sunset neighbourhood in a free, family-oriented event organized around the theme of sustainability. The Assessment Committee recommends a grant of \$1,500 and encourages the organizers to further diversify their revenue sources.

Brazilian Community Association

\$2,000

The Assessment Committee recommends a grant of \$2,000 towards the event costs of presenting the Roundhouse Community Centre component of Brazilian Carnaval 2009, on and around March 7, 2009. Specifically, the grant is targeted to support the exhibits, workshops, Kids' Carnaval and Masquerade Mardis Gras at the Roundhouse, and the event costs related to hosting this free, family-oriented celebration of Brazilian cultural and Carnaval traditions.

Cedar Cottage Neighbourhood House

\$3,500

The Assessment Committee recommends a grant of \$3,500 towards the programming, marketing and event production costs for the 23rd annual Mother's Day Traditional Pow Wow at Trout Lake Community Centre. This year, due to renovations at the Community Centre, the event is scaled down to a one-day event on May 10, 2008. This well-supported and long-established event will present local and national drum and dance groups, traditional arts and crafts, exhibits and information, as well as a First Nations ceremonial component.

CelticFest Vancouver Society

\$10,000 & \$5,000

A maximum cash grant of \$10,000 is recommended for the costs of producing the 6th annual CelticFest Vancouver celebration, March 11-15, 2009 —a multi-stage festival featuring outdoor and indoor venues, weekend Celtic Village Street Market, KidZone activities and parade—which attracts a city-wide audience to its downtown locations. A service grant to cover up to

50% of police and engineering costs (to a maximum of \$5,000) for the annual St. Patrick's Day Parade is also recommended.

Centre of Integration for African Immigrants

A grant of \$2,000 is recommended towards the costs of presenting the 6th annual all-day Black History Market and Cultural Showcase, part of Black History Month, on Saturday February 28, 2009 at the WareHouse in the Renfrew-Collingwood neighbourhood. The Assessment Committee encourages the organization to increase its administrative capacities and to pursue additional revenue sources for the event. The payment of grant funds is SUBJECT TO the Executive Director's resignation from the Board of Directors together with the initiation of a clearly articulated plan for building and strengthening the governance structure of the society.

Chinese Benevolent Association of Vancouver \$10,000 & \$4,500

A maximum cash grant of \$10,000 is recommended for the costs of producing the Chinese New Year Parade on February 1, 2009. This large-scale parade includes diverse professional and community cultural groups and attracts a city-wide audience to its Chinatown location. A service grant to cover up to 50% of police and engineering costs (to a maximum of \$4,500) for the annual parade is also recommended.

Chinese Canadian Artists Federation in Vancouver \$3,500

A grant of \$3,500 is recommended to support artists' fees and event costs associated with the culturally diverse programming of the annual Chinatown Arts and Cultural Festival in the Dr. Sun Yat-Sen Courtyard over four Saturdays in July 2008.

Collingwood Neighbourhood House

\$4,000

\$2,000

A grant of \$4,000 is recommended in support of artists' fees and the cultural component of Collingwood Day, a community-based celebration that takes place on May 31, 2008 around the Joyce-Collingwood Skytrain station and the grounds of Carleton Elementary School. The Assessment Committee is encouraged by the organizers' continued efforts to reflect the neighbourhood through the creative incorporation of the arts and performance in the celebratory activities.

Community Arts Workshop Society

\$2,500

A grant of \$2,500 is recommended to support artists' fees and event costs for the 15th annual Alice in Wonderland Festival and Mad Tea Party, a free, all-ages participatory event at Trout Lake Park on July 27, 2008.

CRAB - Water for Life Society

\$1,850

A grant of \$1,850 is recommended for artists' fees and event costs to produce the July 1st celebration in CRAB Park at Portside. This annual event provides a unique focal point for the DTES neighbourhood residents on Canada Day.

Downtown Eastside Women's Centre

\$3,500

A grant of \$3,500 is recommended to support artists' fees and event costs for the Celebrating Our Journeys taking place along the 300-Block of Columbia Street on September 14, 2008. Recognizing the cultural, political and spiritual contributions and achievements of women in the DTES, this event will also mark the 30th anniversary of the Downtown Eastside Women's Centre.

Dunbar Residents' Association

\$1,000

A grant of \$1,000 is recommended towards the production of the Salmonberry Days calendar, the major promotional tool of the annual community celebration, to be held throughout the month of May in multiple indoor and outdoor venues in the Dunbar neighbourhood.

East Vancouver Celebrate Society

\$9,000

An increased grant of \$9,000 is recommended for programming and event costs for Car Free Vancouver Day on June 15, 2008. Produced for three years as the Commercial Drive Car Free Festival, which celebrated the neighbourhood's diversity, and its pedestrian and family-friendly character, this year's event has expanded and will include multiple sites with other neighbourhood-based festivals. Funding in 2008 is targeted to the Commercial Drive site and the new neighbourhood events along Main & Cambie Streets, Marpole, and the West End.

Eastside Culture Crawl Society

\$10,000

A grant of \$10,000 is recommended for marketing and administrative costs of the 12th annual Eastside Culture Crawl, an open-studio tour and arts festival. More than 300 artists and craftspeople open their studios to the public free of charge in some 45 buildings from November 21-23, 2008 in neighbourhoods stretching from Strathcona to Grandview-Woodlands.

Evergreen Environmental Foundation

\$5,000

A grant of \$5,000 is recommended for the cultural component of the Evergreen Environmental Foundation's annual Earth Day Celebration at Jericho Beach Park on April 25, 2009. The Assessment Committee is encouraged by the ongoing development of arts-based activities and performance in the celebration's programming.

False Creek Watershed Society

\$2,000

A grant of \$2,000 is recommended towards performers' fees, marketing and event costs for the 5th annual Salmon Celebration—Remembering Our History, Celebrating the Living—held on September 28, 2008 in Vanier Park. The event features First Nations performance, music, storytelling, a procession and on-site animation along with information on salmon, the wilderness and urban sustainability.

Frog Hollow Neighbourhood House

\$3,000

The Assessment Committee recommends a grant of \$3,000 in support of the cultural components related to the 8th annual Pumpkin Patch in the City celebration on October 28, 2008, a multi-faceted family celebration with a Halloween theme, serving newcomer residents from surrounding neighbourhood houses and the Renfrew-Collingwood area. The Assessment Committee encourages the organizers to continue to develop and innovate in the area of programming.

Hellenic Canadian Congress of BC

\$7,500

The Assessment Committee recommends a grant of \$7,500 towards performers' fees and event costs for Greek Day, a large-scale community street celebration on June 22, 2008 which promotes the history and culture of Canada's Greek community and includes culinary displays, crafts exhibits, and folk dance and music performances.

Helping Mex Y Can Society

\$1,350

A first-time grant of \$1,350 is recommended to support programming and publicity costs for Fiesta Mexico, a celebration of Mexican arts and culture at the main branch of the Vancouver Public Library in September 2008.

Islamic Heritage Society

\$3,500

A grant of \$3,500 is recommended to support performers' fees and event costs for the Canadian Islamic Cultural Expo, July 25-26, 2008 outside of the Vancouver Art Gallery. This free, publicly-accessible festival celebrates the diversity of Islamic culture in Canada and promotes cross-cultural understanding through exhibits featuring science and technology, heritage and arts and architecture.

Khalsa Diwan Society

\$10,000

The Assessment Committee recommends a city services grant for the annual Vaisakhi Procession. This key event in the South Asian community will take place on Saturday April 18, 2009 in the Sunset neighbourhood. The service grant will to cover up to 50% of police and engineering costs (to the program maximum of \$10,000) for the annual parade. The grant is recommended SUBJECT TO a FEST Committee meeting with the organizers.

Latinos in Action Vancouver Foundation

\$6,000

A grant of \$6,000 is recommended towards artists' fees and production costs for the 8th annual Latin Summer Fest, a free event held on August 17, 2008 at John Hendry Park, Trout Lake. The event celebrates the diversity of Latin culture through the arts, music and food. Noting the value of the event in the Latin American community, the Assessment Committee strongly encourages the society to initiate plans to build organizational and administrative capacity, and to design strategies to develop the organization's infrastructure and staffing resources to build stronger community partnerships and ensure the event's long term quality and sustainability.

Leave Out Violence (LOVE BC)

\$3,000

A first-time grant of \$3,000 is recommended for the inaugural Peace Festival on Sunday June 29, 2008 near the MOBY Community Gardens in the Broadway and Commercial area. The daylong outdoor event will be curated and designed by youth and will use music, dance, photojournalism exhibits and violence prevention workshops to promote peace and justice both locally and globally.

Little Mountain Neighbourhood House

\$2,000

A grant of \$2,000 is recommended for the Little Mountain/Riley Park Community Festival on June 8, 2008 at the Riley Park Community Centre. Their theme, "A Family of Communities" celebrates the intergenerational and culturally diverse characteristics of the neighbourhood. The Assessment Committee encourages the organizers to continue to develop and innovate in the area of programming.

Main Art Drift Society

\$3.000

A grant of \$3,000 is recommended for the marketing and publicity of The Drift, an annual open studio tour and celebration in Mount Pleasant's Artist Live/Work neighbourhood that showcases 90 artists' work in over 70 local studios and businesses along Main Street from Industrial Ave to 33rd Ave during the first weekend of October 2008.

Mount Pleasant Neighbourhood House

\$2,000

A grant of \$2,000 is recommended toward performer's fees and publicity costs for the 16th annual Celebrate Mount Pleasant, scheduled for June 7, 2008 at Guelph Park and Mount Pleasant Elementary School grounds. This event promotes the positive aspects and cultural diversity of this inner-city neighbourhood. The Assessment Committee encourages the organizers to continue to develop and innovate in the area of programming.

Pandora's Collective Outreach Society

\$4,000

A grant of \$4,000 is recommended towards publicity fees and event costs for the annual Summer Dream Literary Arts Festival on July 26, 2008. The free all-day event showcases grassroots spoken word, poetry, storytelling and musical performances, workshops and children's programming at Lumberman's Arch in Stanley Park.

Secret Lantern Society

\$10,000

The Assessment Committee recommends a maximum grant of \$10,000 for artists' fees and event costs for the annual Winter Solstice Lantern Festival on Sunday December 21, 2008. The celebration honours the return of the sun in a culturally diverse event. Pre-event community outreach and workshops lead to site-specific solstice lantern processions, performances and installations in six Vancouver neighbourhoods.

South Asian Family Assn.

\$5,000

A grant of \$5,000 is recommended towards artists' fees and event costs for the 6th annual South Asian Sawan Mela celebration on July 12, 2008. This free public event promotes crosscultural understanding through sharing and participation in a tradition that celebrates young married South Asian women reconnecting with friends, families and communities. Because, at the time of adjudication, the organizers proposed two possible outdoor venues for Sawan Mela: Vancouver Art Gallery or Sunset Community Centre, funding is SUBJECT TO a confirmed venue for this year's event.

South Vancouver Neighbourhood House

\$8,000

A grant of \$8,000 is recommended for artist fees, publicity and administrative costs of the 5th annual Vancouver Celebrates Diwali, a multi-faceted celebration of the South Asian festival of light. Pre-event outreach on the story of Diwali as well as Rangoli and dance workshops are held at multiple community venues and lead to two main public events: The Chai House and the Diwali Celebration at the Roundhouse on the weekend of Nov 1, 2008.

Still Moon Arts Society

\$8,000

A grant of \$8,000 is recommended for programming costs and publicity fees for the September 13th day-long Renfrew Ravine Moon Festival. The event is organized with multiple community partners and volunteers and combines an afternoon harvest fair with an evening of community and professional arts performances and lantern installations in Slocan and Renfrew Parks.

Vancouver Cherry Blossom Festival Society

\$4,000

A grant of \$4,000 is recommended for the 2009 Vancouver Cherry Blossom Festival which welcomes the return of spring through the blossoming of Vancouver's 36,000 ornamental cherry trees. The event is organized with multiple community partners and continues to build community interest and participation in cultural programming with such events as the Cherry

Jam, Sakura Day and participatory activities: hanami (blossom viewing), haiku-writing and blossom art painting as well as blossom rides, walks, talks and demonstrations.

Vancouver Dyke March and Festival Society

\$4,000

A grant of \$4,000 is recommended for publicity and programming costs of the August 2, 2008 Dyke March Festival, which culminates in an all-ages afternoon music festival for queer women, their families and supporters at Grandview Park during Pride weekend.

Vancouver International Bhangra Celebration Society

\$2,000

A grant of \$2,000 is recommended for event and programming costs for the April 2009 City of Bhangra celebration that presents a unique, cross-cultural approach to the celebration of Punjabi music and dance. The Assessment Committee encourages the organizers to continue to build their organizational capacity and focus on deficit reduction to ensure ongoing sustainability.

Vancouver Pride Society

\$8,000 & \$9,000

The Assessment Committee recommends a cash grant of \$8,000 towards the 30th annual Pride parade and festival on August 3, 2008. The Assessment Committee encourages the society's efforts to strengthen its organizational capacity. In recognition of anticipated increases to city services costs resulting from an extension of the parade's route and growth in audience attendance, a service grant to cover up to 50% of police and engineering costs for the parade is also recommended (up to a maximum of \$9,000).

Vancouver Rhythm and Dance

\$1,500

A grant of \$1,500 is recommended for programming and event costs for the Vancouver Rhythm and Dance Festival, September 12-13, 2008 at Vancouver Community College. This will be the second such festival, comprised of drumming and dance concerts and workshops celebrating international rhythm and dance forms.

Vancouver Venture for Diversity Society

\$1,000

A grant of \$1,000 is recommended for an Aboriginal Cultural Day celebration at the Aboriginal Friendship Centre in East Vancouver. The cultural program of this community-focused event will showcase and celebrate the diversity within Canada's First Nations communities and includes culinary displays, crafts exhibits, performances by dancers and musicians, and author readings. This grant is SUBJECT TO confirmation of the event's date and venue.

Vancouver Wooden Boat Society

\$4,000

A grant of \$4,000 is recommended in support of artists' fees and marketing costs for the 21st annual Wooden Boat Festival on Granville Island scheduled for August 21-24, 2008. The Assessment Committee again encourages organizers to explore new programming opportunities to involve more diversity in their presentation of maritime cultures and traditions and develop new avenues for broader and deeper community participation.

West End Senior's Network Society

\$1,500

A grant of \$1,500 is recommended towards artists' fees and event costs for the Strawberry Festival on June 21, 2008, which is presented by seniors in Barclay Heritage Square. The Assessment Committee encourages the organizers to continue to develop and innovate in the area of programming.

NOT RECOMMENDED

Granville Island Business and Community Association

Granville Island Business and Community Association applied for funding for a BC Day celebration on August 4, 2008 on Granville Island. The Assessment Committee did not support the rationale to dramatically increase the budget and programming scale of the existing event, nor did they see Granville Island as priority neighbourhood for support given the community-led initiatives for events in lesser-served areas around the City. In a competitive round, no grant is recommended.

Jewish Federation of Greater Vancouver

The Jewish Federation of Greater Vancouver requested funding to support the Israel at 60 Festival, a celebration of Israel's 60th anniversary of statehood, in September 2008 inside the grounds of Van Dusen Gardens. While the Assessment Committee noted that the ticketed one-day event is moving ahead in partnership with other Jewish cultural organizations, they noted that this one-time celebration has access to existing resources that made the application a lesser priority given the finite budget available for funding. In a competitive round, no grant is recommended.

Kitsilano Neighbourhood House

Kitsilano Neighbourhood House requested funding for an Autumn Fair at the neighbourhood house in October 2008. The Assessment Committee noted that the proposal did not identify a compelling programming vision for this event that made it distinctly based in the local community. The Assessment Committee encourages the organizers to continue to develop and innovate in the area of programming. In a competitive round, no grant is recommended.

Ohel Ya'akov Community Kollel

The Ohel Ya'akov Community Kollel requested funding for its annual Day of Unity, scheduled for Labour Day 2008. The Assessment Committee noted that the proposal did not identify a clear outreach plan for the event to engage and be accessible to the broader community. Further, a unique programming vision for the event was not presented. In a competitive round, no grant is recommended.

Pedal Energy Development Alternatives Power Association

The Pedal Energy Development Alternatives Power Association applied for funding for mobile, bicycle transported and powered programming that would arrive at the multiple sites of Car Free Vancouver Day on June 15, 2008. However, East Vancouver Celebrate Society has been recommended to receive a grant of \$9,000 for programming and event costs for Car Free Vancouver Day in this program year and, with finite resources available, two groups cannot be funded for the same event. In a competitive round, no grant is recommended.

Perfect Ten Organizing Committee (Centre for Creative Initiatives)

The Perfect Ten Organizing Committee applied for funding for a community music festival to be held at New Brighton Park on the Labour Day weekend in 2008. The Assessment Committee identified some problematic logistical and budgetary plans in the proposal that did not give them confidence that the event would be produced in 2008. The organizers are encouraged to further develop their artistic rationale for the event, to work closely with Park Board to

confirm venue dates and logistics and to initiate relevant community partnerships in the neighbourhood. In a competitive round, no grant is recommended.

Proyecto Cultural Sur Vancouver

Proyecto Cultural Sur Vancouver proposed a one-day poetry encounter on June 1, 2008 that would present several components: a panel discussion, key note address, musical interlude and an award to a local poet. The Assessment Committee noted that the event was predominantly reliant on funding from the City of Vancouver and that the event would be produced for an audience drawn primarily from within the society's membership. In the context of a competitive round, no grant is recommended.

Senior Chinese Society of Vancouver

The Senior Chinese Society of Vancouver proposed a Moon Festival celebration at the Chinese Cultural Centre and Trout Lake Park, in September 2008. The Assessment Committee noted a lack of evidence of the event's financial feasibility and that the event's audience would be drawn primarily from the society's membership. In the context of a competitive round, no grant is recommended.

Taiwanese Canadian Cultural Society

The Taiwanese Canadian Cultural Society proposed a Lunar New Year in Taiwan Celebration in January & February 2009. The Assessment Committee noted the event's high percentage of administrative costs, no well-defined strategy to attract an audience beyond membership and neighbourhood schools, and the available resources within the society to sustain the event. In the context of a competitive round, no grant is recommended.

CELEBRATION GRANTS

Program Objectives

This program is for community-based festivals, cultural celebrations and large parades, in recognition of the entertainment they offer and their contribution to a sense of community among residents of diverse cultures, ages and interests.

Assistance with specific costs is available to help community-based not-for-profit societies to present these events, which may include programs of music and performance, crafts, exhibits, culinary and other cultural expressions of the community.

Who can apply?

Applicants	must be:
------------	----------

- ☐ registered as not-for-profit societies in British Columbia for at least six months
- □ located in the City of Vancouver (not in other Lower Mainland municipalities or the University Endowment Lands)
- □ have a cultural mandate which includes organizing festivals, celebrations or large scale parades in Vancouver

Examples of organizations that can apply include neighbourhood houses, resident associations, community service groups, ethnocultural societies, or arts and cultural organizations. Although Business Improvement Associations are not eligible on their own, community events they co-sponsor with not-for-profit community organizations are eligible.

The following are ineligible to apply:

- civic departments or branches (i.e. community centres, libraries)
- organizations receiving City of Vancouver cultural grants or those who would be eligible

What types of events are eligible?

Three types of events, organized for the purpose of building and celebrating a sense of community and held primarily for the benefit of Vancouver residents, qualify for assistance:

- □ Festivals: annual or biannual events of at least two days, actively programmed around a theme related to cultural expression in the broadest sense, for example, through music or other performances, crafts, displays, cooking, or demonstration of cultural traditions.
- □ **Celebrations:** one-day events, generally held outdoors, and actively programmed around a theme, anniversary, or other occasion, with a significant cultural component in the broadest sense.

Major parades: one-day events with a large audience and a significant cultural component,
broadly defined to include music and other performances, costumes, floats, banners, arches and
installations, or other pageantry elements.

Please note: To qualify as "major" a parade must have an event budget of over \$15,000; attract, or have the potential to attract, an audience of over 10,000; and have 20-25 organizations registered as entrants.

Ineligible activities and expenses:

events whose primary theme or focus is not cultural
sports and athletic events, runs, walks
competitions
demonstrations, marches, rallies
block parties, picnics, garden shows, street markets, carnivals
religious rites and ceremonies, small parades and processions
events for marketing, promotional, or commercial purposes
events that have a predominant commercial component
events whose purpose is primarily fund-raising
retroactive expenses or accumulated deficits
city services costs of festivals or celebrations
capital projects
events or activities that would qualify for the City of Vancouver's cultural grants

What can grant funds be used for?

The Celebration Grants program has two components. The first provides for cash grants to festivals, celebrations and parades. Funds may be applied toward one or more of the following:

- □ Programming costs: for example, performers' fees; display and exhibit costs; equipment rental; production technician's fees; costume creation, rental or cleaning; site decoration; parade floats and other pageantry elements.
- □ Staff and administrative costs: for example, planning and co-ordination, fundraising, and event management.
- □ Publicity and marketing: for example, development of marketing strategies; press kits; design and production of advertising for print, radio, television, and web sites; and purchase of advertising in mainstream and/or ethnic media.

Please note: Individual grant amounts will range from \$1,000 to a maximum of \$10,000, depending on the scale of the event. Requests may not exceed \$10,000.

The second component of the program provides for service grants to major parades. Up to 50% of the cost of services provided to major parades by the City is eligible for a grant. Service grants apply to police or engineering services such as traffic signs, barricades, and sanitation. The cost of Park Board, Coast Mountain Bus Company, or BC Ambulance services are not eligible.

Please note: The total annual budget for service grants to parades is \$30,000. Major parades may request up to 50% of their anticipated City service costs; requests may not exceed \$10,000.

How to apply

To obtain an application form, please contact Office of Cultural Affairs (OCA) staff, who manage the Celebration Grants program. Organizations must establish their eligibility for funding with OCA staff well in advance of submitting an application.

- □ To be considered for a grant, an organization must complete, sign and submit an original application form, together with three complete copies of the application. Photocopies of all attachments are required for original application and ALL copies.
- Organizations planning events on city streets or in parks must have all required approvals and permits from the Special Events Office or from the Park Board to hold their event in these locations or demonstrate that these approvals are in process.
- □ Under normal circumstances, the application, review and decision process takes eight weeks. Cash grants will generally be paid out within three weeks of Council approval. Service grants approved by Council for major parades will be applied to eligible City services following the event up to a maximum of 50% of costs.

How will applications be evaluated?

Since funds are limited, not all organizations meeting the eligibility criteria can be supported. This is a competition, based on the following evaluation criteria:

- Does the applicant provide evidence of confirmed revenues from sources other than the City of Vancouver? Revenues may include earned income from tickets and concessions, sponsorships, donations from individuals, businesses or community groups, memberships, in-kind donations, and support from foundations and government agencies.
- □ Does the event provide unique opportunities for the public?
- □ What is the quality of the programming? Does it demonstrate creativity, the involvement of persons with appropriate expertise, authenticity in presentation of cultural traditions, or uniqueness in expressing the character of a community or neighbourhood?
- ☐ How complete is the plan for delivering the event, including site or venue requirements, and engagement of key organizers? How complete is the budget; are there commitments from other sources of support? Is there a demonstrated need for a grant?
- ☐ If the application is for marketing assistance, what are the plans, resources and capabilities of the applicant for reaching a city-wide public, including diverse communities? Does the event have the capacity to attract and engage an audience and/or develop a new audience?
- ☐ How successful were previous events?
- ☐ Is there adequate administration, a functional Board of Directors and financial accountability?
- □ What is the level of community support and involvement, for example, public attendance, number of volunteers, and donation levels?
- ☐ Have impacts on the surrounding neighbourhood been considered and addressed?
- ☐ How effectively have major parade organizers managed their event in the past? What plans are in place to improve management, and control or lower the need for City services?
- ☐ How will grant funds support the growth and sustainability of the event?

Review process

- □ Cultural Affairs staff ensure that applications are eligible. City staff on the FEST committee and Park Board are consulted on operational impacts, site issues and permits. When possible, interviews with applicants are arranged.
- □ A grant program assessment committee of community members and individuals with event management experience reviews the proposals and provides comments. Staff then submit a report with recommendations for Council's approval, and notify applicants of the recommendations and the Council meeting date on which grants will be considered.

Conditions of Assistance

- □ Societies must provide their most recent financial statement within six months of their fiscal year end.
- Uvting members of the applicant's Board of Directors must not concurrently hold paid staff positions, nor be paid for their services to the society. They may be reimbursed for expenses.
- ☐ The organizers must develop and promote the event and extend its services to the general public in the City of Vancouver in a non-discriminatory way.
- □ Support from the City of Vancouver must be appropriately acknowledged on all promotional materials related to the funded event, including brochures, print ads, programs, posters, signs, and media releases.
- ☐ The term of the grant is one year, and only one Celebration grant application per City fiscal year can be submitted. Previously funded projects must be completed before a new application can be accepted.
- ☐ Receipt of a grant does not imply funding in the following fiscal year.

This year, the Pow wow Committee has made a committment to continue the community development work with Aboriginal people's to ensure the Mother's Day Pow Wow Celebration will take place. We will be challenged with fundraising, craft table rentals, corporate donations etc, as this is will be a one day event and we will not be able to generate the revenue as we have in the past years. As the Mother's Day Pow Wow has been a place for Mother's and their children to spend the weekend together the committee would like to continue the Traditional Feast that has been held on the Saturday only this year having the Traditional Mother's perform the Mother's Day Song before the feast. CelticFest Vancouver is an extraordinary celebration of Celtic culture and performance featuring local and international Celtic music performances, Celtic youth dance troupes, music workshops, spoken word, film, theatre and family entertainment. More than 60% of our 60+ events are offered free to the public.

The feature event on March 15 will be the 6th Annual St. Patrick's Day Parade, an inclusive community event, which encourages participation by civic and non profit organizations, performers, multicultural organizations and much more - Our slogan that "Everyone is Celtic at CelticFest "underpins the inclusivity of the event. Last year, over 2,000 people participated in the parade drawing more than 200,000 people to downtown Granville Street and we anticipate at least 400,000 people in March 2009.

Over the Parade weekend, the festival works with the City to close 2 blocks on Granaville Street go accommodate the Celtic Weekend Celtic village, which offers visual arts, crafts, food and fare and the KidsZone which features free entertainment for kids and their Kin. The Vancouver Chinese New Year Parade has become a very popular and fun event for the people of Vancouver and the Lower Mainland since its inception 34 years ago. The upcoming Chinese New Year Parade is scheduled for February 1, 2009 in celebration of the lunar Year of the Ox. This parade is a multi-cultural event that has grown to over 50 entries and about 3,000 participants from diverse cultural, ethnic and community groups. An estimated 50,000-60,000 spectators came out in 2007 to enjoy this event. For the last 4 years, Channel M has provided extensive TV coverage including prime time broadcast of the parade. Other media such as newspapers and radios have deployed more resources for coverage of this event in recent years. The Chinese Benevolent Association has been the lead parade organizer for the past 28 years. To increase participation/diversity and to share financial and organizational responsibilities, the event organizing committee has expanded its membership to include 5 additional Chinese community groups: Chinese Cultural Centre of Greater Vancouver (CCC); Vancouver Chinatown Merchants Association (VCMA); S.U.C.C.E.S.S, the Chinese Free Masons and Shon Yee Benevolent Association.

Under the Celebration Grants program, we are seeking both a service grant and a cash grant.

- 1. The service grant would cover up to 50% of the total cost of the city-provided police and engineering services to facilitate for the proposed parade. Based on the actual costs for 2006 parade (costs for 2007 parade is not yet available), the projected total cost for city services for 2008 is \$10,500.00.

For ten years, Dunbar has been celebrating spring with a unique month-long festival focusing on our neighbourhood ecology. Volunteer naturalists give guided walks and talks about the geology, the native plants and trees and the wildlife that share this land with us. We have also worked with various members of the City Engineering staff to educate our residents about the connections between nature and the city. This help residents understand and appreciate the water and sewer systems and other "silent services" we take for granted. These activities will continue this year as our annual "refresher course" in neighbourhood ecology.

But in addition, we are introducing a new theme this year: urban agriculture. We will be mobilizing the backyards of Dunbar to help meet the City's challenge of developing 2,010 new community garden plots by the year 2010. We will do active outreach to encourage home-owners to develop food-growing garden plots in their backyards and register them with the City. We will participate in City Farmer's Backyard Sharing program to link up home-owners with yard space but to time to garden with volunteers who will garden it for them.

We will support our backyard gardeners with practical information about working with nature to raise food: natural pesticides & fertilizers, beneficial insects, waterwise management, backyard composting, successful species for our region, and more. The Eastside Culture Crawl is an annual event for the artists, craftspeople, and public citizens of Strathcona, Chinatown, the Downtown Eastside, and Grandview/Woodlands. The event attracts a wide spectrum of visitors from across Vancouver, BC, and abroad. All ages and cultures are welcomed, and the event is totally free to attend, making it widely accessible to all. Artists open their studios to the public for a three-day celebration of the arts. It is an opportunity for the public to meet and talk to many diversely talented artists, view their studios, discuss what inspires the artists, and how their work is made. This is our twelfth year and the "Crawl" has grown to become a community arts festival with over 300 artists in some 45 buildings. We also partner with and subsidize the participation of various community and multicultural organizations. 2008 represents 30 years of the Vancouver Pride Society Pride Parade, making it the oldest continued GLBT celebration in Canada. In the First few years Vancouver Pride was a protest march and demonstration that, in time, turned into a parade and celebration. With roots deep in the Westend, we have seen the parade route include Thurlow Street, Davie Street, Burrard Street, Beach Avenue and its current route of Denman Street along Pacific Boulevard to Thurlow. In meetings with City representatives & officials we have been advised that the route needs to be extended either at the beginning or the end by five to seven blocks for the increase in attendance and safety concerns about crowding along the existing route. Recommendations for the route to begin earlier at the top of Robson Street at Thurlow and to follow down to Denman Street and keep the finishing point at Bute Street and Pacific Boulevard would satisfy all parties for the issues that have developed. Marshalling would now take place along Thurlow Street giving us the required seven-block extension/addition. It is estimated that the additional Policing costs could amount to an additional 2500.00 as well as the requirements of barricading at Robson & Thurlow, Robson & Denman, Davie & Denman as well as the last 2 blocks of the Parade Route for breakdown will cost 9500.00 in fence rentals. It is our continued commitment to minimise the impact of the parade on area residences and to allow the businesses to benefit as much as they can from the anticipated 400,000 spectators and participants that would descend on the Westend this Sunday August 3rd. Towards the end of the Parade Route is the annual Pride Festival at Sunset Beach which last year saw attendance to be estimated at 60,000. This family friendly event has a mix of vendors, entertainment, sponsors, food vendors that runs from 11am to 6pm. Funding helps off-set on site rentals for the Society, provide funding to the marketing and advertising, provides food and identification for the over 250 volunteers that come out for this day.
