SUBJECT: Funding Allocations for the Olympic and Paralympic Community

Celebrations Program

#### RECOMMENDATION

THAT Council approve a total of \$47,075 in the Host a City Happening Grant Program to seven organizations listed it Table 1. Source of funds to be the Olympic and Paralympic Community Celebrations Program entitled "Host a City Happening".

#### GENERAL MANAGER'S COMMENTS

The General Manager of Olympic and Paralympic Operations recommends APPROVAL.

#### COUNCIL POLICY

On April 1, 2008 Council approved the 2008 through 2010 program direction for the Olympic and Paralympic Community Celebrations Program entitled "Host a City Happening" as outlined in the Administrative Report *Funding Allocations for the Olympic and Paralympic Community Celebrations Program*, dated March 25, 2008, and the funding allocations totalling \$1 million to the following programs:

i.	Host a City Happening Departmental Program	\$525,000
ii.	Host a City Happening Community Grant Program	\$300,000
iii.	Host a City Happening Program Design, Development,	
	Support and Promotion	\$175,000

Source of fund to be the Olympic and Paralympic Legacy Reserve approved by Council on December 11, 2007.

On April 1, 2008, Council approved the criteria for the Host a City Happening Departmental Program, and delegated the authority to the General Manager of Olympic and Paralympic Operations to approve specific projects and distribution of funds, and instruct staff to report on the progress on the annual basis.

Council also approved the criteria for the Host a City Happening Community Grant Program as outlined in Appendix B of the Administrative Report Funding Allocations for the Olympic and Paralympic Community Celebrations Program, dated March 25, 2008. Individual grant applications will be reported back to Council for approval.

Approval of grant recommendations requires eight affirmative votes.

## **PURPOSE**

This report recommends grants to seven organizations, outlines selection processes, discusses the application in more detail (Appendix A) and outlines the guidelines of the program (Appendix B).

#### **BACKGROUND**

In April 1, 2008, Council approved the Community Celebrations program and criteria for the community grant component of the program as a means of supporting community groups in developing community celebrations projects between 2008 and 2010.

The Happenings are initiatives that celebrate Vancouver being the Host City of the 2010 Winter Games. They are one time stand alone events, activities or existing community events, enhanced with new Games related components or themes. They are also legacy projects that commemorate the Olympic experience.

The Host a City Happening Community Grant Program has four deadlines. The first deadline is May 30, 2008. The second deadline will be September 15, 2008. It is anticipated the deadlines in 2009 will follow a similar timeline.

This being the first of four intakes on grant submissions, information on the program was disseminated through the variety of channels: public service announcements, the City of Vancouver public website and in person presentations by Olympic and Paralympic operations staff to not for profit organizations such as community and neighbourhood house associations, local business improvement associations, and local school groups.

The approved criteria, indicated that Vancouver based registered non-profit societies in good standing for at least one year were eligible to apply for grants. The organization must have demonstrated capacity and resources to complete the project for which the funding was being sought. Partnerships with other funders were to be encouraged. Eligible events, activities and projects must be located in Vancouver.

#### DISCUSSION

The entire process from announcement of the Host a City Happening Grant Program to the application deadline on May 30, 2008 spanned a total of seven weeks. Despite a short turn around period, good cross sections of applications were received for the first intake. A total of 14 applications were received requesting \$144,675.

The applications were reviewed by an assessment committee comprised of staff representatives from the Office of Cultural Affairs, Parks and Recreation, Social Development, Olympic and Paralympic operations and an independent community member. The committee members provided a range of expertise and experience in community based and city wide special events and celebrations.

The recommendations reflect a careful assessment of each application in the key areas of Program Goals, Organizational Competence and Community Involvement. The assessment committee recommended funding for seven applications as per Table 1.

Seven applications were not recommended for funding. One is more suitable for funding through the departmental program of the Host a City Happening program. Another has withdrawn the application for this application cycle. Some non recommended projects proposed interesting ideas, but responded much less strongly to the funding criteria than other projects, and some had unclear activity plans. Organizations with non recommended projects will be encouraged to resubmit or develop new projects for future Host a City Happening submissions.

## FINANCIAL IMPLICATIONS

The Host a City Happening Community Grant program has allotted \$300,000 for projects from 2008 through 2010. In the April 1, 2008 report to Council, staff estimated the Grant stream would fund projects to the amount of \$50,000 in 2008.

## **CONCLUSION**

The Host a City Happening Community Grants program provides support to community organizations holding celebrations throughout the year and throughout Vancouver neighbourhoods from 2008 and up to and including the Winter Games time. The proposed grants allocation will enable the recipients to implement valuable projects in their local neighbourhoods.

## Appendix B

Information Sheet: Host a City Happening Community Grant Program

## **Purpose**

The Host a City Happening Community Grant Program is intended to support community groups by providing seed funding for local celebration events, activities and projects between 2008 and 2010. Successful initiatives will:

- create memorable experiences that build Olympic and Paralympic spirit,
- reflect diverse cultures, ages and interests,
- symbolize the Olympic and Paralympic goals of friendship, solidarity, peace, fair play, optimism, inspiration and empowerment.

## What are Host City Happenings?

Host City Happenings are initiatives that celebrate Vancouver being the Host City of the 2010 Winter Games. They are one-time, stand alone events or activities, or existing community events enhanced with new, Games-related components or themes. They are also legacy projects that commemorate the Olympic experience.

The program name, 'Host City Happenings' identifies it as a City of Vancouver initiative, evokes curiosity about what the "happenings" are, and suggests a fun, friendly and celebratory theme local groups will develop their 'Happenings' based needs and interests of their community stakeholders. Happenings will vary in size, duration, participation and long term legacy.

#### Program Goal

The goal of the Host a City Happening Community Grant Program is to engage citizens through community groups and organizations in events and activities in all Vancouver neighbourhoods to share the spirit and the excitement of the 2010 Olympic and Paralympic Winter Games.

#### **Program Objectives**

- To promote community spirit by providing opportunities for all citizens to celebrate Vancouver as Host City of the 2010 Olympic and Paralympic Winter Games.
- To provide assistance, and seed funding for community groups and organizations to develop activities, events or legacy projects.
- To create partnerships between various City of Vancouver departments and community organizations.
- To build relationships with residents and community members.

## **Funding**

The Olympic and Paralympic Operations Office will provide financial support for community organizations and businesses to put on activities, events and legacy projects. Preference will be given to smaller projects of \$10,000 or less.

## General Eligibility Criteria

- Organizations must be a registered non-profit society in good standing in British Columbia for at least one year.
- Organizations must be based and active in Vancouver.
- Eligible events, activities and projects must be located in Vancouver.
- Organizations must have the demonstrated capacity and resources to complete the project for which the funding is being sought.
- Applicants endeavour to seek partnerships with sources other than the Olympic and Paralympic Operations Office.
- Projects must demonstrate matching funds, or in kind contribution, or donated staff/volunteer time.
- Support from the City of Vancouver must be appropriately acknowledged on all promotional materials related to the project. Including: brochures, print ads, flyers, signage, and media releases.
- Events, activities and projects must reflect the Olympic and Paralympic goals of friendship, solidarity, peace, fair play, optimism, inspiration and empowerment.
- Projects that require approval and permits from the City of Vancouver must either have this complete or demonstrate the approval is in process.
- Applicants must submit and sign a program proposal outline. Proposals must be signed by a Board Member or Director.
- All direct costs incurred by an applicant specifically for the purpose of the project must be applied toward one or more of the following:
  - Programming costs
  - Marketing and publicity costs
  - Permits
  - Rentals
  - Staff and administrative costs

The Host a City Happening Community Program WILL NOT provide assistance for the following items:

- In-kind costs or donated staff/volunteer time
- Costs incurred prior to submitting an application
- Demonstrations marches, rallies
- Start-up costs for new organizations
- Property taxes, capital or maintenance expenses
- On-going operational expenses of the organization
- Debt-reduction, endowments, charitable donations or fund-raising campaigns

- Attendance at or fess for conferences, workshops or other forms of training
- Computer hardware and office equipment
- Religious rites and ceremonies
- Events for marketing, promotional, or commercial purposes
- Events that have a predominant commercial component

## Post Project Summary

To assist the Olympic and Paralympic Operations Office in evaluating the success of Host a City Happening Community Program, applicants must submit a Post Project Summary. Details of the Post Project Summary will be available to the applicant upon approval of funding.

#### Grant Term

Approved projects must be completed and funding must be spent after City Council's approval of the grant no later than March 21, 2010.

#### **Process**

The Host a City Happening Program has four deadlines. The first deadline will be Thursday May 15<sup>th</sup>, 2008. The second deadline will be Monday September 15<sup>th</sup>, 2008. Staff anticipates that deadlines in 2009 will follow a similar structure.

The Olympic and Paralympic Operations Office will conduct interviews with applicants as appropriate. Following the review process, recommendations will be made by a staff committee. Written notice of these recommendations will be sent to all applicants, together with notice of the City Council meeting date at which the grants will be considered. Successful applicants generally receive grant payment within three weeks of Council's approval.
