**ADOPTION OF MINUTES**

1. **2008 Annual Bicycle Plan Update**  
July 8, 2008

Engineering staff presented the report and responded to questions.

The Committee heard from one speaker in general support of the report recommendations, with additional suggestions to move forward with the Plan.

A Council member requested staff provide Council with the November 2005 report referenced during discussion, and subsequent related material, regarding the 10% modal split.

- A. THAT Council receive the Administrative Report dated July 8, 2008, entitled "2008 Annual Bicycle Plan Update" report for information.
- B. THAT staff report back, including costing, on how to achieve a 10% modal split by 2010 or thereabouts and over what time frame.
- C. THAT staff report back, including costing, on implementation of a public bike system in the City of Vancouver.

Council agreed to separate the vote on the components of the motion.

**2. Part 3 Division B Green Building Strategy Update**  
July 7, 2008

THAT the Committee recommend to Council

- A. THAT Council receive this update and endorse the development of the recommended by-law amendments and zoning guidelines to enhance the environmental performance of all buildings regulated under Part 3 of Division B of the Building By-law (generally over 3 storeys or greater than 600 m<sup>2</sup> in building area) as outlined in the Administrative Report dated July 7, 2008, entitled "Part 3 Division B Green Building Strategy Update".

- B. THAT Council approve the proposed amendments to the Building By-law and to Appendix A to the Building By-law, generally as outlined in Appendix A of the Administrative Report dated July 7, 2008, entitled "Part 3 Division B Green Building Strategy Update", to update the energy efficiency standard for Part 3 buildings, to be effective as of September 5<sup>th</sup> 2008.
- C. THAT Council instruct the Director of Legal Services to bring forward a by-law to amend the Building By-law, generally as outlined in Appendix A of the Administrative Report dated July 7, 2008, entitled "Part 3 Division B Green Building Strategy Update".

- 3. **210 Abbott Street - KKBL No. 546 Ventures Ltd. Liquor Primary Liquor License for Outdoor Patio Seating and an Increase in Patron Capacity**  
July 8, 2008

THAT the Committee recommend to Council

- A. THAT Council, having considered the opinion of area residents and business operators of the community as determined by neighbourhood notification, the proximity of residential developments, potential noise impacts and relevant Council policy as outlined in the Administrative Report dated July 8, 2008, entitled "210 Abbott Street, KKBL No. 546 Ventures Ltd., Liquor Primary Liquor License for Outdoor Patio Seating and an Increase in Patron Capacity", endorse the application by KKBL No. 546 Ventures Ltd., for a Liquor Primary patio (on City property) at the Lamplighter Pub, 210 Abbott Street subject to:
  - i. A maximum capacity of 36 persons;
  - ii. The signing of a Good Neighbour Agreement with the City;
  - iii. The patio ceasing all liquor service and vacated by 11:00 p.m.;
  - iv. No music permitted on the patio;
  - v. A license agreement with an initial one-year term;
  - vi. Food service while the patio is open; and
  - vii. Smoking prohibited on patio.
- B. THAT Council, having considered the opinion of area residents and business operators of the community as determined by neighbourhood notification, the proximity of residential developments, potential noise impacts and relevant Council policy as outlined in the Administrative Report dated July 8, 2008, entitled "210 Abbott Street, KKBL No. 546 Ventures Ltd., Liquor Primary Liquor License for Outdoor Patio Seating and an Increase in Patron Capacity", endorse the application by KKBL No. 546 Ventures Ltd., for an increase in patron capacity for the Liquor Primary Liquor License (License #002249) from 169 seats to 183 seats at The Lamplighter Pub, 210 Abbott Street.

THAT Council, having considered the opinion of local area residents and business operators as determined by neighbourhood notifications, noise impacts and relevant Council policy as outlined in this Administrative Report dated July 7, 2008, entitled "1199 West Pender Street - 5230 Investments Ltd., Relocation of Liquor Primary Liquor License Application, Change in Hours and a Decrease in Patron Capacity", endorse the request by 5230 Investments Ltd. to relocate their existing Liquor Primary liquor license from 828 West Hastings Street (Jolly Tax Payer Hotel) to their proposed site at 1199 West Pender Street, subject to:

- i. Adhering to clean air practices;
- ii. Hours of operation limited to 12:00 noon to midnight, seven days a week;
- iii. A maximum total capacity of 50 patrons;
- iv. Signing a Good Neighbour Agreement with the City prior to business license issuance; and
- v. A Time-limited Development Permit.

#### NEW BUSINESS

##### 1. JUNO Celebrations 2009

The following motion was submitted by Councillor Ball. Councillor Cadman called Notice under Section 5.4(c) of the Procedure By-law. The motion will be considered at the Regular Council meeting on July 22, 2008.

WHEREAS:

1. The 2009 Juno Awards were awarded to Vancouver earlier this year by the Canadian Academy of Recording Arts and Sciences. Celebrations are scheduled to take place March 26-29, 2009.

THEREFORE BE IT RESOLVED THAT:

1. Council ask City staff to work with the JUNO Organizing Committee to explore the feasibility of:
  - select road closures for special events & pre-awards music festival - including Granville Street Entertainment District;
  - providing incentives for bar owners to program live music by local artists and bands through temporary approvals for changes to operating hours during the JUNO celebrations in consultation with VPD, Barwatch, Translink and taxi companies;
  - encouraging venue operators to program live music by local artists and bands during the JUNO celebrations;
  - access to banners and flags under the City's Banner and Flag Program.
2. Council invite the Vancouver School Board to work with the JUNO Organizing Committee through the Education Initiatives Committees in order to encourage youth participation in live music.
3. Council invite the Government of Canada to join with the City and Province in contributing \$500,000 in support of this important celebration of Canada's growing music scene, which includes both education and industry.
