# 1. Temporary Protection of the York Theatre - 639 Commercial Drive September 9, 2008

Staff from Current Planning presented the report and responded to questions.

The Committee heard from four speakers; one of whom spoke in support of staff's recommendations and three representing the building owners who spoke in opposition and expressed concerns regarding costs and logistical challenges associated with any additional delays with their housing project at the site.

THAT pursuant to section 589 of the Vancouver Charter, Council orders that the whole of the exterior and the interior of the York Theatre be subject to temporary protection in accordance with the provision of Section 591 of the Vancouver Charter for a period of 120 days from September 18, 2008.
- C. THAT Council agrees the form of this Order shall be satisfactory to the City's Director of Legal Services and that the Order shall be executed on behalf of Council by the Director of Legal Services.

# 3. BC Green Party at the 2008 Union of British Columbia Municipalities Convention

MOVED by Councillor Capri SECONDED by Councillor Anton

Whereas UBCM will be holding their annual convention in September 2008; and

Whereas the leader of the BC Liberal Party and BC New Democrats are provided an opportunity to address the UBCM delegates; and

Whereas the Green Party of British Columbia is the third major political party in the province and is supported by a large number of Vancouver citizens and has no official voice at UBCM; and

Whereas Mayor Sullivan introduced a motion at UBCM last year, that was narrowly defeated, asking them to consider allowing the leader of the BC Green Party to formally address the convention; and

Whereas the leader of the BC New Democrats did not support providing the BC Greens an opportunity to address the convention; and

Whereas the Green Party of BC has indicated their interest in addressing the delegates;

Therefore be it resolved:

THAT City Council request the Mayor write a letter to UBCM asking that they permit the leader of the BC Green Party to address the 2008 convention delegates;

FURTHER THAT a copy of this motion be sent to all Mayors and Councillors across BC; and

FURTHER THAT a copy of this motion be sent to UBCM, the Premier and the Leader of the Official Opposition.

#### AMENDMENT MOVED by Councillor Cadman

THAT the motion be amended by striking out the first paragraph and substituting with the following:

THAT City Council request the Mayor write a letter to UBCM Executive asking that they consider permitting the leaders of all parties running candidates to address the 2008 convention delegates and that the Executive consider a change in policy for future conventions;

#### 7. Metro Vancouver's Solid Waste Management Planning

MOVED by Councillor Cadman SECONDED by Councillor Deal

WHEREAS: Metro Vancouver is looking for alternatives to landfilling the region's solid waste, and is considering building six new waste-to-energy (WTE) incinerators within Metro Vancouver that would burn up to 1.5 million tonnes of garbage annually;

AND WHEREAS: burning garbage releases toxic materials including hydrogen chloride and nitric oxide, lead, cadmium, arsenic, mercury and chromium, that can pose serious health hazards;

AND WHEREAS: the air pollutants released by waste incinerators in Metro Vancouver would drift east into the Fraser Valley, further impacting a sensitive airshed that already suffers from severe air pollution;

AND WHEREAS: Metro Vancouver would be contractually obligated to deliver up to 1.5 million tonnes of waste to the private operators of the incinerators, that could put a cap on incentives and initiatives to increase the region's recycling and to reduce, reuse and recycle waste;

THEREFORE BE IT RESOLVED: that Council advise the Metro Vancouver Waste Management Committee, through its representative on that Committee, that before any decisions are taken on building new WTE incinerators, that the Metro Waste Management Committee undertake a comprehensive and independent economic, health and environmental study of the impacts of waste incinerators on both the Metro and Fraser Valley regions;

AND BE IT FURTHER RESOLVED: that the Metro Vancouver Waste Management Committee initiate an independent and comprehensive public consultation process before making any decision on building new WTE incinerators in the region.

The Chair ruled the motion out of order, as this matter has already been dealt with. Councillor Cadman challenged the ruling of the Chair.

The Chair then put the question:

Shall the ruling of the Chair be sustained?

CARRIED (Councillors Cadman, Chow, Deal and Stevenson opposed) (Councillor Louie absent for the vote)

A two-thirds majority of those present is required to overrule the ruling of the Chair. Therefore, the ruling of the Chair was SUSTAINED.

## 8. 2008 BCSC 661err1 PHS Community Services Society v. Attorney General of Canada

The following motion was submitted by Councillor Louie.

WHEREAS Insite, the Supervised Injection Site, is a critical element of the city's Four Pillars drug policy and crime reduction strategy, which emphasizes prevention, treatment, enforcement and harm reduction; and

WHEREAS the Federal government has refused to provide a long-term extension to Insite's research exemption from federal drug laws despite overwhelming scientific evidence of its benefits; and

WHEREAS the Portland Hotel Society Community Services (PHS) has won an important Supreme Court of British Columbia ruling that struck down sections of Canada's drug laws as unconstitutional and gave Insite an exemption to remain open until the laws are brought into line with the Charter of Rights and Freedoms; and

WHEREAS the Federal government has given notice of its intention to appeal the decision and has publicly attacked the Insite program and the medical professionals operating it;

THEREFORE BE IT RESOLVED THAT Council direct the City's legal department to apply for intervenor status in the federal government's appeal of the Supreme Court of British Columbia decision, in support of the Portland Hotel Society Community Services (PHS) and the Attorney General of British Columbia to defend the supervised injection element of the city's drug policy.

#### **NEW BUSINESS**

# 1. Support for the Vancouver 2011 Outgames

MOVED by Councillor Capri SECONDED by Councillor Anton

WHEREAS:

The Vancouver 2011 Outgames Organizing Committee is submitting a bid for Vancouver to host the games;

The Organizing Committee is proposing a program that Vancouverites can be proud of, which includes: sports competitions – mountain, marine and land, cultural celebrations, corporate challenges, legacy contributions, and human rights education and promotion;

The Organizing Committee will be struck as a legal, indemnified, stand-alone entity whose task will be to plan and deliver a surplus-producing 2011 Outgames; and

If successful in its bid, the Vancouver Outgames will be the first North American Outgames conducted through an open-bid process and therefore will have the distinction of providing a model for future Continental Outgames; and

The Outgames Organizing Committee has requested that Vancouver Council express support for the City of Vancouver to welcome the games here in 2011;

THEREFORE BE IT RESOLVED THAT:

- 1) Council support the Vancouver 2011 Outgames Organizing Committee's bid to host the games, and welcome their submission to the City's Sport Hosting grants program; and
- 2) Council send a copy of this Motion to the Organizing Committee for submission with their bid.

# ENQUIRIES AND OTHER MATTERS

#### 1. Tap Water Campaign

Councillor Stevenson provided an update on Metro Vancouver Water Committee's Tap Water Campaign and on London, Ontario's bottled water ban in municipal facilities. He enquired as to when the staff report back on bottled water is expected and requested that staff also check into London's ban.

The City Manager agreed to look into the status of the report back.

#### 2. Eliminating Plastic Shopping Bags

Councillor Stevenson noted Metro Vancouver's recent recommendation with regard to promoting a reduction in plastic shopping bag use, Vancouver's leadership role, and advised he will be presenting a motion on the matter at the next Council meeting.

Councillor Ladner provided an update on Metro Vancouver Waste Management Committee work pertaining to plastic bags use and solid waste management planning and consultation, and asked for clarification on the City's powers with respect to a plastic bag ban.

The Council adjourned at 12:05 p.m.
