1. Nuisance Building at 3220 Prince Edward Street September 3, 2008

THAT the City Clerk be directed to file, 60 days from September 18, 2008, a 336D Notice against the title to the property at 2745 East Hastings, Lot A of Lot 51, THSL, Plan BCP16237, PID 026-240-327 in order to warn prospective purchasers that there are contraventions of the Building By-law in relation to this building, should the owner not correct the violations.
- B. THAT the Director of Legal Services is hereby authorized, in her discretion, to commence a legal action or proceeding in relation to the premises located at 2745 East Hastings, Lot A of Lot 51, THSL, Plan BCP16237, PID 026-240-327, and may, in her discretion, seek injunctive relief in that action or proceeding, in order to bring this site into compliance with City By-laws.

 Proposed Amendment to Subdivision By-Law No. 5208 - Reclassification of 770 and 782 East 41st Avenue and 5715 Prince Albert Street August 28, 2008

- (i) plans, received December 12, 2007, represented in Appendix F;
- (ii) draft CD-1 By-law provisions, generally as presented in Appendix A; and
- (iii) conditions contained in Appendix B.
