Enactment of the attached by-law will implement Council's resolution of December 18, 2008 respecting new water rates and fees to be effective from January 1, 2009 and other miscellaneous amendments.

A By-law to amend Water Works By-law No. 4848 regarding 2009 fee increases and miscellaneous amendments

THE COUNCIL OF THE CITY OF VANCOUVER, in public meeting, enacts as follows:

- 1. This By-law amends the indicated provisions and schedules of the Water Works By-law.
- 2. To the definition of "SERVICE PIPE" in section 2, before "1.0", Council adds "than".
- 3. From the second paragraph of section 3, Council strikes out "twice", and substitutes "1.5 times".
- 4. From section 3A(b), Council strikes out "1970", and substitutes "1978".
- 5. From the third paragraph of section 7, Council strikes out "ductible", and substitutes "ductile".
- 6. To the first sentence of section 12, after "Collector", Council adds "or Engineer".
- 7. From section 19, Council strikes out 'twice the amount of the cost that would apply if a flat rate charge were applicable, and if the "at cost" amount is less than the advance payment', and substitute 'based on an estimate provided by the City. If the "at cost" amount is less than 1.5 times the flat rate'.
- 8. Council repeals section 32(4), and substitutes:
 - "The city is to compute and render bills at intervals of three months at the rates for water consumption and meter charges prescribed in Schedules D and E for a three month period. The Collector is to state in each bill a date when payment is due and payable which must be subsequent to the date of mailing of the bill."
- 9. To section 34(b), after "penalty", Council adds "or loss of discount".
- 10. From Schedule D, Council repeals:
 - "A minimum charge of 8 units per month will be charged should lower or no consumption be recorded in any billing period."
- 11. Council strikes out from:
 - (a) the third paragraph of section 7, "of \$45 per month";
 - (b) the first paragraph of section 12, "of \$300.00 for each such unit";

- (c) section 32(5), "of \$75"; and
- (d) the first paragraph of section 38, "of \$110.00"; and substitutes "as specified in Schedule H".
- 12. Council strikes out from:
 - (a) section 26, "\$50" and "\$200";
 - (b) section 28, "of \$60.00 for a single family dwelling and \$90.00 for all other properties"; and
 - (c) section 34(d)(ii), "of \$50";

and substitutes "as specified in Schedule "I".

13. Council repeals Schedules A to I inclusive, and substitutes:
