(e) the acquisition, disposition or expropriation of land or improvements, if the Council considers that disclosure could reasonably be expected to harm the interests of the city;

(g) litigation or potential litigation affecting the city;

(i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;

(j) information that is prohibited, or information that if it were presented in a document would be prohibited, from disclosure under section 21 [disclosure harmful to business interests of a third party] of the Freedom of Information and Protection of Privacy Act;

(k) negotiations and related discussions respecting the proposed provision of an activity, work or facility that are at their preliminary stages and that, in the view of the Council, could reasonably be expected to harm the interests of the city if they were held in public.

NOW THEREFORE BE IT RESOLVED THAT Council authorize the City Manager and Director of Legal Services to make an urgent request to the Province to amend the *Vancouver Charter* to provide Council with sufficient financing powers in connection with the Olympic Village project so that the City may ensure that the optimal outcomes are achieved for the taxpayers.
