SUBJECT: 2009 Community Services Grants and Rent Subsidy Allocations

RECOMMENDATION

A. THAT Council approve 9 Neighbourhood Organization Grants totalling \$695,488, including any recommended Conditions on the grants, as listed in APPENDIX A-1. Source of funding is the 2009 Community Services Grants budget;

- B. THAT Council approve 6 Organizational Capacity Building Grants totalling \$186,788, including any recommended Conditions on the grants, as listed in APPENDIX A-2. Source of funding is the 2009 Community Services Grants budget;
- C. THAT Council approve 90 Direct Social Services Grants totalling \$3,094,988, including any recommended Conditions on the grants, as listed in APPENDIX A-3. Source of funding is the 2009 Community Services Grants budget;
- D. THAT Council approve the establishment of a \$30,000 reserve in the 2009 Community Services Grants budget for the Partners in Organizational Development program;
- E. THAT Council approve 4 Rent Subsidy Grants totalling \$95,575, as listed in APPENDIX A-4. Source of funding is \$63,500 from the 2009 Rent Subsidy Grants budget and \$32,075 from the Contingency Reserve;

As Recommendations A, B, C, and E recommend grants, 8 affirmative votes are requested for approval.

CITY MANAGER'S COMMENTS

The City Manager recommends approval of A to E.

COUNCIL POLICY

On March 7, 1978, City Council established the Community Services Grants program.

On June 8, 1993, City Council decided that rent subsidies to social service or cultural organizations, occupying City-owned property held in the Property Endowment Fund, will be funded from the Community Services or Cultural Grants budget, and that these budgets will be adjusted to accommodate any new or renewed subsidies approved by Council.

On October 9, 2003, City Council approved a number of revisions to establish the current Community Services Grants program, including:

- the creation of three categories of Community Services Grants;
- three sets of eligibility criteria which apply to each of the categories of Community Services Grants;
- priorities for the Direct Social Services category of Community Services Grants.

Council also reconfirmed, as policy, other aspects of the Community Services Grants program, including: Basic Eligibility Criteria, Ineligible Services, Core Funding Guidelines, Rent Subsidy Grants, and the Appeal Process.

Approval of grant recommendations requires eight affirmative votes.

PURPOSE AND SUMMARY

This report provides information about the Community Services Grants and Rent Subsidy Grants programs, the review process and this year's applications. This report recommends the allocation of \$4,007,264 in Community Services Grants and \$95,575 in Rent Subsidy Grants.

Recommendations in the Community Services Grants stream include:

- 9 Neighbourhood Organization Grants, 6 Organizational Capacity Building Grants and
 90 Direct Social Services Grants, totalling \$3,977,264.
- A reserve of \$30,000 for the Partners in Organizational Development (POD) program.
 POD is a joint City of Vancouver, Vancouver Foundation and United Way of the Lower Mainland program that supports organizational development needs of non profit groups.

Five applicants have appealed their Community Services Grants recommendations. These applications have been removed from this report and will be the subject of a separate report which is scheduled for Standing Committee on City Services and Budgets on May 7, 2009.

Staff also recommends approval of 4 Rent Subsidy Grants totalling \$95,575. The rent subsidy budget is in a separate category within the Social Policy Grants. By Council policy, approval of additional rent subsidy grants beyond the year's annual budget is funded from Contingency Reserve as has been done in prior years. The 2009 budget for Rent Subsidy Grants is \$63,500. Recommendations include increases in rent subsidy to two organizations and one new rent subsidy grant, for a total increase of \$32,122 over the existing budget. There is \$47 in unallocated funds available from the original Rent Subsidy Budget of \$63,500. This requires

\$32,075 in additional funding for Rent Subsidy Grants from the Contingency Reserve, bringing the total rent subsidy budget to \$95,575.

BACKGROUND

Established in 1978, the Community Services Grants program provides financial support to non-profit organizations which are working with each other, the various levels of government and residents to address social problems and bring about positive social change.

This grant program:

- Provides support and services to low income and vulnerable populations;
- Provides strategic support to address gaps in services;
- Helps provide stability in the social services sectors;
- Leverages substantial support from other funders for Vancouver programs;
- Enables the City to collaborate with other funders;
- Contributes to volunteer time to strengthen services and assist the public;
- Lets the City have an influence over what and how programs are delivered;
- Supports priority programs on an ongoing rather than short-term basis, allowing the City to see and document the benefits that accrue over time; and
- Can be used to bring about service or organizational change, and to develop community/neighbourhood capacity.

The most recent major review of the Community Services Grants program took place in 2003 and resulted in a number of changes which were approved by City Council on October 9, 2003. Starting in 2004:

- The grants program was divided into three categories:
 - Neighbourhood Organizational Grants, which support the core staff in organizations which serve all population groups in a neighbourhood and also demonstrate community capacity building and community development activities;
 - o Organizational Capacity Building Grants, which support groups whose purpose is to assist other non-profits to function more effectively; and
 - Direct Social Services Grants, which support the activities of groups which deliver direct services to vulnerable populations and respond to key social issues:
- Eligibility criteria were developed for each of the three types of grants (website www.vancouver.ca/commsvcs/socialplanning/grants/commgrantsapp.htm);
- A list of priorities was developed for the Direct Social Services Grants category to assist in the comparative assessment of applications (website www.vancouver.ca/commsvcs/socialplanning/grants/pdf/09_DSS_Info.pdf); and
- An Outcomes Measurement approach was developed. This framework enables groups to record their objectives for a given year, and the actual outputs and short and long term outcomes achieved. These reports are reviewed in the City's grant review process and also serve as a planning tool for groups.

The majority of applications are received under the Direct Social Services (DSS) grants category. The review process for these grants includes both basic eligibility and how well applications meet current City priorities, as well as the Outcomes Measurement reporting.

Some applications meet City priorities more strongly than others, hence, a DSS may be eligible, but not recommended for funding due to its low priority compared to other applications, within the given budget. New applicants may meet City priorities more strongly than groups which have previously been funded. This may result in the termination of grants that have been funded in previous years, but also allows for the funding of programs and organizations.

For reference, the average Community Services Grant for all types is \$37,816. The average grant per stream is:

DISCUSSION

2009 Summary of Applications

For the 2009 Community Services Grants program, Social Policy received 116 regular grant applications. In addition, 4 rent subsidy grant applications were received. As shown, the number of applications, organizations and new applications is relatively consistent over the years.

Note: the totals above include groups that have appealed their recommendation. However, these groups are not included in the recommended grant totals noted elsewhere in this report as they will be the subject of a later Council report.

Grant Review Process

As part of an effort to simplify both the application and review process, a shorter, simpler application form was made available to most 2009 applicants. This facilitated the collection of the most relevant updated information required to assess the application. A few organizations, most significantly new applicants, received a longer more detailed application form (website - www.vancouver.ca/commsvcs/socialplanning/grants/commgrantsapp.htm). Staff also simplified the review process by conducting telephone rather than face-to-face

interviews for groups whose work was well known and where there were no significant changes in the organization or programs.

Rent Subsidy Grants

Council has a policy of considering rent subsidy grants to groups which qualify for a Community Services Grant and which rent City-owned property held in the Property Endowment Fund. The City charges market rental for these properties and groups may request a subsidy to offset this market rent. Social Policy's recommendation for or against such a grant will be based on the grant criteria and priorities used to assess Community Services grant allocations. Rent subsidy grants can be applied for at any time during the year.

Four organizations are being recommended for rent subsidy grants:

- Family Services received a rent subsidy of \$15,500 in 2008 and has requested, and been recommended for, the same subsidy this year.
- The Dugout Drop-in Centre received a rent subsidy of \$8,880 in 2008 and has requested, and been recommended for, a subsidy of \$9,000 in 2009. A subsidy of close to 100% of the rent of \$9,324 is recommended, because this group has very limited resources and serves a very high need population.
- BC Coalition of People with Disabilities received a rent subsidy of \$39,073 and has requested, and been recommended for, a subsidy of \$50,000 in 2009 (\$10,927 increase). The 2008 rent was \$61,425 and the 2009 rent is \$78,863 (an increase of \$17,438).
- Pacific Community Resources Broadway Youth Resource Centre is recommended for a new rent subsidy grant of \$21,075. This organization previously paid market rent and operating costs of \$134,400. The City now owns the site and rent and operating costs will increase to \$161,000 effective May 1, 2009 (\$26,600 total increase). The recommended subsidy represents a pro-rated amount of the total increase. Youth hubs are high priority in the City grant policy.

The 2009 budget for Rent Subsidy Grants is \$63,500. The recommendation of \$32,075 in additional funding for Rent Subsidy Grants from the Contingency Reserve would make the total rent subsidy budget \$95,575.

Contingency Reserve funds have been used in prior years to top up the Rent Subsidy grants when necessary (2008 - \$109,250; 2003 - \$4,128; 2001 - \$63,820).

Summary of Recommendations

The following is a summary showing a comparison between 2008 and 2009. The table shows the recommendations which are made in this report concerning 111 applications. The five applications (four Direct Social Services and one Organizational Capacity Building applicant) that have appealed their recommendations are not shown in the table.

APPENDICES A-1 to A-4 list the grants which are being recommended at this time. Applicants that have appealed their grant recommendation have been removed from these lists.

APPENDICES B lists the applicants which are not recommended for a grant, along with the reasons for this recommendation.

APPENDIX C lists the applications that have appealed their recommendations.

APPENDIX D lists the Direct Social Services Grant applications, sorted by the target population which they primarily serve. Most organizations serve more than one population; therefore, a completely accurate picture of the allocation of City funds to each target group cannot be given. However, this table does give an indication of funding changes within population groups.

Copies of the front pages of all applications, along with information sheets that contain the approved criteria and priorities have already been distributed to Council. These contain more detailed information on the applicants and the programs or services for which they are seeking City funding.

Recommendations Summary:

- Increases to two Neighbourhood Houses which have markedly increased outreach and capacity building activities;
- Increase to one Organizational Capacity Building organization;
- Increases to 13 Direct Social Services organizations which most strongly respond to City
 grant priorities to supplement low salary levels and assist groups to retain staff, or add
 additional hours for high priority services (including Conditions with respect to the
 purpose of these increases), and seven increases to prorated grants to bring them up
 to a full year funding;
- Cost of living increases for 7 Neighbourhood Houses, 6 Organizational Capacity Building grants and 74 Direct Social Services grants. Many of these groups have had funding levels fall significantly behind inflation over the past ten years;
- Funding for three new applications which address high priority needs, including Conditions respecting the purpose of the funding;
- The reserve of \$30,000 to the Partners in Organizational Development (POD) program; and

 4 rent subsidy grants, including one new rent subsidy grant and an increase to two rent subsidy grants.

As is normally the case, staff have placed Conditions on a number of grants, and have made comments on some grant recommendations. All applicants have been informed, in writing, of Social Policy's recommendations.

Should Council approve all the above-noted recommendations, there will be an unallocated balance of \$40,136 in the 2009 Community Services Grants budget. Should the five groups that have appealed the initial staff recommendations be successful for their request for consideration, the balance remaining is sufficient to only cover the original staff recommendation.

Appeal Process

Appeals to the recommendations will be addressed in a separate report that will go to Council at the Standing Committee on City Services and Budgets meeting on May 7, 2009. Five applicants have advised us that they wish to appeal their recommendations. They are: Chinese Community Library Services Society, Downtown Eastside Youth Activities Society, Hastings North Area Plan - Thunderbird Restorative Justice, PeerNetBC - Kinex, and South Vancouver Seniors Network Society.

FINANCIAL IMPLICATIONS

The 2009 budget for the Community Services Grants category is \$4,047,400 and the Rent Subsidy Grants is \$95,575.

The Community Services Grants recommended in this report total \$4,007,264 and are broken down as follows:

The proposed allocations include the establishment of a \$30,000 reserve for the Partners in Organizational Development.

In addition, 4 rent subsidy grants totalling \$95,575 are also recommended for approval. Currently only \$63,500 is provided for in the 2009 Social Policy Grants budget; therefore, approval would require an allocation of \$32,075 from 2009 Contingency Reserve. This is consistent with prior years use of Contingency Reserve funds to top up the Rent Subsidy grants (2008 - \$109,250; 2003 - \$4,128; 2001 - \$63,820).

SOCIAL IMPLICATIONS

The Community Services Grants Program provides financial support to non-profit organizations that work with each other, various levels of government and residents to address social problems and bring about positive social change. The grants have been an important resource for community groups to provide needed services in Vancouver, leverage funding from other sources, and contribute to the building of strong communities and the delivery of quality services to Vancouver residents.

CONCLUSION

The Community Services Grants Program provides an important contribution to the delivery and sustainability of Social Services in Vancouver, to a wide range of population groups serving marginalized citizens. The program also supports City liveability and social development objectives.
