SUBJECT: 2009 Cultural Operating, Project and Major Exhibiting Institution Grant Allocations

RECOMMENDATION

- A. THAT Council approve 96 Operating Grants for a total of \$2,727,000 and 60 Project Grants for a total of \$454,700 as listed in Appendix A, for a total of \$3,181,700 including 2 conditional grants as noted in Appendix A. Source of funds to be the 2009 Cultural Grants budget;
- B. THAT Council approve 25 Expanded Criteria grants as listed in Appendix A for a total of \$174,500. Source of funds to be the 2009 Cultural Grants budget;
- C. THAT Council approve 5 Major Exhibiting Institution Grants for a total of \$3,943,900 as listed in Appendix A. Source of funds to be the 2009 Cultural Grants budget;
- D. And THAT Council approve a one-time extraordinary advance release of four months of grant installments of \$722,500 in one lump sum to the Vancouver Art Gallery. Source of funds to be the 2009 Cultural Grants budget.

GENERAL MANAGER'S COMMENTS

The General Manager of Community Services recommends approval of the foregoing.

COUNCIL POLICY

City Council established the annual civic grant programs, including Cultural Grants, in March 1978. The current Operating and Project Grant categories were approved on December 14, 1989.

On November 22, 1994, Council approved the two-step grant approval process for Operating and Project Grants, whereby undisputed recommendations are approved first (and are the

subject of this report), while applications eligible for reconsideration are given a second review and are presented to Council at a later date.

Pursuant to the June 26, 2008 report Culture Plan Implementation Phase One - Review of Grant Programs (RTS# 07236), Council directed Staff to restructure the City's funding relationship with the Major Exhibiting Institutions incorporating their inclusion in the annual peer review process. This is the first year that the five Major Exhibiting Institutions—A.S.T.C. Science World, the H.R. MacMillan Space Centre, the Vancouver Art Gallery, the Vancouver Museum and the Vancouver Maritime Museum—have been included in this process and not presented to Council under a separate report.

In 2008, as a result of the first phase implementation of changes informed by the Cultural Grants Program Review, the grants program criteria was expanded to respond to needs within the cultural community. These changes included considering conferences, publications, films, videos, audio recordings, and web-based initiatives as eligible activities. Further, mentorships and residencies were also introduced as a component of the program.

Approval of grant recommendations requires eight affirmative votes.

SUMMARY & PURPOSE

As listed in Appendix A, this report recommends approval of 161 grants for a total amount of \$7,125,600 which includes all Operating, Project and Major Exhibiting Institution Grant applications for 2009. Also listed in Appendix A, this report recommends approval of 25 Operating and Project Expanded Criteria grants for a total of \$174,500. The report requests Council approval for a grand total of \$7,300,100 of cultural grants.

The recommendations include and are not in addition to any advance Operating Grant instalments already approved by Council on January 20, 2009 or any Major Exhibiting Institution Grant instalments already approved by Council on December 16, 2008. Appendix B includes Operating and Project Grants guidelines.

BACKGROUND

Operating grants are designed to assist organizations in achieving a level of stability required to provide ongoing quality programming or services. To be considered for an Operating Grant, an organization must be a non-profit, professional arts organization with an artistic mandate. Organizations will have received civic Operating or Project Grants for at least the past two consecutive years. They must also meet other criteria related to artistic merit, organizational competence and community impact. Project Grants are designed to support emerging arts groups, groups undertaking one-time initiatives, or those who work on a project basis. These groups must also be professional, non-profit arts organizations.

Recommendations are based on a thorough analysis by an Assessment Committee comprised of City staff and independent community peer representatives using clearly articulated evaluation criteria for the two programs (see Appendix B), including:

 Artistic merit as demonstrated through previous activities, artistic niche, and proposed activities.

- Organizational competence evidenced through capable administration and governance, financial stability and accountability, planning and demonstrated need for public sector assistance.
- Community impact as demonstrated through accessibility of the work by the public (including Vancouver's diverse communities), public interest and community outreach.
- Consideration of one or more of the City's five strategic cultural priorities as outlined in the 2008 Culture Plan (Innovation, Learning, Connecting people ideas and community, Neighbourhoods and Valued and valuable) and alignment and support of the City's cultural vision.
- Evidence that the organization has the ability to achieve the proposed activities within its available resources.

Request for Reconsideration Process

Applicants who meet specific criteria (see below) have the opportunity to formally request reconsideration. The Reconsideration process, approved by Council in 1994, ensures consistency in reconsidering grant recommendations and allows adequate time for organizations to present their case and for staff to provide Council with a written response.

Under current policy, grants referred to the process are assessed on the basis of two established grounds:

- 1) that eligibility criteria have not been properly applied; and/or
- 2) that the financial situation of the applicant was not properly evaluated or understood at the time of the grant review.

Information on this policy and the process is provided to applicants at the time they receive written notice of recommendations going forward to Council. The deadline for Request for Reconsideration is April 17, 2009. Any requests for reconsideration will be considered by Council in a separate report and at a future date. Those groups which request reconsideration but do meet the eligibility criteria will not be reconsidered but will be reported to Council along with the original Assessment Committee's recommendation at the same time as the eligible Requests for Reconsideration.

DISCUSSION

The Cultural Services Department invited independent peer community members to participate in the assessment committee process to review grant application requests. For this deadline, Assessment Committee members from the arts and cultural community were sought through an ongoing call for nominations that was re-sent in early January 2009. Twenty community members were selected to participate with staff to review grant applications and make recommendations.

The Committee represented a broad range of expertise in the disciplines of visual arts, theatre, dance, music, literary, festivals and multi-disciplinary art forms. The independent Assessment Committee members for the 2009 Cultural Operating, Project and Major Exhibiting Institution grants were:

All independent committee members (external peer reviewers) are sent full application packages to read well in advance of the adjudication meeting. Members conduct an evaluation of the applications using the same criteria as staff (assessing artistic merit, organizational capacity, community impact and consideration of the City's strategic cultural priorities). Members of the Assessment Committee met over a seven-day period at the beginning of March 2009 to discuss the grant application requests, and arrive at consensus-based recommendations. Requests for funding for initiatives under the new expanded program criteria were considered within the above-noted Assessment Committee process. Staff finalize recommendations which are forwarded to Council for consideration and approval in April.

Any applicant who requests reconsideration of their recommendation, and who meets reconsideration criteria, is referred to a separate *Request for Reconsideration* process. These requests are forwarded to Council in a separate report at a later date.

This process augments staff's ongoing consultation with organizations throughout the year, their attendance at the organizations' events, as well as personal meetings with staff and board members of the organizations.

Major Exhibiting Institutions

As outlined in the June 26, 2008 report Culture Plan Implementation Phase One - Review of Grant Programs (RTS# 07236), Council directed Staff to restructure the City's funding relationship with the Major Exhibiting Institutions incorporating their inclusion in the annual peer review process. Prior to 2009, the City of Vancouver's funding relationship with the five Major Exhibiting Institutions—A.S.T.C. Science World, the H.R. MacMillan Space Centre, the Vancouver Art Gallery, the Vancouver Museum and the Vancouver Maritime Museum—was a staff-driven review which recommended financial support for general operations to these institutions through operating grants which have been adjusted annually by a blended inflation factor based on the recommendation of Budget Services.

This change was made in response to a need to include key organizations in the annual review process discussion to impart a more comprehensive analysis of the cultural sector and also to commence the streamlining of numerous grant programs. For the first year of this transition, the peer review members of the Assessment Committee were asked to review and comment on the application requests only where staff would make final recommendations on grant levels. These comments, like all comments from the Assessment Committee, will be provided to the Majors in their recommendation letters and will inform discussion of these groups in future.

The peer members of the Assessment Committee reviewed the requests with great interest observing the unique challenges and responsibilities of the institutions holding civic collections. They noted the caliber of the Maritime Museum collection given the recent review conducted and looked forward to learning about specific plans to maximize the promotion and presentation of maritime culture through this collection. They supported the Vancouver Museum's new vision and acknowledged the significant strategic planning and programming initiatives underway in support of that vision. They further noted the extent of their community collaboration, outreach and focus on audience engagement. They commended the curatorial team and vision of the Vancouver Art Gallery and looked forward to learning more about the society's plans for their future location. They also noted the imminent presentation of the "Vermeer, Rembrandt and the Golden Age of Dutch Art Masterpieces from The Rijksmuseum" exhibition and the strain this significant exhibition has put on their cash flow situation, forcing the Gallery to draw from reserves to conduct overall operations. The Committee was encouraged by the creative methods of interpreting cosmologies through specific cultural lenses as demonstrated by the H.R. MacMillan Space Centre. The Committee commended the success of some recent exhibitions and programs at Science World and their capacity to attract large audience numbers.

Staff are recommending an operating grant to all five institutions at the base level from 2008 plus a 2% inflationary increase to each organization. The recommendation for the major

exhibiting institutions totals \$3,943,900. Staff are also recommending an advance grant of the equivalent of four months of grant installments totaling \$722,500 to the Vancouver Art Gallery to relieve cash-flow issues placed on the Gallery as a result of the Dutch masterpiece exhibition. This is a one-time extraordinary request which is not in addition to the monthly installments the Gallery is already receiving.

The next phase of the transition will be to fully integrate the Major Exhibiting Institutions into the Assessment Committee process where the Committee will make recommendations on the organization's grant levels consistent with the current Operating and Project grant process. Additionally, collection management support will be separated out from operations with those institutions who hold collections on behalf of the City (Vancouver Art Gallery, Vancouver Maritime Museum, Vancouver Museum) and establish collection service agreements with levels of support commensurate with those responsibilities.

Summary of Assessment Committee Recommendations

The Assessment Committee noted that 2009 is an unprecedented year for the arts and cultural sector as it adapts to and prepares for an uncertain future within the current global and local economic crisis, while addressing the challenges and opportunities of maintaining or expanding operations during the year of the Olympic and Paralympic Games. The Assessment Committee further noted the importance of stable, even increasing, civic funding in the face of shrinking corporate sponsorship and Provincial arts and culture funding. Staff note that just one year ago, the Assessment Committee was praising a healthy arts and cultural sector, which had been building upon the City's three-year strategic investment in the cultural community, and was actively planning, building endowments, developing significant new initiatives and collaborating in unique ways with community partners.

The proposed recommendations (grant total of \$7,300,100) reflect the Assessment Committee's desired investment in established and emerging organizations that are making great strides in artistic development and organizational growth. The Assessment Committee was encouraged that civic funding could further invest in the creative sector with support towards expanded criteria activities such as residencies and mentorships, publishing activities and conferences.

As is consistent with every review process, not all requests can be supported. The Assessment Committee applied the evaluative criteria carefully; reviewing distinct artistic visions, history of artistic work in the community, organizational capacity and resources, community impact, and the strategic cultural priorities among other criteria. Not all organizations meet the criteria at the same level as their peers and therefore, in a competitive process with finite resources, not all are being recommended for support.

A more detailed package about the Assessment Committee recommendations was distributed to Mayor and Council in mid-March and is also on file at the City Clerk's office.

Expanded Criteria Allocations and Expanded Community Need

On June 26, 2008, Council directed staff to expand program eligibility criteria and consider such professional development opportunities as conferences, residencies and mentorships and further consider such activities as print, web or music publishing and dissemination as eligible activities within program guidelines. These new criteria were included in the 2009 Operating

and Project grant guidelines and considered under the current review. To support this increase in criteria, Council approved \$575,000 of funding, which will be supplemental funding in 2009 and then annual ongoing beginning in 2010.

Requests for funding for initiatives under the new expanded program criteria were considered within the above-noted Assessment Committee process. Based on this process and criteria, 25 groups are being recommended for expanded criteria support for a total of \$174,500. This leaves a reserve of \$400,500 from the \$575,000 New Grants budget to address expanded community need (\$137,000 of which is requested in this report). Further requests will be submitted for other Cultural Services grant programs in 2009.

Please see Appendix A and Table 1 for Expanded Criteria allocation recommendations.

Transfer of Project Applicants into Operating Program

In 2009, 11 eligible organizations requested to be transferred into the Operating program. All requests were considered by the Assessment Committee, but the requests put a strain on the Operating Budget. Council will note that on January 29, 2008 (RTS# 06994), they approved a on-going increase of \$200,000 to the Operating Grants budget which facilitated the permanent transfer of eight project applicants to Operating without any impact on the already limited Operating budget. In this current grants review, however, only four project applicants are being recommended for Operating assistance as follows:

- Crafts Association of BC
- Company Erasga Dance
- Music on Main
- The Only Animal Theatre Society

The other seven project-based companies were not able to be accommodated due to a combination of budget constraints and the Assessment Committee's analysis of their readiness for Operating funding.

Implementation Phase 1 of Cultural Grants and Support Programs Review

On June 26, 2008, Council approved the Culture Plan Implementation Phase One - Review of Grant Programs and directed staff to report back with final program details for a new Cultural Grants Program. Much of the work is underway. In Phase One - 2008/09, work on a new Cultural Grants program design framework was initiated by Staff with the assistance of a Program Design Working Committee. Program criteria was expanded to increase access to a broader cultural sector and the cultural policy framework (new Strategic Cultural Plan vision, priorities and values) was introduced into the program structure. The Cultural Grants budget was also increased to support the program expansion. In addition, Staff initiated research on Cultural Diversity and around multi-year funding for eligible civic cultural grant clients. A new agreement with the Centre for Not-for-Profit Sustainability was established for the delivery of a renewed ArtsPOD (Arts Partners in Organizational Development) program and the NEXT Generation Arts Leadership Pilot program (approved January 20, 2009 RTS # 07766). A review of the Arts Partners in Creative Development (APCD) was also completed.

Pending resources, Phase Two - 2009/10, will see stand-alone programs fully integrated into one Cultural Grants program with different access streams. Consultation around the subject of Cultural Diversity and the articulation and priorities of that research will be incorporated into the overall Cultural Grants program. The launch of CADAC (common application forms), and multi-year funding will be part of the second phase as will the development of a new internal database system to support program changes and to increase efficiency. The development of an outreach strategy will support the expansion of the program mandate to better assist groups in accessing City resources. Further, collection service agreements will be developed with those institutions holding civic collections.

Operational (non-grant) resources have been put on hold in the context of 2009 budget and hiring freezes. Should they become available as per the plans outlined in the Culture Plan Implementation Phase One – Grant Programs, Staff expect to launch the restructured Cultural grant Program in fall 2009 and complete full implementation of the grants review recommendations by 2010.

FINANCIAL IMPLICATIONS

As listed in **Appendix A**, the Assessment Committee is recommending support for 161 Operating, Project and Major Exhibiting Institution Grants for a grand total of \$7,300,100.

The total requested amount and the total recommended amount before consideration of expanded criteria recommendations are indicated in Table 1. Approval of these recommendations totals \$6,988,600 and leaves zero balance in all of the Major Exhibiting Institution, Operating and Project Grant budgets.

On June 26, 2008, Council approved \$575,000 funding for the expanded mandate and expanded community need of cultural grant programs: supplemental funding in 2009 and then annual ongoing beginning in 2010.

The 2009 expanded criteria recommendations total \$174,500 and are also shown in Table 1. This report requests \$174,500 from the \$575,000 New Grants fund leaving a subtotal of \$400,500.

Staff further request a transfer of \$137,000 from the \$400,500 subtotal into Operating (\$106,800) and Projects (\$30,200) to address expanded community need. This transfer will bring the total Operating and Project grant recommendations to \$7,125,600 as outlined in Appendix A and Table 1. Approval of these recommendations will leave \$263,500 remaining in the New Grants Program budget to be allocated later in 2009.




Chart 1: 2009 Cultural Grants Budget

2009 Cultural Grants Information - Operating

Vision

The City of Vancouver, through Cultural Services, aims to develop, enliven, enhance and promote arts, culture and cultural diversity in the City in ways that benefit its citizens, creative community, cultural entrepreneurs, business sector and visitors.

Strategic Cultural Priorities

Five strategic priorities will guide the City's involvement in arts and culture and the creative sector from 2008 - 2018:

Innovation

To recognize Vancouver locally, nationally and internationally as a city of creative innovation, a city of ideas, a city which leverages the unique and authentic voices of the diverse, young and growing cultural community, a city which realizes its full creative potential, a city on the leading edge of cultural activity and development.

Learning

To build on Vancouver's reputation as a city of learning, a city that embeds cultural exchange, cultural curiosity and cultural development as part of lifelong learning – from the very young to the elderly – to ensure that all our citizens have the opportunity to engage with and participate in cultural education throughout their lives and to ensure that every citizen has the opportunity to develop his or her expressive capacities.

Connecting People, Ideas and Community

To take advantage of Vancouver's position as a creative city where connectivity is a hallmark of our cultural system – artists, creative industries, institutions, communities, and neighbourhoods. It is a city engaged in a dynamic conversation, an ongoing dialogue and an exploration of cultural enterprise and opportunity on a regular and consistent basis, connecting people and communities, sharing innovative ideas and programs.

Neighbourhoods

To highlight Vancouver as a city of vibrant creative neighbourhoods by showcasing the talent, enterprise and diversity of our artists, communities and neighbourhoods for our citizens and visitors. To build on the unique identity of our neighbourhoods – engaging local residents, artists and businesses – to ensure that the rich culture, creativity, diversity and innovation of Vancouver lives and is accessible to all.

Valued and Valuable

To ensure that citizens and taxpayers of Vancouver experience in real and concrete ways the value that arts and culture bring to the city and their lives, families and businesses; to promote our growing reputation as an international cultural tourism and entertainment destination known as a place where culture is vibrant and happening and where we value and celebrate the rich multicultural and intercultural expression that is unique to Vancouver.

Program Objectives and Description

This program aims to reflect the City of Vancouver's cultural vision and strategic priorities through support to established organizations that have an ongoing presence in Vancouver and a track record of quality public programming and services. It is designed to support a range of activities and art forms, reflecting a variety of cultural traditions and artistic practices including those of Aboriginal and distinct communities.

General Eligibility Criteria

- An applicant must be registered as a non-profit society in British Columbia and must operate on a yearround basis.
- To qualify for this category, applicants must have received civic Operating or Project grants for at least the past two years. Applicants who do not meet the two-year funding requirement should apply in the Project category.
- The grants are available to organizations engaged in creation, production, presentation, and dissemination activities related to the performing, visual, literary, and media arts, reflecting a variety of traditional and contemporary art forms and practices including those of Aboriginal and distinct communities.
- All applicants must have ongoing paid professional artistic leadership and administration, and must pay principal artistic contributors for their services in accordance with generally accepted professional standards. **Please see Appendix A** for a list of organizations to refer to for these fee standards.
- Applicants must be based and active in Vancouver, and provide programming or services in Vancouver that are open to the public and publicized city-wide.
- Applicants must have a diversified revenue base which includes earned revenue (e.g. memberships, admissions, concessions), funding from other levels of government and support from the private sector (e.g. foundations, fundraising activities, donations, sponsorships).
- Applicants must demonstrate a real need for public sector subsidy and demonstrate that the initiative could not be realized without public sector assistance.

Specific Eligibility Criteria

Additional guidelines apply to service organizations, facilities, and training organizations, which must also meet the general eligibility criteria for Operating grants.

Service Organizations

Organizations whose primary objective is to support the development of one or more art forms through a range of services to professional artists and/or non-profit arts organizations may qualify for Operating assistance. Guilds, trade unions, and professional associations are not eligible. To qualify, an organization must:

- Have designated administrative staff and a high standard of professionalism in its operations.
- Have a membership that is broadly representative of its mandate and that includes artists and/or non-profit organizations based in Vancouver.
- Consistently provide a range of services and resources for members, including a number of the following: research, information, professional development, administrative services, audience development and marketing.

Facilities

Professionally equipped facilities zoned for public assembly and managed by independent non-profit arts and cultural organizations may qualify for Operating funding. Clubs, schools, churches and community centres are ineligible.

To qualify, a facility must:

- Provide a professional level of facility services (e.g. box office, technical).
- Provide a balance of curated arts programming and presentations that involve multiple users, not just one or two resident companies.
- Provide equitable rental access to Vancouver's artists and arts organizations at reasonable rates.
- Primarily serve professional artists and arts and cultural organizations.
- Engage in ongoing umbrella marketing.

Training Organizations

"Stand-alone" arts organizations whose primary mandate is to provide professional quality training for children and youth may be eligible for assistance with the costs of annual public presentations (but not with training costs). The following eligibility criteria apply:

- Only professionally directed or curated public performances and exhibitions (not including competitions) qualify for assistance.
- Work must be performed and/or created by children and youth.
- Activity must take place in a facility regularly used by professional artists in accordance with accepted professional presentation standards.
- Only costs directly related to artistic, presentation and promotion activities are eligible.

Examples of Eligible Activity

- The development of art forms and activities which reflect a variety of cultural traditions and artistic practices which will ideally result in dissemination to a broad public Vancouver audience. This may include exhibitions, performances, and presentations.
- <u>NEW</u>: Public dissemination may also include publications, video, film, radio, audio recordings, or webbased applications.
- The delivery of services or resources (research, information, professional development opportunities, administrative services, audience development, marketing) to Vancouver-based professional artists and/or non-profit arts and cultural organizations (see specific *Service Organizations* criteria).
- The provision of facilities zoned for public assembly and equipped with professional facility services, primarily for professional artists and arts and cultural organizations (see specific *Facilities* criteria).
- <u>NEW</u>: Conferences that offer significant learning, networking and public presentation opportunities for artists, arts and cultural organizations and the general public.
- <u>NEW</u>: Artist residencies for Vancouver-based professional artists working with a non-profit arts or cultural organization (or another organization where residency objectives support the City's cultural vision and strategic priorities). See specific details in Appendix B.
- <u>NEW</u>: Artistic or administrative mentorships for Vancouver-based individuals seeking learning opportunities with qualified professionals. See specific details in Appendix C.

Ineligible Organizations and Activities

- Civic departments or branches (e.g., libraries or community centres).
- Social service, religious or sports organizations.

- Educational institutions (schools, colleges, etc.) do not qualify for cultural grants, but "stand-alone" arts organizations may qualify for support for their professional public presentations (see specific *Training Organizations* criteria).
- Clubs or community centre programs.
- Contests, competitions.
- Scholarships.
- Activity, travel, tours outside of Vancouver (to be revised in 2010).
- Capital projects (refer to Capital Grants program).
- Fundraisers.

Evaluation Criteria

The following criteria will guide the assessment of the grant requests:

NEW: Strategic Cultural Priorities

• How the proposal or the organization's mandate and objectives align and support the City's cultural vision and strategic priorities. This can be addressed in responses to questions throughout the application or specifically in Question 7.

Artistic Merit

Organizational Competence

- Evidence of a clear mandate, competent administration, functional board and an appropriate administrative and governance structure.
- Financial stability and accountability, and evidence of effective short and long-term planning.
- Appropriate outreach and marketing strategies.
- Overall quality and consistency of the applicant's recent activities.
- Demonstrated need for financial assistance from the City.

Community Impact

- Public access to the work, including access by Vancouver's diverse communities.
- Substantial and/or growing public interest and attendance.
- Level of engagement with other arts organizations, artists and community groups, including distinct communities.
- If an organization's work involves collaborative creation with community participants, the strength of the collaborative process and effectiveness of the work in expressing community interests and issues.

Process

The 2009 deadline for Operating grants is December 15, 2008. An Assessment Committee comprised of independent members of the arts and cultural community, along with staff from Cultural Services, review the grant applications. Staff will also conduct interviews with applicants as appropriate. Following the review process, recommendations are made by the Assessment Committee to City Council. A written notice of the recommendation is sent to all applicants, together with information about the Request for Reconsideration process, and notice of the City Council meeting at which the grants will be considered. Under normal circumstances, successful applicants generally receive grant payment approximately four months after the deadline.

Application Requirements

- An organization must complete and submit the appropriate, signed, original application form, plus three additional copies (including the required additional information). The organization must also submit one electronic version of the application.
- Applicants must provide their most recent audited or independently-prepared financial statement within six months of their fiscal year end.

Conditions of Assistance

APPENDIX B

Artist Residencies

To facilitate learning, development and cultural exchange opportunities between professional artists and qualified Host organizations.

- Residency candidates must be Vancouver-based professional artists. The City's definition of a professional artist is one that has:
 - completed his or her basic training (university or college graduation or the equivalent in specialized training, such as two or three years of self-directed study or apprenticeships)
 - o is recognized as such by his or her peers
 - o is committed to devoting time to artistic activity, if financially feasible.
- Applications may be made by a non-profit organization to either:
 - o host a residency or
 - sponsor a Vancouver-based artist to be hosted by another organization (where the residency objectives support the City's cultural vision and strategic priorities).
- Applicants may apply to *host* consecutive residencies, however, priority will be given to new applicants each year. An applicant may *sponsor* more than one artist at a time.
- The residency period shall be a minimum of one month to twelve months.
- Applicants must be able to demonstrate the capacity to host or sponsor a residency and must meet the *General Eligibility* criteria.
- There must be clear artistic development objectives for both the artist and Host organization.
- The residency should provide opportunities for development and creation of the artist's work and if possible, some form of presentation of the artist's work either in progress or at completion.
- There should be some public engagement component of the work during the residency which would offer learning opportunities for the artist, related staff, the arts and cultural community and the general public.
- The residency and work created therein, must be in addition to the regular activities of the Host organization.
- A *Residency Agreement* should be included with the following: Artist Letter of Intent demonstrating the residency objectives and how it will further the development of the artist or artistic practice; Organization Letter of Intent indicating the residency objectives, a work plan (including timelines, activities, milestone dates, etc.), financial obligations, how the project will be evaluated, a contingency plan (addressing potential changes, conflict or non-compliance), and the signatures of all parties involved agreeing to the terms.
- The grant is applicable to artist fees, materials, presentation costs and administration costs born by the Host organization.

APPENDIX C

Mentorships

To facilitate learning opportunities for professional artists and administrators wishing to gain experiential training with qualified professionals.

- Mentorship candidates must be Vancouver-based professionals. The same definition of *professional artists* referred to previously applies to artists and administrators in this category.
- Applications may be made by a non-profit organization to either:
 - o host a mentorship or
 - sponsor a Vancouver-based individual to be mentored by another organization (where the mentorship objectives support the City's cultural vision and strategic priorities).

- A Mentorship Agreement should be included with the following: Mentee's Letter of Intent demonstrating the need for the mentorship and how it will develop the applicant's area of work, a work plan addressing those objectives (including timelines, specific types of training, tasks, mentors), financial obligations of both parties, how the project will be evaluated, a contingency plan (addressing potential changes, conflict or noncompliance), and signatures of all parties involved agreeing to the terms.

Program Objectives and Description

This program aims to reflect the City of Vancouver's cultural vision and priorities through support to new and developing organizations, established organizations that work on a project basis, and for organizations undertaking a special one-time initiative. It is designed to support a range of activities and art forms, reflecting a variety of cultural traditions and artistic practices including those of Aboriginal and distinct communities.

General Eligibility Criteria

- An applicant should be legally registered as a non-profit society in British Columbia and have been active in the City of Vancouver for at least six months as of the application deadline date.
- Project grants are not available to organizations that receive operating assistance from the City in the form of Theatre Rental, Operating or Major Exhibiting Institutions Grants.
- The grants are available to organizations engaged in creation, production, presentation, and dissemination activities related to the performing, visual, literary, and media arts, reflecting a variety of traditional and contemporary art forms and practices including those of Aboriginal and distinct communities.
- All applicants must have paid professional artistic leadership and administration, and must pay principal artistic contributors for their services in accordance with generally accepted professional standards. **Please see Appendix A** for a list of organizations to refer to for these fee standards.
- Applicants must be based and active in Vancouver, and provide programming or services in Vancouver that are open to the public and publicized city-wide.
- Applicants must have a diversified revenue base which includes earned revenue (e.g. memberships, admissions, concessions), funding from other levels of government, and support from the private sector (e.g. foundations, fundraising activities, donations, sponsorships).
- Applicants must demonstrate a real need for public sector subsidy and demonstrate that the initiative could not be realized without public sector assistance.

Specific Eligibility Criteria

Additional guidelines apply to service organizations, facilities, and training organizations, which must also meet the general eligibility criteria for Project grants.

Service Organizations

Organizations whose primary objective is to support the development of one or more art forms through a range of services to professional artists and/or non-profit arts organizations may qualify for assistance. Guilds, trade unions, and professional associations are not eligible. To qualify, an organization must:

- Have designated administrative staff and a high standard of professionalism in its operations.
- Have a membership that is broadly representative of its mandate and that includes artists and/or non-profit organizations based in Vancouver.
- Consistently provide a range of services and resources for members, including a number of the following: research, information, professional development, administrative services, audience development and marketing.

Facilities

Professionally equipped facilities zoned for public assembly and managed by independent non-profit arts and cultural organizations may qualify for funding. Clubs, schools, churches and community centres are ineligible.

To qualify, a facility must:

- Provide a professional level of facility services (e.g. box office, technical).
- Provide a balance of curated arts programming and presentations that involve multiple users, not just one or two resident companies.
- Provide equitable rental access to Vancouver's artists and arts organizations at reasonable rates.
- Primarily serve professional artists and arts and cultural organizations.
- Engage in ongoing umbrella marketing.

Training Organizations

"Stand-alone" arts organizations whose primary mandate is to provide professional quality training for children and youth may be eligible for assistance with the costs of annual public presentations (but not with training costs). The following eligibility criteria apply:

- Only professionally directed or curated public performances and exhibitions (not including competitions) qualify for assistance.
- Work must be performed and/or created by children and youth.
- Activity must take place in a facility regularly used by professional artists in accordance with accepted professional presentation standards.
- Only costs directly related to artistic, presentation and promotion activities are eligible.

Artist and Communities Projects

Arts organizations can apply for Project grants to assist with the costs of partnerships between professional artists and community members engaged in a collaborative creative process that will result in the public presentation of art expressing community interests and issues. In addition to the general evaluation criteria for Project grants, this type of proposal will be evaluated for:

- Clear articulation of the artistic and community interests/issues the project will address.
- Strength of the proposed collaborative process between artist(s) and community participants.
- Artistic merit of the artist(s)' previous collaborative work.
- Overall merit of the project as a vehicle for collective experience and public expression.

Examples of Eligible Activity

- The development of art forms and activities which reflect a variety of cultural traditions and artistic practices which will ideally result in dissemination to a broad public Vancouver audience. This may include exhibitions, performances, and presentations.
- <u>NEW</u>: Public dissemination may also include publications, video, film, radio, audio recordings, or webbased applications.
- The delivery of services or resources (research, information, professional development opportunities, administrative services, audience development, marketing) to Vancouver-based professional artists and/or non-profit arts and cultural organizations (see specific *Service Organizations* criteria).
- The provision of facilities zoned for public assembly and equipped with professional facility services, primarily for professional artists and arts and cultural organizations (see specific *Facilities Organizations* criteria).
- Collaborative and creative initiatives between professional artists and community members (see specific *Artist and Communities Projects* criteria).

- <u>NEW</u>: Conferences that offer significant learning, networking and public presentation opportunities for artists, arts and cultural organizations and the general public.
- <u>NEW</u>: Artist residencies for Vancouver-based professional artists working with a non-profit arts or cultural organization (or another organization where residency objectives support the City's cultural vision and strategic priorities). See specific details in Appendix B.
- <u>NEW</u>: Artistic or administrative mentorships for Vancouver-based individuals seeking learning opportunities with qualified professionals. See specific details in Appendix C.

Ineligible Organizations and Activities

- Civic departments or branches (e.g., libraries or community centres).
- Social service, religious or sports organizations.
- Educational institutions (schools, colleges, etc.) do not qualify for cultural grants, but "stand-alone" arts organizations may qualify for support for their professional public presentations (see specific *Training Organizations* criteria).
- Clubs or community centre programs.

Please note that organizations that have not previously applied to this program are expected to establish their eligibility with Cultural Services staff at least one month prior to submitting an application.

- Applicants must provide their most recent audited or independently-prepared financial statement within six months of their fiscal year-end.
- Under normal circumstances, the term of a grant is for one year and only one Project grant application per City fiscal year can be submitted (January to December). Previously funded projects must be completed before a new application can be accepted.
