ADOPTION OF MINUTES

The Minutes of the Standing Committee on City Services and Budgets meeting of April 9, 2009, were adopted.

**1. 2008 City of Vancouver Annual Financial Report
April 8, 2009**

The Committee also had before it the Annual Financial Report 2008 (*limited distribution - on file*).

The Director of Financial Services, along with the Auditor from KPMG, provided an overview of the report and responded to questions. The City Manager and the General Manager of Business Planning and Services also provided comments.

Councillor Anton rose on a point of order in regard to the amount of time allowed for speaking. The Chair advised the Procedure By-law limits speaking times in debate.

Councillor Anton challenged the decision of the Chair.

The Chair then put the question:

Shall the decision of the Chair be sustained?

(The Mayor absent for the vote)*

A two-thirds majority of those present is required to overrule the ruling of the Chair, therefore the ruling of the Chair was sustained.

**2. 2009 Property Taxation: Distribution of Property Tax Levy
April 14, 2009**

The Manager, Financial Policy and Projects, and the General Manager of Business Planning and Services responded to questions.

The Committee heard from two speakers in general support of staff's recommendations, with concerns raised that the shift does not do enough.

MOVED by Councillor Woodsworth
THAT the Committee recommend to Council

THAT the City of Vancouver instruct the Director of Finance to defer the tax shift of 1% from non-residential to residential property for one year.

THAT Council instruct the Director of Finance to calculate the 2009 general purpose tax rates incorporating a one percent shift of tax levies from non-residential properties (Classes 2, 4 5 and 6) to residential properties (Classes 1, 8 and 9) to achieve a distribution of approximately 50% residential and 50% non-residential.

3. Bottled Water in Civic Facilities April 7, 2009

The Assistant City Engineer, Water and Sewers, provided an overview of the report.

The Committee heard from three speakers, two in support of staff's recommendations, and one in opposition.

MOVED by Councillor Stevenson
THAT the Committee recommend to Council

- A. THAT the City of Vancouver adopt Metro Vancouver's Tap Water Declaration and immediately eliminate the Civic purchase of single serving sized bottled water for Staff and delegation consumption, and substitute with tap water options.
- B. THAT staff incorporate access to municipal drinking water into designs for new civic facilities and those scheduled for renovation, such as City Hall and Crossroads at an estimated cost of \$15,000. Source of funds to be the 2009 Facilities Capital Budget, subject to approval of the 2009 Basic Capital Budget.
- C. THAT staff pilot options for year-round access to municipal drinking water in outdoor public spaces at an estimated cost of \$35,000. Source of funds to be a reallocation of \$5,000 from the 2009 Waterworks Operating budget and \$30,000 from the 2009 Waterworks Capital Budget, subject to approval of the 2009 Basic Capital Budget.

- D. THAT Council forward A, B and C above to the Board of Parks and Recreation, PNE Board, Library Board, and Police Board for their consideration.
 - E. THAT staff report back on options that will promote access to municipal drinking water in all new buildings.
 - F. THAT staff prepare an inventory of existing public access options (e.g. fountains) to municipal drinking water supplies across the City and develop a plan that prioritizes the installation and activation of public access options taking into account the unique needs of each neighbourhood; and
- FURTHER THAT staff also identify venues where less healthy beverages will be sold in place of bottled water and make recommendations on strategies to ensure drinking water remains available in those venues.

THAT the City of Vancouver mount a "use tap water" education campaign to explain why we are encouraging people to use our tap water rather than bottled water.
