## **BUSINESS LICENSE HEARING MINUTES**

JUNE 10, 2009

A Business License Hearing of the Council of the City of Vancouver was held on Wednesday, June 10, 2009, at 9:30 a.m., in the Council Chamber, Third Floor, City Hall, to determine whether or not the 2009 City of Vancouver business license granted to Wendy Mei Wah Wong and Ching Ming Wu, doing business as The Only Fish and Oyster Café for business premises located at 20 East Hastings Street, Vancouver, British Columbia, should be suspended or revoked.

Tom Zworski, Litigator, Legal Services, was present on behalf of the City of Vancouver. Wendy Mei Wah Wong and Ching Ming Wu (the "Licensees") were present and represented themselves with the aid of Nicole Lee, a registered Cantonese interpreter.

Mr. Zworski advised that this matter had been referred to City Council by the Chief License Inspector pursuant to Section 278 of the *Vancouver Charter* with a recommendation that the Restaurant Class I license be revoked. He noted Council has broad discretion to refuse, revoke, or suspend a license, as set out in Section 275 of the *Vancouver Charter* and further that Section 277 delegates Council's powers to the Panel. Mr. Zworski also advised that the issue for the Panel to consider is the management of the business, the impact on the community and whether the business is likely to be managed properly in the future.

Mr. Zworski referred the Panel to evidence before it as set out in documents which were considered by the Chief License Inspector in referring the license to Council, which set out the allegations that the licensees have failed to properly manage the premises by:

- (a) failing to maintain control of the Premises;
- (b) causing a drain on police and City resources;
- (c) failing to comply with the provisions of provincial and municipal legislation which apply to the Premises, including the Food Premises Regulation to the *Health Act*, RSBC 1996 c. 179;
- (d) permitting or facilitating trafficking of illicit drugs on the Premises;
- (e) carrying on business to the detriment of public order and safety in the neighbourhood.

In support of the allegations set out in the above-noted reports and evidence, Mr. Zworski called the following witness:

The Licensees, with the assistance of a Cantonese interpreter, were given an opportunity to cross examine witnesses and also provided comments following the witnesses' testimony.

Following the testimony and questions to witnesses, a recess was called at 11:02 a.m. The Hearing reconvened at 11:08 a.m. will all Panel members and representatives present.

There were no witnesses called by the Licensees.

The Panel members and Mr. Zworski also asked questions of the Licensees.

Ms. Wong and Mr. Wu submitted they had been in business for over ten years and never had a problem with the Health Department. Mr. Wu also submitted that the police made a mistake, and if there is any complaint about sanitation, the Licensees could address it satisfactorily. Ms. Wong and Mr. Wu further advised they had no knowledge of drugs and that the drugs, jacket, and money from a waist pouch found on the premises belonged to someone else. They also noted the scale had always been in the restaurant. Mr. Wu expressed concern that if they lose their business, it would be place them in a difficult position trying to find jobs at their age.

In closing, Mr. Zworski submitted the evidence is clear regarding the significant illegal drug activity and state of uncleanliness at the restaurant. He further noted these are related and the potential for food contamination exists in the small premises. He also submitted the Licensees did not take appropriate care.

The Licensees' comment was they wanted the license.

## PANEL MEMBERS DISCUSSION

Prior to making a decision on this matter, the Panel noted the current owners are not running the business in an appropriate way, and allowed the premises to be used for illegal drug activity, including drugs being cut up on site. The Panel questioned credibility of the idea that items found by police were left by restaurant patrons. The Panel further noted the neighbourhood needs safe restaurants and the importance of protecting the public.

## MOVED by Councillor Woodsworth

THAT the 2009 City of Vancouver Business License issued to Wendy Mei Wah Wong and Ching Ming Wu doing business as The Only Fish and Oyster Café (the "Licensees"), for business premises located at 20 East Hastings Street, Vancouver, British Columbia (the "Premises"), be revoked because the Licensees have failed to properly manage the Premises by:

- (a) failing to maintain control of the Premises;
- (b) causing a drain on police and City resources;
- (c) failing to comply with the provisions of provincial and municipal legislation which apply to the Premises, including the Food Premises Regulation to the *Health Act*, RSBC 1996 c. 179;
- (d) permitting or facilitating trafficking of illicit drugs on the Premises;
- (e) carrying on business to the detriment of public order and safety in the neighbourhood.

CARRIED UNANIMOUSLY

The Business License Hearing Panel adjourned at 11:47 a.m.
