**1. Single Room Accommodation (SRA) By-law Status Update and Amendments
October 21, 2009**

Vancouver City Council, at its Regular Council meeting on Tuesday, November 17, 2009, received an Administrative Report dated October 21, 2009, entitled "Single Room Accommodation (SRA) By-law Status Update and Amendments". Subsequently on December 15, 2009, a Special Council meeting was held in order to hear from members of the public on the proposed SRA By-law Amendments.

The SRA By-law Coordinator provided an overview of the "SRA By-law Status Update and Amendments", and along with the Assistant Director of Housing Policy, and the Chief License Inspector responded to questions.

Council heard from 10 speakers, 9 of whom expressed opposition regarding the SRA By-law Amendments. The major area of concern included allowing rentals of up to 10% of the designated rooms, on a less than monthly basis.

MOVED by Councillor Stevenson

THAT Council approve the amendments to the Single Room Accommodation By-law, generally in accordance with Appendix A of the Administrative Report entitled "Single Room Accommodation (SRA) By-law Status Update and Amendments" dated October 21, 2009, including:

- a) Prohibiting the nightly rental of up to 10% of designated rooms, and allowing rentals of up to 10% of the designated rooms, on a less than monthly basis, only as permitted by the Chief License Inspector in case of emergency;
- b) Removing the exemption for commercial hotels from the by-law requirements;
- c) Allowing for accessory or amenity space that is not subject to conversion requirements;
- d) Allowing an owner to fulfill the conditions of approval for an SRA Conversion/Demolition Permit within the later of 12 months after receiving notice of those conditions and the date the development permit lapses;
- e) Removing certain properties from Schedule A as a result of approval of an exemption or issuance of an SRA Conversion/Demolition Permit or because the by-law does not apply to them;
- f) Recording changes in civic addresses in Schedule A to the By-law, generally in accordance with Appendix A of the Administrative Report entitled "Single Room Accommodation (SRA) By-law Status Update and Amendments" dated October 21, 2009; and

- g) Improving the administration of and promoting compliance with the By-law, generally in accordance with Appendix A of the Administrative Report entitled "Single Room Accommodation (SRA) By-law Status Update and Amendments" dated October 21, 2009; and

FURTHER THAT Council authorize the Director of Legal Services to prepare a by-law amending the Single Room Accommodation By-law, generally in accordance with Appendix A of the Administrative Report entitled "Single Room Accommodation (SRA) By-law Status Update and Amendments" dated October 21, 2009.
