 Granville Mall By-Law and Administration of Flexible Sidewalks on Granville Street for Sidewalk Patios November 20, 2009

Engineering Services staff responded to questions.

MOVED by Councillor Woodsworth
THAT the Committee recommend to Council

- A. THAT Granville Mall By-law No. 9272 be repealed and a new Granville Mall By-law, generally as set out in Appendix A of the Adminsitrative Report dated November 20, 2009, entitled *Granville Mall By-Law and Administration of Flexible Sidewalks on Granville Street for Sidewalk Patios*, be enacted to reinstate the transportation function of Granville Mall to pre-Canada Line construction operation and extend access to private vehicles through a permit system.
- B. THAT the Director of Legal Services be requested to prepare the new Granville Mall By-law generally as set out in Appendix A of the Adminsitrative Report dated November 20, 2009, entitled *Granville Mall By-Law and Administration of Flexible Sidewalks on Granville Street for Sidewalk Patios.*
- C. THAT Council receive for information the project plan and schedule to develop a program to deliver mechanisms needed to appropriately animate and program a portion of Granville Street in and around the Civic Event Space on an annual basis.
- D. THAT sidewalk patios be encouraged on Granville Street downtown, in accordance with principles of the Great Street design, by allowing the removal of up to 12 sidewalk parking spaces (equivalent to two spaces per block per side) to accommodate sidewalk patios and encourage street animation which translates into a potential decrease in revenue of up to \$53,600 should there be sufficient uptake.

## 2. Reserved On-street Parking Spaces and Residential Parking Permits for Car-Sharing Vehicles January 5, 2010

- B. THAT Council approve the issuance of residential parking permits to car-share vehicles, with rates and conditions as outlined in the Administrative Report dated January 5, 2010, entitled *Reserved Onstreet parking spaces and Residential Parking Permits for Car-Sharing Vehicles.*
- C. THAT the Director of Legal Services be instructed to prepare the necessary amendments to the Street and Traffic By-law and Parking By-law generally as set out in Appendix A of the Administrative Report dated January 5, 2010, entitled *Reserved On-street parking spaces and Residential Parking Permits for Car-Sharing Vehicles.*
