Item 4 - Vancouver Athletic Commission By-law

Professional Wrestling Fees

At the April 20, 2010 meeting of the Vancouver Athletic Commission, the Commission dealt with the subject of professional wrestling fees and approved the following motion unanimously:

THAT the Vancouver Athletic Commission recommend to Council

THAT Schedule A of the "Vancouver Athletic Commission By-law amending by-law re appointments and related matters", dated April 6, 2010, be amended to reflect the following:

- That the Promoter's License Fee for professional wrestling events be \$300;
- That the Event Permit Fee for professional wrestling events with greater than 500 attendees be \$150 per event, plus 30 cents per occupied seat; and
- That professional wrestling events with less than 500 attendees be exempt from the event fee and seat tax.

The Commission felt it was important to distinguish the fees for professional wrestling from other events since professional wrestling events don't require nearly the same level of administrative support and review by the Commission. The Commission also feels that the promoter's fee should be standardized for professional wrestling to the same level as for other events.

Accordingly, the Vancouver Athletic Commission recommends that Council approve the revised Schedule A to the amending by-law to the Vancouver Athletic Commission By-law (as attached).
