RECOMMENDATION

THAT Council authorize Councillor Cadman, as a member of the Executive Board, to attend the International Association of Peace Messenger Cities General Assembly of the IAPMC 2009 being held in Sarajevo from October 25 to November 1, 2009, at an estimated cost of \$2,232.00 to be funded from the Councillors 2009 Travel Budget.

CITY MANAGER'S COMMENTS

The City Manager submits this report for Council's consideration.

COUNCIL POLICY

The City's Mayor and Council Members' Expenses By-law No 8904 requires that a Council member wishing to engage in an activity that is representing the city, engaging in city business or attending a course, meeting or convention must request Council prior approval. If Council approval is granted, the council member may claim reimbursement for expenses incurred in accordance with the By-law.

PURPOSE

The purpose of this report is to seek Council's approval for Councillor Cadman to attend the International Association of Peace Messenger Cities General Assembly of the IAPMC taking place in Sarajevo from October 25 - November 1, 2009.

BACKGROUND

At the 20th Meeting of Executive Board /IAMPC/ held in District of Abidjan in April this year, the City of Sarajevo was entrusted to host the 22nd General Assembly of the International Association of Peace Messenger Cities. Topics of the assembly will be the following:

- 1. Cultural, religious and ethnic coexistence in multiethnic environment
- 2. Post conflict construction of peace and establishment of trust
- 3. Key factors of economic progress of cities as basis for reinforcement of peace
- 4. Institutional frameworks for development of multiethnicity and nurturing of religious and traditional values of ethnic groups in multiethnic environments.
