BUSINESS LICENSE HEARING MINUTES

MAY 19, JULY 21, SEPTEMBER 22, 2009

A Business License Hearing of the Council of the City of Vancouver was held on Tuesday, May 19, 2009, at 9:40 am, in the Council Chamber, Third Floor, City Hall, to determine whether or not 2009 City of Vancouver business licenses should be granted to Avalon Sunsplash Ltd. (the "Licensee"), for a Retail Dealer - Food (Convenience Store) for business premises located at 316 West Hastings Street and for a Retail Dealer and Administrative Offices in premises located at 303 and 307 West Hastings Street, Vancouver, British Columbia. Subsequently, the meeting was recessed and reconvened in the Council Chamber on Tuesday, July 21, 2009 at 9:30 am, and on September 22, 2009 at 9:30 am. The minutes are consolidated for ease of reference.

Catherine Kinahan, Assistant Director, Enforcement and Prosecutions, Legal Services was present on behalf of the City of Vancouver. Marc Emery (the "licensee") was present and represented by Kirk I. Tousaw, Barrister.

Ms. Kinahan advised that this matter had been referred to City Council at the request of the License Applicant, upon the refusal by the Chief License Inspector of the City of Vancouver to issue business licenses to the License Applicant pursuant to section 4(2) of the *License By-law* of the City of Vancouver. Ms. Kinahan also noted, as set out in Section 275 of the *Vancouver Charter*, Council has broad discretion to refuse, revoke, or suspend a license.

Ms. Kinahan referred the Panel to evidence before it as set out in documents which were considered by the Chief License Inspector in refusing to issue the business Licenses pursuant to section 4(2) of the *License By-law*, letters from the Chief License Inspector and the evidence of witnesses, which set out the allegations that:

- a) the sole director of the License Applicant has been convicted of an offence within the preceding five years under a Statute of Canada, to wit, trafficking in a scheduled substance, in contravention of the Controlled Drugs and Substances Act, on August 19, 2004, in Saskatoon, Saskatchewan;
- (b) the Chief License Inspector is of the opinion that the conviction is related to the Business because the sole director of the License Applicant has a history of encouraging, facilitating, permitting and promoting cultivation, possession and consumption of illicit drugs on and from licensed premises in Vancouver;
- (c) the sole director of the License Applicant has been convicted of other offences as the result of his unlawful activities on licensed premises in Vancouver:
- (d) the sole director of the License Applicant has a history of encouraging, facilitating, permitting and promoting cultivation, possession and consumption of illicit drugs on and from unlicensed premises in Vancouver;
- (e) the License Applicant operates a vapour lounge on the premises at 307 West Hastings and encourages, facilitates and permits consumption of illicit drugs, which attracts criminal activity, including drug trafficking, to the neighborhood, and causes a drain on police and City resources;
- (f) the License Applicant and the sole director of the License Applicant have a history of failing to comply with City by-laws in regards to the business premises and other premises; and
- (g) the sole director of the License Applicant is presently bound by a recognizance which prohibits him from attending the Premises at 316 West Hastings Street.

On July 21, 2009, Ms. Kinahan advised the appeals for refusal of business licenses for the retail business at 316 West Hastings Street and the Administrative Offices at 303 West Hastings Street were withdrawn by the licensee, leaving one appeal before the Panel, in regard to the retail business at 307 West Hastings Street.

Mr. Tousaw confirmed the businesses at 303 and 316 West Hastings had been closed due to the uncertainty in meeting the City's requirements and that new licenses would be sought once the issues were rectified through the upcoming business development phase.

Mr. Tousaw and the Panel also directed questions to the witness.

On September 22, 2009, Mr. Tousaw advised that on September 28, 2009, Mr. Emery is surrendering himself to the authorities of the BC Supreme Court in order to serve a five year prison term in the USA. In response to questions from the Panel, Mr. Tousaw advised directorship of the business would subsequently be transferred to Jodi Emery.

In response to questions from the Panel, Barb Windsor, Chief License Inspector, advised that approval of transferring the business license would be subject to a police background check of Ms. Emery, and that this is standard practice in order to determine how the business would be operated under the new directorship. After investigation and a meeting with the applicant it would be determined whether to grant the license or refer the matter to Council.

Following the recess, Mr. Tousaw advised Avalon Sunsplash had agreed to withdraw the license application for the business at 307 West Hastings Street until directorship transfer and corporate structure transactions were complete, upon which time a new business license application will be submitted.
