Proposed Amendment to Subdivision By-law Number 5208 - Reclassification of 3583 and 3593 West 39th Avenue May 20, 2010

Staff from Subdivision and Strata provided an overview of the report and responded to questions.

The Committee heard from one speaker, who spoke in support of the reclassification of 3583 and 3593 West 39th Avenue.

THAT the Committee recommend to Council

- A. THAT Council approve the application to reclassify the properties at 3583 and 3593 West 39th Avenue from Category C to Category B of Schedule A, Table 1, of Subdivision By-law Number 5208.
- B. THAT the Director of Legal Services be instructed to prepare the necessary by-law for enactment.

Proposed Amendment to Subdivision By-law Number 5028 - Reclassification of 4416 West 11th Avenue May 21, 2010

THAT Council refuse the application to reclassify the property at 4416 West 11th Avenue from Category B to Category A of Schedule A, Table 1, of Subdivision By-law Number 5208.

4. Amendment to City of Vancouver Health Bylaw May 28, 2010

Staff from Parks and Recreation provided an overview of the report and responded to questions.

The Committee heard from three speakers who spoke in support of the recommendations.

THAT the Committee recommend to Council

- A. THAT Council delegate the authority to regulate smoking in parks for the care, promotion and protection of the health of persons in parks, to the Board of Parks and Recreation.
- B. THAT the Director of Legal Services be instructed to prepare and bring forward the necessary changes to the Health Bylaw as generally described in Appendix A, of the Administrative Report dated May 28, 2010, entitled "Amendment to City of Vancouver Health Bylaw", which in the opinion of the Director of Legal Services, are necessary to carry out the direction of Council.

 Housing Agreement for 5498 Fraser Street (Related to the Replacement of Rental Units at 798 East 29th Avenue) May 25, 2010

MOVED by Councillor Anton THAT the Committee recommend to Council

- A. That Council approve entering into a Housing Agreement with 709 Homes Ltd. (Ledingham McAllister), the owners of 5498 Fraser Street (PID 014-288-591; Lot 6 of Block 6, DL 667, Plan 1797), pursuant to the Rental Housing Stock Official Development Plan, to secure 48 rental units, for 60 years or the life of the building, whichever is greater, on the terms and conditions set out in this report and subject to the satisfaction of the Director of Legal Services and Managing Director of Social Development.
- B. THAT the Director of Legal Services be instructed to bring forward a by-law to enter into the Housing Agreement.
- C. THAT no legal rights or obligations will arise or be created from the approval of A and B above, until the Housing Agreement as authorized by by-law is fully executed on terms and conditions to the satisfaction of the City's Director of Legal Services.

6. Heritage Incentives Policy for Landscape Resources May 25, 2010

Heritage Planning staff provided an overview of the report and along with the Director of Planning responded to questions.

The Committee heard from eight speakers, two in support of the recommendation and six in opposition, specifically with reference to the property at 1245 Harwood Street.

THAT the Committee recommend to Council

THAT historic landscape resources in the City are important and worthy of retention and protection however, Council affirms that bonus incentives are not supported for landscape resources that cannot be wholly protected through legal designation.

7. SRA Exemption & Conversion Permit for 577 Richards (St. Clair Hotel) May 25, 2010

THAT the Committee recommend to Council

- A. THAT Council approve an exemption from the Single Room Accommodation Bylaw for 15 rooms at 577 Richards Street (St. Clair Hotel).
- B. THAT Council approve an SRA Conversion Permit to convert the remaining 21 rooms at 577 Richards Street (St. Clair Hotel) subject to the payment of \$30,000 (\$15,000 x 2 rooms).

8. SRA Exemption - 1038 Main Street (Ivanhoe) May 25, 2010

Community Services staff responded to questions.

THAT Council grant an exemption from the Single Room Accommodation By-law for 6 rooms (#500, #501, #502, #504, #505, #506) at 1038 Main Street (Ivanhoe Hotel).

9. Office of Public Consultation

Vancouver City Council, at its meeting on June 8, 2010, referred the following motion to the Standing Committee on Planning and Environment meeting on June 10, 2010, in order to hear from speakers.

WHEREAS:

- 1. Vancouver City Council wants to encourage citizens to participate more actively in civic life, as well as in the development and management of municipal affairs.
- 2. Council unanimously passed a resolution on July 28, 2009 that noted "the City of Vancouver is committed to bringing the community into City Hall by engaging citizens, and soliciting their ideas, input and creative energy".
- 3. City Council should more formally recognize the power of citizens to influence the decisions of City Hall.

- 4. The City of Vancouver's public consultation processes are managed by a variety of city departments, agencies and boards.
- 5. These consultation processes are often delivered using different goals, budget levels, tools and methodologies.
- 6. The efficacy of some of these consultation processes have been put into question by several residents' groups in recent years (for example, in the West End and by groups concerned about the budget consultation).
- 7. Both COPE and Vision Vancouver candidates and parties said they strongly supported establishing an independent office of public consultation when surveyed by the Think City Society in the fall of 2008.

THEREFORE BE IT RESOLVED

THAT staff report back on the feasibility of the creation of an independent office of public consultation; and

BE IT FURTHER RESOLVED

THAT the staff report will include:

- (a) the potential savings or cost of the office (and the possibility of consolidating public consultation and engagement in one department to create a cost-neutral office);
- (b) examination of how other cities handle public consultation processes that involve multiple departments, agencies and boards; and
- (c) examination of how other cities handle public consultation processes to ensure that processes are transparent, credible and effective.

THAT the Committee recommend to Council

WHEREAS:

- 1. Vancouver City Council wants to encourage citizens to participate more actively in civic life, as well as provide opportunities for citizens to meaningfully engaged in municipal affairs.
- 2. City Council's commitment to this principle has been demonstrated over the past 18 months by a number of initiatives including:
 - reinstating citizen advisory committees cut by the previous council;
 - initiating a globally recognized initiative on open data;
 - expanding and improving community consultation on a number of policy areas such as the annual operating budget; and
 - introducing engagement tools such as Facebook, Twitter, Pecha Kucha and other modern processes for increasing opportunities for a broader range of citizens.
- 3. City Council strives to constantly improve both citizen consultation and citizen engagement to ensure citizens have a strong voice.
- 4. Public consultation processes and citizen engagement is conducted across a variety of city departments, agencies and boards and these consultation processes may unnecessarily vary in tools and methodology.
- 5. Staff have recognized this deficiency and have been working for a number of months to pilot initiatives aimed at developing a coordinated Office of Citizen Engagement under the working title of "VOICE".
- 6. A majority of City Councillors broadly support this work evidenced by a 2008 election platform commitment to creating a Citizen Engagement Unit.

THEREFORE BE IT RESOLVED

THAT staff provide a status report to Council no later than September 2010 on their ongoing work to improve the effectiveness, efficiency and coherence of community engagement on policy and planning. As part of this status report, staff are requested to provide Council with background information on the research they have done to inform their ongoing work.

CARRIED UNANIMOUSLY (Councillors Anton and Deal and the Mayor absent for the vote)
