 1502 Duranleau Street - Vancouver TheatreSports League Liquor Primary Liquor Licence Application (Liquor Establishment Class 3 -Live Theatre) July 6, 2010

THAT the Committee recommend to Council

THAT Council, having considered the opinions of local area residents and business operators as determined by neighbourhood notifications, noise impacts and relevant Council policy as outlined in the Administrative Report dated July 6, 2010, entitled "1502 Duranleau Street - Vancouver TheatreSports League, Liquor Primary Liquor Licence Application (Liquor Establishment Class 3 - Live Theatre)", endorse the request by Vancouver TheatreSports League for a 264 seat with 20 seat outdoor patio Liquor Primary liquor licence (Liquor Establishment Class 3) at 1502 Duranleau Street subject to:

- i. Signing a Good Neighbour Agreement with the City prior to business licence issuance;
- ii. A Time-limited Development Permit for the patio;
- iii. The patio ceasing all liquor service and vacated by 11 pm;
- iv. No entertainment or music permitted on the patio;
- v. The use of the liquor licence limited to live theatre events only; and
- vi. Standard Hours of operation for the first three to six months are limited to 11 am to 12 am, weekdays and 11 am to 1 am on weekends; after which time the Extended Hours of operation may be considered which are limited to 9 am to 1 am, weekdays and 9 am to 2 am on weekends.

# 4. Green Building Policy for Rezonings Update July 7, 2010

Sustainability Group staff provided an overview of the report and responded to questions.

The Committee heard from one speaker in support of the recommendations.

THAT the Committee recommend to Council

- A. THAT Council adopt the Amended Green Building Policy for Rezonings as outlined in Appendix A of the Policy Report dated dated July 7, 2010, entitled "Green Building Policy for Rezonings Update", to replace all previous iterations of the Green Building Policy for Rezonings.
- B. THAT staff report back to Council with the results of the first five rezonings that have been required to certify under this policy to ensure that the Green Buildings Policy for Rezonings is delivering LEED™ or Built Green™ Gold Certified Buildings and that the process for compliance is achieving Council priorities.
- C. THAT staff and industry meet annually at a minimum to ensure that "Green Building" market transformation and continued "Green Building" design innovation which are the primary goals of the Green Buildings Policy for Rezonings are being supported by the implementation of this initiative.

#### 5. Public Community Development Events

Vancouver City Council, at its meeting on July 20, 2010, referred this matter to the Standing Committee on Planning and Environment meeting on July 22, 2010, in order to hear from speakers.

WHEREAS on June 28, 2010, a Marpole Neighbourhood Meeting was held to discuss a development proposal located at the Marine Drive Canada Line Station and other possible development proposals;

WHEREAS over eighty residents attended the meeting along with Councillors Deal, Louie, Meggs, Reimer and Woodsworth;

WHEREAS numerous questions and concerns were raised along with a significant amount of inaccurate information;

WHEREAS the proposal from the developer of the Cambie and Marine site has substantially and substantively changed over the course of the public consultation process.

THEREFORE BE IT RESOLVED THAT staff be directed, in the context of development proposals located at Marine Drive and Cambie Street, and at West 70<sup>th</sup> Avenue and Granville Street, to hold a public event in each of these two areas in September 2010, to ensure the public has an improved opportunity to understand and comment on these significant proposals in their community.
