- 1. The City of Vancouver is the owner of all the streets and lanes lying within the limits of the City of Vancouver;
- 2. The owners of Lot C Block 3 South East ¼ of Section 47 Town of Hastings Suburban Lands Plan 3313 ("Lot C") have made application to purchase the abutting 17.5 foot wide portion of lane west of Atlin Street, north from 29th Avenue;
- 3. The said portion of lane to be closed was dedicated by the deposit of Plan 12233 in 1966;
- 4. The said portion of lane to be closed is no longer required for municipal purposes;
- 5. The said portion of lane to be closed will be conveyed to the owners of Lot C and consolidated with Lot C to form a single parcel.

THEREFORE BE IT RESOLVED THAT all that portion of lane west of Atlin Street, north from 29th Avenue, the same as shown in heavy outline on the Reference Plan prepared by David Lyon, B.C.L.S., completed and checked on the 16th day of September, 2010, and marginally noted "File: 10-329.RE1" a copy of which is attached hereto, be closed, stopped-up and conveyed to the owners of abutting Lot C; and

BE IT FURTHER RESOLVED THAT the said portion of lane to be closed is to be consolidated with said Lot C to form a single parcel, to the satisfaction of the Director of Legal Services.


