1. Extensions for Infrastructure Projects under Canada's Economic Action Plan January 6, 2011

Staff from the Southeast False Creek and Olympic Village Project Office provided an update.

THAT Council approve the following resolutions which request extensions for the specific federal/provincial infrastructure projects noted therein and confirm the City's commitment to complete these projects within the revised terms of the relevant infrastructure stimulus programs under the Economic Action Plan:

RESOLUTION SEEKING EXTENSION OF FEDERAL PROJECTS

WHEREAS the federal government will make a one-time extension of the deadline for funding of projects under the Infrastructure Stimulus Fund, the Building Canada Fund - Communities Top-Up and the Recreational Infrastructure Canada (RinC) from March 31, 2011 to October 31, 2011;

AND WHEREAS all funding from the Government of Canada will cease after October 31, 2011;

AND WHEREAS the City of Vancouver has asked the Government of Canada for an extension to federal funding to October 31, 2011 for the following projects:

RESOLUTION SEEKING EXTENSION OF FEDERAL - PROVINCIAL PROJECTS

WHEREAS the federal and provincial governments will make a one-time extension of the deadline for funding of projects under the Infrastructure Stimulus Fund from March 31, 2011 to October 31, 2011;

AND WHEREAS all funding from the Government of Canada and the Province will cease after October 31, 2011;

AND WHEREAS the City of Vancouver has asked the provincial government for an extension to October 31, 2011 for the following project:

Project number: 14853

Project title: Glen Drive Development

Total eligible cost: \$30,300,000 Federal contribution: \$10,000,000 Provincial contribution: \$10,000,000

THEREFORE BE IT RESOLVED THAT the City of Vancouver attests that it will continue to contribute its share of the required funding for the aforementioned project;

AND BE IT FURTHER RESOLVED THAT actual claims for all eligible costs incurred by March 31, 2011, for the aforementioned project(s) must be and will be submitted no later than April 15, 2011 to the Province;

AND BE IT FURTHER RESOLVED THAT the City of Vancouver will ensure that the project will be completed.
