1. Proposed Amendment to Subdivision By-law Number 5208 - Reclassification of 5606, 5626, 5656 and 5686 Alma Street December 23, 2010

THAT the Committee recommend to Council

- A. THAT Council approve the application to reclassify properties at 5606, 5626, 5656 and 5686 Alma Street from Category D to Category A of Schedule A, Table 1, of Subdivision By-law Number 5208.
- B. THAT the Director of Legal Services be instructed to prepare the necessary bylaw to amend the Subdivision By-law implementing the required change, contained in A above.

THAT Council, having considered the opinion of area residents and business operators of the community as determined by neighbourhood notification, the proximity of residential developments, noise impacts and relevant city policy as outlined in the Administrative Report dated December 16, 2010, entitled "216 Carrall Street - Blarney Stone Pub Inc. (The Blarney Stone), Liquor Primary Liquor Licence Application for an Increase in Person Capacity (Liquor Establishment Class 3 - Pub) and New Outdoor Sidewalk Patio", endorse the application by Blarney Stone Pub Inc. for an increase in patron capacity for the Liquor Primary Liquor Licence (Licence #009485) from 270 interior seats to 295 interior seats (Liquor Establishment Class 3) and for a new 6 person Liquor Primary outdoor sidewalk patio at The Blarney Stone located at 216 Carrall Street, subject to:

- i. A maximum interior capacity of 295 persons;
- ii. A maximum patio capacity of 6 persons;
- iii. The patio ceasing all liquor service and vacated by 11 pm;
- iv. No music permitted on the patio;
- v. A Licence Agreement with an initial one-year term for the patio;
- vi. Food service while the patio is open; and
- vii. Signing a Good Neighbour Agreement with the City prior to the issuance of the revised business licence.
