Structures for Public Expression on City Streets 1. April 5, 2011

> Amendments to the Street and Traffic By-law to Facilitate use of Structures on Streets for Political Expression April 14, 2011

On April 7, 2011, the General Manager of Engineering provided an overview of the Administrative report dated April 5, 2011, entitled "Structures for Public Expression on City Streets" and along with Transportation and Streets Administration staff responded to questions. To address issues and questions raised by both Council and the speakers, staff brought forward an amended Administrative report dated April 14, 2011, entitled "Amendments to the Street and Traffic By-law to Facilitate use of Structures on Streets for Political Expression".

The Committee heard from 24 speakers, five in support of the recommendations who also expressed concerns and 19 opposed to the recommendations.

A. THAT Council approve amendments to the Street and Traffic By-law in order to regulate the placement of structures on city streets for the purpose of political expression.

FURTHER THAT the Director of Legal Services be instructed to prepare the necessary amending by-law, generally in accordance with Appendix A of the Administrative Report dated April 14, 2011, entitled "Amendments to the Street and Traffic By-law to Facilitate use of Structures on Streets for Political Expression", with the following additional provisions:

## TABLES CONVEYING POLITICAL EXPRESSION

- 71E. Despite section 71A of the By-law, a table which conveys political expression does not require a permit under section 71B of this By-law if:
  - (a) it is no larger than 1 meter in depth by 1.8 meters in width by .75 meters in height;
  - (b) it is placed on the street for no more than thirty consecutive days;
  - (c) it is removed from the street between the hours of 8 pm and 8 am daily;
  - (d) it is attended at all times;
  - (e) no more than one table is placed on any city block at any time;
  - (f) the name of the sponsoring organization or person is clearly displayed on the table;
  - (g) it does not obstruct or interfere with pedestrian or vehicular traffic;
  - (h) it does not obstruct or interfere with any utility, postal or similar installation;
  - (i) it does not obstruct or interfere with any other structure, object, substance or construction works which occupy the street pursuant to a permit;

- (j) it does not obstruct or interfere with the use of street furniture;
- (k) it does not obstruct or interfere with City works, on or adjacent to the street;
- (I) it is more than 5 meters from any building entrance or exit;
- (m) it is more than 5 meters from any bus stop, street intersection, driveway crossing, loading zone, taxi zone, or wheelchair ramp;
- (n) it is more than 0.5 meters from any curb;
- (o) it contains no moving parts, electrical or electronic components or lights;
- (p) it is structurally safe and stable;
- (q) it is not used in association with any electronic signs, electric or gas lighting or appliances, extension cords, open flames, propane tanks, gas or electric heaters, barbeques; and
- (r) it does not contain obscene or defamatory content and does not promote hatred or violence.

# **EMERGENCIES ON STREETS**

- 71F. In the case of an emergency, the City Engineer may temporarily remove a structure or table that is permitted on a street.
- B. THAT Council approve a new city program to place and maintain free standing city sponsored structures on city streets in order to facilitate free political expression in locations designated by the City Engineer, generally as outlined in Administrative Report dated April 14, 2011, entitled "Amendments to the Street and Traffic By-law to Facilitate use of Structures on Streets for Political Expression".

# AMENDMENT MOVED by Councillor Woodsworth

THAT the motion be amended to add to Section 71A of the By-law and the motion be endorsed in principle:

- (f) who is homeless and erects a tent or temporary shelter on a Vancouver street, does not require a permit under section 71B of this By-law subject to the following conditions:
  - 1. There remains less available shelter space than the best estimate of homeless people in Vancouver.
  - 2. Tents or temporary shelters shall not be erected in the middle of the sidewalk, on a curb, in a roadway, or in such a manner as to cause an obstruction to pedestrian or vehicular traffic.
  - 3. Tents or temporary shelters shall allow a minimum 1.5 meter (5 ft) passage space for pedestrians.
  - 4. Tents or temporary shelters shall allow a minimum 1.5 meter (5 ft) distance from any "obstruction" such as trees, lamp standards, bike racks, bus stop or parking meters.
  - 5. Areas around tents or temporary shelters shall be kept in a neat, clean and orderly manner.
  - 6. Tents or temporary shelters shall not block access to any Fire Department equipment, connections or exits from any buildings;
  - 7. Tents or temporary shelters shall not, in any way, be a safety hazard.
  - 8. Tents or temporary shelters shall be taken down during the business hours of adjacent businesses, or in the case of residential areas, between 8:00 am and 8:00 pm.

- i. A maximum capacity of 50 seats;
- ii. The signing of a Good Neighbour Agreement with the City;
- iii. The patio ceasing all liquor service and vacated by 11 pm;
- iv. No music permitted on the patio;
- v. A Time Limited Development Permit for the patio; and
- vi. Food service to be provided while the patio is open.

# 4. Emergency Response Plan for City of Vancouver

Vancouver City Council, at its meeting on April 5, 2011, referred the following motion to the Standing Committee on Planning and Environment meeting on April 7, 2011, in order to hear from speakers:

## **WHEREAS**

- 1. Japan is a leader in having organized its citizenry in earthquake preparedness, and Christchurch has organized a Civil Defence Emergency Management plan involving a series of partnerships between City Council, emergency services, community agencies and neighbourhood volunteers for effective emergency response and relief, and were immediately deployed after the February 22, 2011 earthquake.
- 2. Vancouver's Neighbourhood Emergency Preparedness Program (NEPP) delivers sessions on family emergency preparedness through Community Centres; while at the same time there is no coordinated Response measures in effect.
- 3. Vancouver actively supports volunteers in Emergency Social Services and Amateur Radio through the Office of Emergency Management and the Police Department, however does not have programs in place to engage women's and disability organizations to address more specific family needs.

4. There is no single program that consolidates neighbourhood emergency preparedness with response teams through the Office of Emergency Management, the Police Department and Community Centres across the City.

## THEREFORE BE RESOLVED

- A. THAT in order to provide the most effective earthquake crisis relief, the City of Vancouver work with the Park Board to expand Emergency Preparedness and Response services at Community Centres and in neighbourhoods, which includes providing tools, training, and support to a network of neighbourhood volunteers.
- B. THAT the City of Vancouver, in consultation with the Park Board and Board of Education, provide coordinated communications support for any such community based response that would include neighbourhood specific printed materials, online resources, and any other support necessary that would enable citizens to clearly understand how to best respond to a large-scale emergency.

The Committee heard from three speakers in support of the recommendations.

Following the hearing of speakers, the motion was put and CARRIED UNANIMOUSLY with Councillor Louie absent for the vote.
