 Report Back - Improving Pedestrian Safety and Accessibility July 13, 2011

The Director of Transportation presented the report and, along with the General Manager of Engineering Services and additional staff from Engineering Services and the Vancouver Police Department, responded to questions.

The Chief Medical Health Officer, Vancouver Coastal Health Authority, spoke in support of the report recommendations, particularly recommendation C.

The Committee heard from four speakers in support of the report recommendations, particularly recommendation C, and one speaker who noted concerns with the report.

MOVED by Councillor Deal THAT the Committee recommend to Council

A. THAT Council receive for information the overview of immediate actions undertaken by Engineering Services to improve pedestrian safety and accessibility, as contained in the Administrative Report dated July 13, 2011, entitled, "Report Back - Improving Pedestrian Safety and Accessibility".

- B. THAT Council approve the 2011 Road Safety Awareness Program as described in the Administrative report dated July 13, 2011, entitled, "Report Back Improving Pedestrian Safety and Accessibility", with funding of \$150,000 to be provided from the 2009 Streets Basic Capital Budget Traffic Calming Program (CER-00084).
- C. THAT Council approve the establishment of a Pedestrian Safety Zone on Hastings Street between Abbott Street and Jackson Street, which includes working with the Vancouver Police Department to implement a trial 30 km/h speed limit while implementing other safety measures as determined by the General Manager of Engineering Services, and
  - FURTHER THAT Council urge staff to prioritize actions on pedestrian safety in the block of Hastings Street between Main Street and Columbia Street.
- D. THAT Council approve the establishment of the Active Transportation Advisory Committee.
- E. THAT Council direct staff to consult with Port Metro Vancouver, TransLink and other commercial users of downtown streets including couriers, tourist busses, taxi cabs and delivery trucks.

THAT Council receive for information the Administrative Report dated July 13, 2011, entitled "Viaducts and False Creek Flats Planning: Eastern Core Strategy" on the initial work relating to transportation impacts, soils contamination and a structural review for the Georgia and Dunsmuir Viaducts Review (Phase I), as detailed in Appendix A of the aforementioned report.
- B. THAT Council direct staff to undertake analysis of land use, cost, development potential and structural reconfiguration options for the Georgia and Dunsmuir viaducts in the context of an integrated transportation and land use approach to the Eastern Core, all within existing budgets, generally in accordance with the *Eastern Core Strategy* work program as outlined in Appendix B of the Administrative Report dated July 13, 2011, entitled "Viaducts and False Creek Flats Planning: Eastern Core Strategy".
- C. THAT Council direct staff to report back with policy directions for the Eastern Core, including a Terms of Reference for the next phase of more detailed land use and transportation planning for the area.
