 - 1. Award Studio 1 #303 272 East 4th Avenue: for a lease term of three years less two weeks, awarded free of rent, excluding all utilities;
 - 2. Rental Studio 2 #223 428 West 8th Avenue: for a sub-lease term of three years less two weeks, at a monthly rent equal to the maximum BC Employment and Assistance (BCEA) shelter allowance for single persons (currently \$375 per month), excluding all utilities;
 - 3. Rental Studio 3 #367 485 West 8th Avenue: for a sub-lease term of three years less two weeks, at a monthly rent equal to the maximum BC Employment and Assistance (BCEA) shelter allowance for single persons (currently \$375 per month), excluding all utilities; and
 - 4. Rental Studio 4 #106 1202 East Pender Street: for a lease term of three years less two weeks, at a monthly rent equal to the maximum BC Employment and Assistance (BCEA) shelter allowance for single persons (currently \$375 per month), excluding all utilities.
- C. THAT Council approve A and B above on the basis that no legal rights or obligations are hereby created and none shall arise hereafter except upon execution of all necessary legal documents by all parties.

- B. Motions on Notice
- 1. Water Meter Analysis

The following Motion contains a revision to the original Motion on Notice, which was accepted by the Council.

MOVED by Councillor Affleck SECONDED by Councillor Deal

WHEREAS

- 1. The City of Vancouver wants to ensure its practices are environmentally friendly and sustainable;
- 2. Water meters have been adopted by Council as a requirement in new home construction;
- 3. Meters were presented to Council as a tool which will get residents to save water, although no analysis was presented to Council to support that proposition;
- 4. Staff will be reporting back shortly with a proposal for putting meters on all single family homes, with the goal that all 90,000 single family homes install meters;
- 5. Meters are estimated to cost homeowners \$80 per year; or about \$7.2 million per year for all single family homes in Vancouver;
- 6. Metro Vancouver is the supplier of water to Vancouver. Its budget for water is about \$220m a year, with virtually the entire budget paying fixed costs;

- 7. When Metro Vancouver residents use less water, the unit price of water must increase to cover the fixed costs to deliver said water; and
- 8. It would appear that the net result of universal metering is that all households will pay an extra \$80 a year for water.

THEREFORE BE IT RESOLVED THAT staff are requested to report back with a complete financial analysis of residential water meters, including:

- How much water does a homeowner have to conserve in order to recover the extra \$80 annual fee?
- How does a meter persuade a homeowner to conserve water? Is it a financial incentive? Or are there non-tangible incentives?
- If all the residents of Metro Vancouver use less water, what is the impact on water rates?
- Information on the amount of staff time to prepare this report.

2. Online Rental Database

MOVED by Councillor Stevenson SECONDED by Councillor Jang

WHEREAS

- 1. 52% of Vancouver residents are renters;
- 2. there are approximately 4,900 purpose-built rental buildings in Vancouver;
- 3. many of these rental buildings are several decades old, and require regular maintenance to maintain the safety and livability for tenants;
- 4. information on these buildings, such as property violations, currently exists in the public domain but is difficult to access;
- 5. the City of Vancouver is striving to be a leader in implementing open source standards and applications; and
- 6. other cities, including New York, have created online, searchable databases that include information on the history of rental apartment buildings.

THEREFORE BE IT RESOLVED THAT City staff report back on creating an online, searchable database of rental apartments in Vancouver, which would:

- utilize existing publicly available information collected by the City; and
- include information such as building owner, outstanding work orders, and property violations, if any.

3. BC Place Stadium Digital Signs

MOVED by Councillor Meggs SECONDED by Councillor Deal

WHEREAS

- 1. residents around BC Place Stadium continue to report significant negative impact from the installation of large digital signs at three locations around the stadium;
- 2. these signs were not installed with advance public consultation and public input, as would have been required on a similar project under City jurisdiction;
- 3. efforts by Mayor Robertson to resolve public concerns through correspondence with Minister Pat Bell have not produced results; and
- 4. claims by PAVCO that they have mitigated the impact and reduced brilliance and intrusiveness of the lighting have not produced the improvements sought by residents.

THEREFORE BE IT RESOLVED THAT Council direct the City Manager to advise PAVCO that the City requires a clear action plan by PAVCO to bring the signs into compliance with City standards and processes, failing which the City will seek further remedies to reduce neighbourhood impact.

AMENDMENT MOVED by Councillor Ball

THAT the motion be struck and replaced with the following:

WHEREAS

- 1. Residents around BC Place Stadium continue to report significant negative impact from the installation of large digital signs at three locations around the stadium;
- 2. These signs were not installed with advance public consultation and public input, as would have been required on a similar project under City jurisdiction;
- 3. Council supports all efforts by Mayor Robertson to resolve public concerns through dialogue and correspondence with Minister Pat Bell and PAVCO staff;
- 4. PAVCO's mitigation efforts to minimize the impact with reduced brilliance and different timing have not yet produced the improvement sought by residents;
- 5. Council endeavours to work in co-operation with other orders of government and in this spirit is pleased to provide the Minister with information which will aid in a speedy solution to this concern;
- 6. Light at night not only disrupts sleep but also interferes with circadian rhythms. Research indicates that intrusive lighting may reduce the production of melatonin, a hormone, resulting in increased rates of breast and other cancers;
- 7. Excessive or misdirected lighting can intrude on the privacy of others when light or glare trespasses over property lines; and
- 8. Lighting that is too bright interferes with the eye's ability to adapt to darker areas. Unsafe glare can hinder visibility and contribute to accidents.

THEREFORE BE IT RESOLVED THAT Council direct City staff to provide the Mayor with reports and research on the health, trespass and safety issues caused by exposure to the high levels of illumination and glare that exist at BC Place Stadium. Council also requests that staff provide the Mayor with documented levels of light encroaching upon residents in their homes. Council expects that given such reports the Mayor will be successful in negotiation. However, should further action be required, the City will be well prepared.

6. Improve the Efficiency of the Permit Process at City Hall

MOVED by Councillor Tang SECONDED by Councillor Deal

WHEREAS

- 1. The issuing of permits is a key function of the City of Vancouver's service to its citizens:
- 2. Delays in permits can lead to increased costs for citizens and local businesses, particularly for new housing; and
- 3. The City is committed to improving and enhancing the efficiency of the services it provides.

THEREFORE BE IT RESOLVED THAT staff be directed to undertake a review of City regulations and permitting processes, with the goal of supporting local businesses through updated regulations, improved speed and greater efficiency of processes;

FURTHER THAT staff specifically review the permitting process related to home building construction, and provide recommendations for achieving a turnaround benchmark of six weeks for all home construction permits.
