1. 2012 Operating Budget: Proposed Budget and Public Consultation Update

On Tuesday, February 28, 2012, Vancouver City Council received a report reference on the 2012 Operating Budget, and referred the hearing of speakers to a Special Council meeting on Wednesday, February 29, 2012.

Council heard from the following 11 speakers who noted concerns regarding cuts to the Vancouver Public Library (VPL), transparency, the public consultation process and the impact

of taxes on businesses. They also offered ideas on new revenues and savings, and encouraged Council to spend more on housing:

During the hearing of speakers, Penny Ballem, City Manager, and Sandra Singh, Chief Librarian, responded to questions.

Following the hearing of speakers, the City Manager, along with Patrice Impey, General Manager of Financial Services/Chief Financial Officer, responded to questions.

THAT Council approve "in principle" the 2012 Proposed Operating Budget, as outlined in the Administrative Report dated February 20, 2012, entitled "2012 Operating Budget: Proposed Budget and Public Consultation Update", and detailed in Table 1 of the aforementioned report, and instruct the Director of Finance to bring the budget into balance with a 2.5% general purposes tax increase;

FURTHER THAT Council approve "in principle" the 2012 Grants budget of \$16.4 million, held to 2011 levels;

AND FURTHER THAT Council approve "in principle" the Vancouver Board of Parks and Recreation Global Budget of \$55,935,900, comprised of \$103,808,800 expenditures and \$47,872,900 revenues;

AND FURTHER THAT Council receive for information the 2012-2014 Operating Budget outlook as shown on Table 5 of the aforementioned report;

AND FURTHER THAT, as part of the 2012 operating budget, Council request the City Manager to report back with a range of options for the creation of an Innovation Fund that would be used to leverage additional monies from external funding sources. (e.g. other orders of government, not for profit organizations, private sector, universities and foundations). The use of the Innovation Fund is to advance City policy while attaining an enhanced value for the City's investment.
