


NEW STRATEGIES TO PROVIDE STUDIO AND CREATIVE SPACE

- Pilot program: Minimum 10,000 sf of space
- Update: Artist studio regulatory review



PROFILE: VANCOUVER'S ARTISTS

- 8,200 artists live in Vancouver (2006)¹
- From 2006 to 2011:
 76% growth in the number of artists vs.
 28% growth in the overall labour force¹
- Highest concentration of artists per capita in Canada (1991 - 2006)¹
- Artists earn a lower income¹
- Many artists do not have a long-term workspace arrangement²



ARTIST STUDIO AND SPACE CHALLENGES



PRIVATE SECTOR CHALLENGES

NO FINANCIAL INCENTIVES

- to create spaces for artists
- to upgrade studios
- to secure studios in the long term, especially if redevelopment exists

DISINCENTIVES

- Existing studios may not have proper permits
- Existing studios may not meet life safety requirements
- Perception that artists may not be reliable for rental payments



CURRENT INITIATIVES CITY OF VANCOUVER ARTIST STUDIO AWARD PROGRAM

Selected artists receive a studio on a 3-year term, rent-free or at below-market rate

15 artists have received live-work studios since 1995

These artists have

- gone on to receive national and international recognition
- made significant contributions to artistic excellence

CURRENT INITIATIVES PARK BOARD FIELD HOUSE - STUDIO PROGRAM


Selected artists and arts collectives receive a field house studio, up to a 3-year term, in exchange for community-engaged arts projects in neighbourhoods





SUCCESSES | ARTIST STUDIO REGULATORY REVIEW

✓ Opportunities for new studios	Artist studio initiatives underway (13,000 sf committed); additional studios to be provided through new strategy
✓ Improvement to permit process	Dedicated senior zoning and building staff are guiding simple artist studio applications
✓ Identify known multi-tenant studios	Updated inventory targeted for Summer 2012
✓ Engagement and learning	Mini Workshops engaged over 50 participants Artists engaged for design input on new studios
✓ Posting of approved artist studio use in new multi-tenant buildings	Required for Development Permits and rezonings
Improvements to functionality	Development of Interim Artist Studio Guidelines in progress



CHALLENGES | ARTIST STUDIO REGULATORY REVIEW

Require artist-led building management body for all new multi-tenant buildings	No power in the Vancouver Charter to enable this
"Interim program" for studios	In many cases, property owners have not been interested in committing to this program; one opportunity under discussion
Explore the use of covenant to preserve studios	In discussion with Legal Services
