Today you will be reviewing a public hearing for the REZONING: 3212 East Boulevard.

As per the "vancouver.ca/yoursay.htm" website this hearing description is: "To rezone the site from RS-1 District to CD-1 District to permit a housing demonstration project that proposes a principal multi-family dwelling and a second building at the lane containing parking at grade and residential space above, at a density of 1.2 FSR. The proposed height of the principal building is 11.47 metres (37.63 feet)."

I am speaking in support of this public hearing based on my experience as being a young professional living in the city of Vancouver. As a citizen of Canada I am a Professional Engineer that grew up and received my education in Alberta. I spent six years working in the city of Edmonton as an Engineer and have recently relocated to the city of Vancouver two years ago. As a single female working in a male dominated profession in the city of Edmonton I am able to say that I make a fairly decent income in which I was able to have a relatively modest life and be an owner of a 1700 square foot double attached garage home that was priced in the range of \$400,000 to \$500,000. After having moved to Vancouver my salary took a short pay cut and the pricing of houses here for the equivalent of what I could afford back in Edmonton has quadrupled itself out here. I find that if I want home ownership then I would have to be living either outside of the city of Vancouver or rather in a much smaller accomodation. The housing costs out here are so much higher that I question whether I would like to stay in Vancouver for the long term.

It is due to this reason that I am in support of the rezoning of 3212 East Boulevard such that housing can be more affordable and available for people who aren't in a position to afford a home in the area.

Dear Mayor and Council,

This application proposes to rezone the site from RS-1 District to CD-1 District to permit a housing demonstration project that proposes a principal multi-family dwelling and a second building at the lane containing parking at grade and residential space above, at a density of 1.2 FSR.

We are all very much aware that the cost of housing in Vancouver is beyond most Vancouverites. The above proposal would introduce more affordable housing on the west side.

Besides the obvious affordability this proposal may very well be the start of what might be best for the larger housing we have on offer in Vancouver. It would allow more people to live on a smaller footprint than if they all owned individual residences, making better use of land space.

I know of one woman who owns a home in a beautiful spot on Vancouver's west side. She told me that there are seven homes in her neighbourhood that are owned by foreign interests that now sit empty as the owners do not live in them but live in their home countries. Breaking up the footprint of a large home into several other residences would allow permanent residents the opportunity to buy and eliminate the possibility of this happening in this neighbourhood.
