SUBJECT: Social Grants: Year End 2012

**RECOMMENDATION**

- A. THAT Council approve 5 Hastings Legacy Fund grants for 2013 totaling \$117,100; source of funding is the Hastings Social Responsibility Reserve.
- B. THAT Council approve 5 Social Policy Capital grants totalling \$52,455 and 4 New Licensed School Aged Child Care Grants totalling \$34,098; source of funds to be the 2012 Capital Budget.
- C. THAT Council approve 5 Civic Childcare Program Innovation, Stabilization and Development Grants totalling \$30,000; source of funds to be the unallocated portion of the 2012 Child Care Grants Budget.
- D. THAT Council approve 2012 funding in the amount of \$235,059 to the Collingwood Neighbourhood House Society for the delivery of recreational programs and operation of the Collingwood Gymnasium for the period January 1, 2012 to December 31, 2012; source of funds to be the 2012 Operating Budget.

Approval of grant recommendations (A - D) requires eight affirmative votes.

**REPORT SUMMARY**

This report recommends grants and funding that align with the policy objectives of the Social Grants Program. These objectives will continue to inform the ongoing development of a corporate granting strategy and include:

- Meeting basic needs;
- Building capacity;
- Enhancing belonging;
- Supporting inclusive neighbourhoods.

This report recommends 19 grants to registered nonprofit organizations in Vancouver for a total of \$233,653 and consolidates six Social Granting streams under one report.

This report also recommends \$235,059 in on-going funding for Collingwood Neighbourhood House (CNH) for the delivery of recreational programs and operation of the Collingwood Gymnasium.

#### **COUNCIL AUTHORITY/PREVIOUS DECISIONS**

**Hastings Legacy Fund Grants:** On October 4, 2005, as part of the rezoning conditions for Hastings Park, Council accepted a number of public benefits from Hastings Entertainment Inc. including Hastings Legacy Fund grants. In 2009 City staff consulted with residents and businesses and identified priorities including public safety, public realm improvements and celebrations.

**Child Care Grants:** Council approved the Civic Child Care Strategy in 1990 with goals that include supporting the viability, accessibility and quality of existing child care services. In 2011, the Joint Council on Childcare targeted an increase of 500 new childcare spaces over the following three years.

**Collingwood Neighbourhood House gym:** On December 15, 1994 Council agreed to provide Collingwood Neighbourhood House Society funding for gymnasium/recreational programs and approved an operating agreement. A modification to the Lease to formalize funding and operating commitments was confirmed on November 26, 2003.

The General Manager of Community Services RECOMMENDS approval of the foregoing.

**REPORT****Background/Context**

Recommended funding helps to address Council priorities:

- **Healthy City Strategy** including enhancing public safety, belonging and inclusion and opportunities for recreation.
- **Childcare and Early Learning** through the creation of childcare spaces that supports the target of 500 additional spaces by 2014.
- **Greenest City 2020** including neighbourhood beautification, events and small grants to enhance community involvement in green initiatives.

Funding also aligns with the Social Grants objectives of meeting basic needs, building capacity, enhancing belonging and supporting inclusive neighbourhoods.

**Strategic Analysis****1) Hastings Legacy Fund**

Of the 6 applicants, 5 applications totaling \$117,100 are being recommended for funding for projects starting in 2013 because they best align with neighbourhood priorities, and correspond with Council priorities, including supporting safe and inclusive communities, civic engagement, and *Greenest City 2020*. One project is NOT RECOMMENDED.

The total available funds in the HLF reserve for 2013 is \$117,100. (for a more detailed description of each project see APPENDIX A)

## 2) Small Social Policy Capital Grants

Small Capital Grants improve the safety, accessibility and operational needs of non-profit social service and child care organizations. This report recommends 5 small projects related to health and safety upgrades and improved physical accessibility. 7 applications were received and 5 are recommended for funding. 2 applications are NOT RECOMMENDED. The submissions are summarized below (for a more detailed description of each project see APPENDIX B)

#### 4) Additional Licensed School Aged Child Care Spaces:

In 2011, Council set a target of 500 new childcare spaces by 2014. To help address a shortfall in before and after school care spaces staff are developing a guideline and funding agreement with the Vancouver Board of Education to create opportunities for spaces in school sites. Staff will report back to Council when the funding agreement and guidelines are completed.

As an interim measure staff recommend funding to non-profits operating childcares in school settings. Recommendations for grants in this category will create 59 licensed school aged spaces within Vancouver Board of Education facilities.

#### 5) Collingwood Neighbourhood House Gym:

The Collingwood Neighbourhood House Society (CNH) continues to provide a broad range of programs to meet the needs of a diverse community including residents of different age groups and cultures to improve recreation opportunities, cultural development and participation in the community. In 2010/2011, approximately 23,390 local residents and 14,000 youth participated in CNH's 71 recreational programs - about an 8% increase in participants over 2009/2010. (These statistics include multiple visits from program participants.)

City staff have concluded that CNH continued to provide quality services throughout 2010/2011 and that their business plan for 2011/2012 is consistent with the City's goals and recommend no change from the 2011 approved funding (\$235,059).

***Implications/Related Issues/Risk (if applicable)******Financial*****1) Hastings Legacy Fund**

As of October 22, 2012, there is an unallocated balance of \$117,100 in the Social Responsibility Hastings Reserve. Annual contributions from Hasting Entertainment Inc. of \$100,000 (2007 base) with an annual CPI adjustment are expected until the Operational Agreement between the City and Hastings Entertainment Inc. expires. The 5 recommendations in this report total \$117,100, leaving \$0 unspent. The total contribution to the Hastings Legacy Fund to date is \$516,100.

**2) Small Capital Grants**

The total 2012 budget for Capital Grants for Social Service and Child Care facilities is \$85,000. This report recommends allocations of \$52,455 leaving \$32,545 unspent. It is recommended that these remaining funds be made available to respond to future Capital needs in the nonprofit sector in Vancouver.

**3) Child Care Grants**

The 2012 budget for Civic Childcare Grants is \$1,160,200. The 5 recommended grants for Research, Innovation and Program Development, will consume the remaining balance in the 2012 Civic Childcare Grants budget, leaving \$0 unspent.

**4) New or Expanded Licensed School Aged Child Care Grants**

The approved Vancouver Board of Education (VBE) Community Partnerships Budget is \$377,500 of which staff are seeking approval of \$34,098. The 4 recommended grants for New Licensed School Aged Child Care will leave a balance of \$343,042 for future use when the guidelines and funding agreement are secured between the VBE and the City of Vancouver.

**5) Collingwood Neighbourhood House Gymnasium**

The review of the existing lease with Collingwood Neighbourhood House (currently overholding) will be part of a Corporate Project aimed at improving oversight of City-owned property leased to non-profit agencies. One potential outcome of the lease review for Collingwood Neighbourhood House is to provide a multi-year arrangement to fund the Gymnasium activities. In the meantime, the existing lease arrangement requires that funding be approved by Council on an annual basis.

City Staff recommend continued financial support from the City for the delivery of recreation programs and the operation of the Gymnasium at CNH through the proposed City funding of \$235,059 for 2012, source of funds to be the 2012 Operating Budget.

**CONCLUSION**

All grants and funding recommended in this report align with the policy objectives of the Social Grants Program and will help the City address Council priorities that are included in the Healthy City Strategy: public safety, belonging and inclusion, and opportunities for recreation, in addition to Council's commitment to early learning and care by promoting the

growth, stability and accessibility of quality child care. Specifically, grants to child care operators will help achieve the target of 500 spaces by 2014. Once an operating agreement with Vancouver Board of Education (VBE) is in place, capital funding to increase child care spaces in schools will be provided to the VBE directly.
