# 1. Contract Award for Granville Bridge Bearing and Expansion Joint Replacement

The Director of Streets, along with the City Manager, responded to questions.

MOVED by Councillor Louie

- A. THAT Council authorize City staff to enter into a contract with Graham Construction and Engineering a Joint Venture for the replacement of bearings and expansion joints at the Granville Bridge at a total cost of \$5,633,200 (\$5,238,000.00 for mandatory work, plus \$395,200.00 for Optional Work) plus applicable taxes with funding to be provided from the approved 2012-14 Granville Bridge Bearing Replacement program (Capital Budget Council Report RTS No. 9454); subject to the terms and conditions satisfactory to the General Manager, Engineering Services, the Director of Legal Services and the Chief Purchasing Official.
- B. THAT the Director of Legal Services be authorized to execute and deliver, on behalf of the City, all legal documents required to implement A above.
- C. THAT no legal rights or obligations will be created by Council's adoption of A and B above unless and until such legal documents are executed and delivered by the Director of Legal Services.
