

PUBLIC HEARING MINUTES

JULY 16, 2013

A Public Hearing was held on Tuesday, July 16, 2013, at 6:05 pm, in the Council Chamber, Third Floor, City Hall, to consider proposed amendments to the zoning and development and sign by-laws.

COMMITTEE OF THE WHOLE

MOVED by Councillor Jang SECONDED by Councillor Tang

THAT this Council resolve itself into Committee of the Whole, Mayor Robertson in the Chair, to consider proposed amendments to the zoning and development and sign by-laws.

Mayor Robertson explained Council would not be making a decision on the application at this meeting, and public comments may be submitted up until 5:00 pm July 22, 2013, or until 15 minutes after the close of the speakers list, whichever is later.

1. REZONING: 508 Helmcken Street

An application by GBL Architects Inc., was considered as follows:

Summary: To rezone 508 Helmcken Street from DD (Downtown) District to a CD-1

(Comprehensive Development) District. The proposal is for a 36-storey building containing 448 residential units, of which 110 are proposed as

secured market rental, with retail use and a private pre-school/kindergarten

facility at grade. A height of 97.5 m (320 ft.), a floor space ratio (FSR) of 17.19, a residential floor area of 32,833 m 2 (353,287 sq. ft.), a retail floor area of 111 m 2 (1,192 sq. ft.) and an institutional floor area of 512 m 2 (5,505 sq. ft.) are proposed.

The General Manager of Planning and Development Services recommended approval, subject to the conditions set out in the summary and recommendation of the Public Hearing agenda.

Council also had before it two memorandums. The first, dated July 3, 2013, from the Assistant Director of Current Planning, provided a revised graphic to replace Figure 7, "Floor Plate Comparison of New Yaletown Towers", on page 10 of Appendix D of the Policy Report dated June 4, 2013.

The second memorandum, dated July 16, 2013, also from the Assistant Director of Current Planning was distributed to Council at the Public Hearing, and provided revised loading requirements for the application as follows:

THAT Appendix C of the Policy Report dated June 4, 2013, entitled, "CD-1 Rezoning - 508 Helmcken Street" be amended to replace the Class A loading requirements with:

"Class A loading must be provided at a minimum rate of 0.01 space per dwelling unit up to 300 dwelling units and at a minimum rate of 0.008 space per dwelling unit for 300 or more units."

Staff Opening Comments

Karen Hoese, Senior Rezoning Planner, Rezoning Centre, and Anita Molaro, Assistant Director, Urban Design and Development Planning Centre, introduced the application and, along with Brian Jackson, General Manager of Planning and Development Services, responded to questions.

Applicant Comments

Brent Kerr, Brenhill Developments, and Stuart Lyon, GBL Architects, Inc., provided opening comments.

Summary of Correspondence

Council received the following since the application was referred to Public Hearing and prior to the close of the speakers list:

- 29 letters and emails in support;
- 25 letters and emails opposed;
- 116 signatures on an electronic petition opposed (unaudited), and
- One email addressing other matters.
