referred discussion and decision to a Special Council meeting on August 1, 2013, at 2 pm, as Unfinished Business.

Penny Ballem, City Manager, provided a presentation on the history of Hastings Park and the Pacific National Exhibition (PNE), and along with David Hutch, Project Manager, Hastings Park/PNE Planning, responded to questions.

# MOVED by Councillor Louie

- A. THAT Council adopt the implementation plan outlined in the Administrative Report dated June 18, 2013, entitled "Hastings Park/PNE Governance Review", for a new governance structure for Hastings Park and the Pacific National Exhibition (PNE).
- B. THAT Council approve funding for consultants, needed to support and resource the implementation plan set out in the Administrative Report dated June 18, 2013, entitled "Hastings Park/PNE Governance Review", to a maximum of \$80,000; source of funding to be the Hastings Park Reserve.

# AMENDMENT MOVED by Councillor Carr

THAT the motion be struck and replaced with the following:

- A. THAT Council adopt a governance structure for Hastings Park and the Pacific National Exhibition (PNE) that delegates authority to govern Hastings Park to the Vancouver Board of Parks and Recreation and requires the Park Board to appoint a PNE Board of Directors to manage the PNE, and establish a Multi-Party Operating Agreement with leaseholders in Hastings Park.
- B. THAT Council approve funding for consultants to develop, support and resource an implementation plan for the governance model noted in A, above, to a maximum of \$80,000; source of funding to be the Hastings Park Reserve.

## AMENDMENT MOVED by Councillor Carr

THAT the following changes be made to the first sentence of the third paragraph on page 13 of the Administrative Report dated June 18, 2013, entitled "Hastings Park/PNE Governance Review":

Delete the words "continue to" and the word "and" prior to the word "track";

• Insert the words "the Sancutary, and the Momiji and Italian Gardens" following the word "construction)"

so that the sentence would read:

Park Board would manage Empire Fields, track, the new Plateau Park (currently under construction), the Sanctuary and the Momiji and Italian Gardens.
